**I Review of current procedures for making applications to establish bazaars**

Meeting with bazaar organizers and the Administration

The Chairman welcomed representatives of the Administration and deputations to the meeting, and reminded the deputations that their written submissions and views presented at the meeting would not be covered by the protection and immunity provided under the Legislative Council (Powers and Privileges) Ordinance (Cap. 382).

Discussion

2. The Subcommittee received views from six deputations attending the meeting (Index of proceedings attached at **Appendix**).

*(Post-meeting note: A written submission tabled at the meeting (Chinese version only) was issued to members vide Lotus Notes e-mail on 13 June 2017.)*

3. The Subcommittee noted the following views expressed by the deputations –

*Applications for setting up bazaars*

- (a) it was noted that different District Councils ("DCs") had different mechanisms in handling bazaar proposals (e.g. requiring the organizers to submit concrete proposals for consideration, approving in principle a venue for setting up bazaars which could be applied by all interested parties, serving only as a discussion platform without voting on the proposals);
- (b) it was suggested that the Administration should approve a bazaar proposal under the district-led approach if support had been obtained from the local DC members and no dissenting voices were received from local communities after consultation with

stakeholders, such as the relevant Estate Management Advisory Committees, Owners Corporations and Mutual Aid Committees;

*Measures to facilitate the setting up of bazaars*

- (c) in view of the complicated application procedures (including the application for relevant licences) involving various departments, the Administration should deploy a co-ordinator to assist the organizers throughout the application process;
- (d) an inter-bureaux/departmental task force, to be led by a Secretary or Director, should be formed to co-ordinate relevant departments in handling bazaar applications;
- (e) the Administration should consider (i) establishing bazaars with special themes in various districts which could help attract tourists and shoppers and promote local economy, (ii) standardizing the procedures for applying different types of venues (including the venues under the management of the Leisure and Cultural Services Department) for setting up bazaars, (iii) developing a list of sites suitable for setting up bazaars to facilitate the public in making applications, and (iv) setting up a seed fund for application by non-profit-making organizations to promote the long-term development of bazaars;

*Organization of bazaars in public rental housing estates*

- (f) the Housing Department ("HD") should develop standard procedures and application forms to facilitate interested parties to set up bazaars in public rental housing ("PRH") estates, and inform estate management and frontline staff that bazaar-related applications would be processed in complement with Government's policy;
- (g) it was unclear whether fees would be required for organizing bazaars at venues in PRH estates (i.e. whether HD would charge \$600 regardless of the scale of the bazaars) and the maximum duration allowed for organizing each bazaar; and
- (h) HD should consider allowing bazaar organizers to collect views of the local communities through other channels as consulting the respective DCs and Estate Management Advisory Committees could be very time consuming.

Action

Follow-up actions to be taken by the Administration

4. The Administration was requested to provide information on:
- (a) the Administration's response to Subcommittee members' suggestion of developing a common standard to be adopted by 18 DCs and the District Environmental Hygiene Offices in determining how a bazaar proposal would be regarded as having obtained support from DC (e.g. no dissenting voice from DC members to the proposal, the proposal needed to be voted on at a DC meeting, written endorsement from DC had to be obtained, etc.);
  - (b) the general principles (通則) adopted by various departments in vetting and approving bazaar proposals, in particular the requirements of the Food and Environmental Hygiene Department on the contents of a concrete proposal (具體計劃書) (e.g. whether the proponent was required to attach the floor plan of the venue to the proposal);
  - (c) concrete measures to improve the existing application procedures for establishment of bazaars, including setting clear vetting criteria and enhancing communication among relevant departments;
  - (d) a copy of the new application form developed by HD for setting up bazaars in PRH estates (i.e. 慈善團體／機構在屋邨內進行臨時墟市活動申請書); and
  - (e) the Administration's response to the views raised by deputations at the meeting and in their submissions.

*(Post meeting note: The Chinese and English versions of the Administration's written response were issued vide LC Paper Nos. CB(1)1457/16-17(02) on 6 October 2017 and 9 October 2017 respectively.)*

*(At 12:48 pm, the Chairman ordered that the meeting be extended for 15 minutes to 1:00 pm. At 1:00 pm, the Chairman suggested that the meeting be further extended for 10 minutes. Mr Steven HO raised objection and requested the Chairman to end the meeting.)*

If more than one application was received for setting up bazaars in the same venue during the same period, HD would co-ordinate the applications, with a view to facilitating the implementation of the proposal by each organization/institution concerned. HD would also make reference to the Government's policy in handling bazaar applications; and</p> <p>(i) HD had already provided the relevant application forms to estate offices and informed frontline staff the proper procedures in handling bazaar applications.</p>	
<p>005935 – 010925</p>	<p>Chairman Mr LEUNG Yiu-chung CDA Administration</p>	<p>Mr LEUNG expressed concern about the need to obtain support from respective DCs or relevant local DC members before departments could approve a bazaar proposal. He requested the Administration to clarify whether DCs would need to give consent (a) for setting up a bazaar, or (b) for setting up the bazaar at a particular location.</p> <p>Mr LEUNG, the Chairman, and Miss CHIU of CDA considered that DCs should only act as a consultation platform and the Administration should be the approving authority of bazaar proposals. The Administration should take into consideration the requirements of various departments and the views and concerns of the local communities and respective DCs in making the final decision.</p> <p>The Government responded that bazaars in different forms might have different impacts (e.g. night markets would generate more nuisances to nearby residents than day-time</p>

010926 – 011557	Chairman Dr YIU Chung-yim Administration	<p>Dr YIU commented on the case-by-case approach adopted by the Administration in handling bazaar applications and considered that the Administration should develop the principles and procedures in vetting and approving bazaar proposals, and inform the public of the details.</p> <p>The Government responded that –</p> <ul style="list-style-type: none"> <li>(a) relevant departments would need to examine the details of a bazaar proposal to consider whether it could meet requirements of the respective departments;</li> <li>(b) open spaces in PRH estates were often public passageways, sitting-out areas or common spaces for use of residents; and</li> <li>(c) given that details of individual bazaar proposals would be different and that impacts of a proposal would vary depending on the actual circumstances of the estates concerned, HD had to handle each proposal on a case-by-case basis having regard to the situations of the estates concerned, including whether the proposal would cause environmental hygiene problems, obstruction of public passageways, nuisances to residents or the risk of drawing in illegal hawking activities, etc.</li> </ul>	
011558 – 012349	Chairman Mr LEUNG Che-cheung Administration	<p>Mr LEUNG commented that at times consultation of bazaar proposals at DC might arouse disputes among political parties, and shops in PRH estates could raise objection to the proposals.</p>

		<p>The Government advised that –</p> <ul style="list-style-type: none"> <li>(a) for PRH estates involving other owners (e.g. the Link Real Estate Investment Trust ("Link REIT")), consent of other owners would be required for implementing a bazaar proposal; and</li> <li>(b) views and concerns of other stakeholders, such as the shop owners in the vicinity, would also need to be taken into account.</li> </ul> <p>Mr LEUNG and the Chairman were of the view that the Administration should facilitate bazaar organizers to address the concerns of DCs and other stakeholders, in particular if they had opposing views.</p> <p>The Government reiterated that –</p> <ul style="list-style-type: none"> <li>(a) FEHD would assist bazaar organizers in taking forward the proposals if support from respective DCs had been obtained;</li> <li>(b) some PRH estates were located on lots subject to land leases and deeds of mutual covenant and the Government had to observe the relevant conditions when considering proposals for setting up bazaars; and</li> <li>(c) HD would assist the organizers to consult residents and other stakeholders through the Estate Management Advisory Committee of the estate concerned with a view to reaching a consensus among various stakeholders.</li> </ul>	
012350 – 013045	Chairman Ms Claudia MO Administration	<p>Ms MO suggested that the Administration should inform the public of the reasons of approving or rejecting a bazaar proposal (e.g. through FEHD's website).</p> <p>The Chairman said that the Administration could consider making a summary of the views and concerns expressed by various stakeholders, together with the application results, so that the experience could be shared by other organizers.</p>

		<p>The Government advised that the bazaar organizer would be informed of the reasons for refusing an application, and very often the organizer would take follow-up action to resolve the problems. He urged the Administration to take a more active role in promoting the development of bazaars.</p> <p>The Government remarked that bazaars could appear in various forms and with different purposes, and different districts might have different circumstances and public sentiments, and hence the Government considered the bottom-up approach more desirable. Though bazaar proposals would be considered on a case-by-case basis, FEHD had established mechanism and guidelines in vetting and approving proposals.</p>
