<u>The Chairman</u> welcomed representatives of the Administration and deputations/individuals to the meeting, and reminded deputations/individuals that their written submissions and views presented at the meeting would not be covered by the protection and immunity provided under the Legislative Council (Powers and Privileges) Ordinance (Cap. 382).

Discussion

2. <u>The Subcommittee</u> received views from 40 deputations/individuals attending the meeting, and noted the six written submissions provided by organizations/individuals (Index of proceedings attached at **Appendix**).

Action

(*Post-meeting note*: Five written submissions tabled at the meeting (Chinese version only) were issued to members vide Lotus Notes e-mail on 13 October 2017.)

(*Post meeting note:* Two written submissions received from 香港天主教正義和平委員會 (Chinese version only) and 民社服務中心 (Chinese version only) after the meeting were issued to members vide LC Paper No. CB(1)64/17-18 on 17 October 2017.)

(*Post meeting note:* A written submission received from Democracy Groundwork (Chinese version only) after the meeting was issued to members vide LC Paper No. CB(1)67/17-18 on 18 October 2017.)

3. <u>The Subcommittee</u> noted the following views expressed by deputations and individuals:

Policies on bazaars and the relevant application procedures

- (a) the development of bazaars would boost local economy, promote tourism, and provide a means for the grass-root people, housewives and elderly people to support their living;
- (b) it was very difficult to apply for the establishment of bazaars as the current bazaar application procedures were complicated (including inconsistent consultation procedures with the relevant parties and conflicting requirements of various departments) and processing of applications and relevant licences took a long time. The Government should simplify the current application procedures, develop application guidelines and provide necessary assistance to facilitate the public in making applications for setting up bazaars;
- (c) the Government should review the requirements of different types of licences relating to the setting up of bazaars and consider developing a single licence for bazaars/cooked food bazaars;
- (d) the Government, in particular departments in charge of venues, should formulate short, medium and long-term policies on bazaars and set up a review committee to monitor the development of bazaars;
- (e) the Government should identify suitable public spaces/idle lands in various districts for setting up community bazaars ("社區墟市")

- and launch a pilot scheme by setting up bazaars at locations where bazaars or carnivals had been successfully held;
- (f) the Government should consider developing a policy of establishing a festive bazaar/bazaar in each of the 18 districts;
- (g) the Government should establish (i) an inter-bureaux/departmental task force/one-stop platform (with representatives from all relevant departments)/designated office to facilitate the public in making applications for setting up bazaars; and (ii) a licensing office under the Food and Environmental Hygiene Department for coordinating applications for setting up cooked food bazaars;
- (h) the Chief Executive had stated in her manifesto that "the development of district economy would be promoted, for example through studies on the establishment of bazaars with special features in various districts", but there was no mention of any bazaar related policy in her 2017 Policy Address;
- (i) the Government should (i) compile a list of suitable sites (including suitable venues in public rental housing ("PRH") estates, in particular those estates which did not have other private owners) for setting up bazaars, and the list should include details on the facilities available at the sites to facilitate the public in making applications; (ii) set up a seed fund for application by bazaar organizers; (iii) enhance the operating environment of bazaars (e.g. safety standard and environmental hygiene); and (iv) assist in promoting bazaars to tourists;

Lunar New Year bazaars and cooked food bazaars

- (j) the Government should announce its policy for setting up bazaars during the Lunar New Year ("LNY") in 2018 soonest possible and take immediate action to consult relevant stakeholders:
- the Government should select a venue for Lunar New Year Fair and a pedestrian precinct from each of the five major constituencies of Hong Kong for the establishment of cooked food bazaars during LNY (i.e. establishing 10 LNY bazaars at the five major constituencies of Hong Kong "五區十市");

Action

- (l) before a comprehensive bazaar policy was in place, the Government should adopt a lenient approach in taking enforcement actions against street hawking activities during LNY;
- (m) the use of "naked flame", instead of electricity, should be allowed in LNY bazaars and cooked food bazaars with proper crowd control arrangements and fire safety measures, so that "featured snacks" that needed to be cooked by "naked flame" on spot could also be sold at the bazaars;
- (n) the Fire Services Department should consider relaxing the fire safety requirements for cooked food bazaars (i.e. one 4.5 kg CO2 gas type fire extinguisher and one 9-litre water type fire extinguisher were required at each food stall) taking into account the temporary nature of bazaars and the limited resources and manpower of bazaar organizers;

Organization of bazaars in public rental housing estates

- (o) estate offices and frontline staff of the Housing Department ("HD") were not aware of the bazaar application procedures and the new application form developed by HD for setting up bazaars in PRH estates and still did not allow bazaars with cash transactions to be organized at PRH estates; and
- (p) it was not clear if bazaars would be allowed to be set up in PRH estates when the local District Council ("DC") members and the Mutual Aid Committees of the estates concerned welcomed the proposals but support from respective DCs could not be obtained.

<u>Motions</u>

- 4. At 10:05 am, the Chairman informed the Subcommittee that he had received two motions respectively from Mr SHIU Ka-chun and Dr Fernando CHEUNG. Members had no objection to the Subcommittee proceeding with the motions. The Chairman invited the two members to speak on their motions.
- 5. <u>Mr SHIU Ka-chun</u> spoke on his motion. The terms of the motion were as follows –

"基於新年熟食墟屬傳統活動,市民對此需求甚殷,但政府過去列明的申辦方法含混,以致民間團體一直申辦熟食墟市仍困難重重,而

無法營辦熟食墟市。

就此,本人動議署方在全港 5 個立法會選區中,各區覓一個年宵市場 及一個行人專用區舉辦熟食墟市,公開予民間團體申請有關地點舉辦 墟市,並盡早就該等選址進行地區諮詢工作。"

(Translation)

"Given the nature of Lunar New Year cooked food bazaars as traditional events, members of the public have keen demand in this regard. However, the methods of application provided by the Government in the past were confusing, so non-government organizations had all along encountered various difficulties in their application for setting up cooked food bazaars and did not find a way to operate them.

In this connection, I move that government departments identify in each of the five Legislative Council constituencies in Hong Kong a site used for Lunar New Year Fair and a pedestrian precinct for non-government organizations to apply for the setting up of cooked food bazaars, and conduct local consultations on such sites expeditiously."

- 6. <u>The Chairman</u> put Mr SHIU's motion to vote. All members present at the meeting voted for the motion. The Chairman declared the motion passed.
- 7. <u>Dr Fernando CHEUNG</u> spoke on his motion. The terms of the motion were as follows –

"特首林鄭月娥在競選政綱表示會「促進地區經濟發展,包括研究在各區增設特色墟市」,但在施政報告卻隻字不提。特首應兌現政綱,落實墟市政策,推動多元墟市發展,統一和簡化申辦程序。在各區開放試點舉辦墟市,而且不應限制墟市的形式,如熟食墟、乾貨墟、手作市集等,讓不同團體可彈性地舉辦墟市,落實「一區多市」。"

(Translation)

"Chief Executive Carrie LAM states in her manifesto that "the development of district economy will be promoted, for example through studies on the establishment of bazaars with special features in various districts", but not a word is mentioned in the Policy Address. The Chief Executive should honour her manifesto by implementing a policy on bazaars, promoting the diversified development of bazaars as well as standardizing and simplifying the application procedures. Trial sites

Action

should be opened up across districts for the establishment of bazaars and no restriction should be imposed on the bazaar format, such as cooked food bazaars, dry good bazaars, handicraft markets etc., such that different groups may set up bazaars flexibly so as to achieve "multiple bazaars in a district"."

8. <u>The Chairman</u> put Dr Fernando CHEUNG's motion to vote. The majority of members present at the meeting voted for the motion. The Chairman declared the motion passed.

(*Post-meeting note*: The terms of the motions were circulated to members vide LC Paper No. CB(1)44/17-18 on 16 October 2017.)

Follow-up actions to be taken by the Administration

- 9. The Administration was requested to provide information on:
 - (a) a comparison of the procedures in 2017 and 2018 for organizations/operators to apply for setting up LNY bazaars, with a view to demonstrating measures taken by the Government in streamlining the application procedures and enhancing the processing of applications;
 - (b) the conditions under which HD would allow a bazaar with cash transactions (whether the organizer was a non-profit making organization or not; and whether the bazaar was non-profit making in nature or not) to be set up in PRH estates using the recent Tin Yiu Estate Bazaar as an example;
 - (c) the case of a recent bazaar organized in To Kwa Wan where cash transactions were not allowed at the bazaar;
 - (d) the progress of the Administration in taking forward the proposal of setting up a festival bazaar at the "Goldfish Street" dawn market near the Mong Kok Stadium which had been considered by the Yau Tsim Mong District Council;
 - (e) how the Administration would facilitate the selling of cooked food (e.g. steamed rice-rolls) in bazaars, for example by allowing the use of relevant heating facilities; and
 - (f) the fire safety requirements in respect of a cooked food bazaar using electricity and that using naked flame, e.g. the requirements in the

type and number of fire extinguishers.

- 10. The Administration was requested to provide responses to:
 - (a) the views raised by deputations/individuals at the meeting and in their submissions; and
 - (b) the two motions passed at the meeting, including the suggestions for the Government to: (i) set up LNY bazaars and cooked food bazaars at each of the five Legislative Council constituencies; and (ii) set up cooked food bazaars at pedestrian precincts.

(*Post-meeting note*: The English and Chinese versions of the Administration's written response was issued vide LC Paper Nos. CB(1)187/17-18(02) on 6 November 2017 and 27 November 2017 respectively.)

(At 10:22 am, the Chairman ordered that the meeting be suspended for a break of five minutes. The meeting resumed at 10:29 am.)
