<u>The Chairman</u> welcomed representatives of the Administration and deputations/individuals to the meeting, and reminded the deputations/individuals that their written submissions and views presented at the meeting would not be covered by the protection and immunity provided under the Legislative Council (Powers and Privileges) Ordinance (Cap. 382).

Discussion

2. <u>The Subcommittee</u> received views from 29 deputations/individuals attending the meeting, and noted the five written submissions provided by organizations/individuals (Index of proceedings attached at **Appendix**).

(*Post meeting note:* Five written submissions tabled at the meeting (Chinese version only) were issued to members vide Lotus Notes e-mail on 7 November 2017.)

(*Post meeting note:* One written submission received from an individual, Mr CHEUNG Yin (Chinese version only) after the meeting was issued to members vide LC Paper No. CB(1)204/17-18(01) on 9 November 2017.)

3. <u>The Subcommittee</u> noted the following views expressed by deputations and individuals:

Policies on bazaars and the relevant application procedures

- (a) the Government should consider establishing regular bazaars in various districts, in particular during the weekends, to help boost local economy and tourism, and assist the grass-root people to support their living and shop for basic necessities at affordable prices;
- (b) there were only shopping centres owned and managed by the Link Real Estate Investment Trust ("Link") and large consortiums in new towns such as Tung Chung and Tin Shui Wai. The Government should identify suitable sites for setting up bazaars and temporary markets with a view to providing daily necessities for nearby residents at reasonable prices;
- (c) deputations faced a lot of difficulties in applying leisure venues under the management of the Leisure and Cultural Services Department ("LCSD") for setting up bazaars. LCSD should provide details regarding the utilization rate of its venues;
- (d) the Government should inform bazaar organizers the reasons for not approving their bazaar proposals which could facilitate organizers in revising the proposals to address the concerns raised or other interested parties in making new proposals in future;
- (e) the Government should compile a list of suitable sites for setting up bazaars including cooked food bazaars, after reviewing the situation of and facilities available at the sites (e.g. water supply and waste water discharge, availability of emergency vehicular access, etc.);
- (f) the Government should allow bazaar operators (i) to use naked flame to cook food (instead of reheating pre-cooked food) for sale at bazaars, and (ii) to use two or more stoves in each cooked food stall;
- (g) the Government should (i) formulate and implement a policy on bazaars, and set up a committee on bazaars to gauge public views and various stakeholders in formulating the policy; (ii) establish an inter-bureaux/departmental task force/one-stop platform or a designated office to facilitate the public in making applications for setting up bazaars; (iii) streamline the application procedures to facilitate interested parties in setting up bazaars; (iv) provide resources including land and related facilities like water and electricity supply to facilitate the development of bazaars; (v) set up

- a seed fund for application by bazaar organizers; and (vi) step up efforts in promoting bazaars with special characteristics to tourists;
- (h) the Chief Executive had stated in her manifesto that "the development of district economy would be promoted, for example through studies on the establishment of bazaars with special features in various districts" but it was disappointed that there was no mention of any bazaar related policy in her 2017 Policy Address;

Resource Handbook for Bazaar Applications

(i) the Resource Handbook for Bazaar Applications to be published by the Food and Health Bureau should include a designated department/official responsible for coordinating the application process for setting up bazaars;

Lunar New Year bazaars and cooked food bazaars

(j) the Government should select suitable venues (e.g. venue for Lunar New Year ("LNY") Fair) for establishing 10 LNY bazaars at the five major constituencies of Hong Kong "五區十市";

Organization of bazaars in public rental housing estates

(k) for organizers setting up bazaars at areas in public rental housing ("PRH") estates involving other owners (e.g. Link), the consent of such owners would be required in addition to the Housing Authority. The Housing Department ("HD") should provide details regarding other owners in the PRH estates;

Hawker-related issues

- (l) the Government should review the policy on hawkers, and consider issuing new fixed-pitch hawker licences (including issuing licences to hawkers' assistants) and "Dai Pai Tong" licences; and
- (m) the Government should consider allowing licensees to transfer hawker licences in order to resolve the "succession problem".

Motions

4. At 10:34 am, the Chairman informed the Subcommittee that he had received three motions respectively from Mr SHIU Ka-chun, Mr LEUNG

Yiu-chung and Mr Andrew WAN. <u>Members</u> had no objection to the Subcommittee proceeding with the motions. <u>The Chairman</u> invited the three members to speak on their motions.

5. <u>Mr SHIU Ka-chun</u> spoke on his motion. The terms of the motion were as follows –

"建議增設墟市諮詢委員會,討論長遠墟市政策,讓不同持份者定期相討墟市未來發展,推動扶助基層的墟市文化。"

(Translation)

"It is proposed that an Advisory Committee on Bazaars be set up for the discussion of a long-term policy on bazaars, to allow regular discussion by different stakeholders on the future development of bazaars and promote a culture of bazaar in support of the grass-roots."

- 6. <u>The Chairman</u> put Mr SHIU's motion to vote. All members present at the meeting voted for the motion. <u>The Chairman</u> declared the motion passed.
- 7. <u>Mr LEUNG Yiu-chung</u> spoke on his motion. The terms of the motion were as follows –

"本委員會要求食物及衞生局即將出版的「墟市資料指南」內列明部門 統籌官員的名稱及聯絡,並加上負責整個墟市申辦流程的協調及統籌 角色,當中協調部分包括:與民共議,將申辦者的計劃書遞交給當區 區議會討論,並促進各政府部門之間的溝通,促成各區墟市申請。"

(Translation)

"This Subcommittee requests that the "Bazaar Information Guide" to be published by the Food and Health Bureau should set out the names and contacts of the officials responsible for handling bazaar applications, and include a department/official to facilitate and coordinate the entire application process for setting up bazaars, including discussing with the public, submitting the proposals of applicants for discussion of the District Councils concerned, as well as promoting the communication among various government departments to facilitate bazaar applications in various districts."

8. <u>The Chairman</u> put Mr LEUNG's motion to vote. All members present at the meeting voted for the motion. <u>The Chairman</u> declared the motion passed.

9. <u>Mr Andrew WAN</u> spoke on his motion. The terms of the motion were as follows –

"建議政府增加撥款在各區找出墟市指數較高的地點作墟市試點,讓民間團體或機構恆常化地舉辦墟市,實現「一區多市」的遠景,讓熟食文化重現街頭。"

(Translation)

"It is proposed that the Government to provide funding for identification of sites with higher bazaar potential index across the districts as trial sites for community groups or organizations to organize bazaars regularly in order to realize the vision of "multiple bazaars in a district" and the reemergence of a cooked-food culture on the streets."

10. <u>The Chairman</u> put Mr WAN's motion to vote. All members present at the meeting voted for the motion. <u>The Chairman</u> declared the motion passed.

(*Post-meeting note*: The terms of the motions were circulated to members vide LC Paper No. CB(1)190/17-18 on 8 November 2017.)

Admin Follow-up actions to be taken by the Administration

- 11. The Administration was requested to provide information on:
 - (a) the benchmark set by the Commerce and Economic Development Bureau ("CEDB") for considering an event/activity (including bazaars) with tourism appeal and could showcase Hong Kong's local characteristics, such that the Hong Kong Tourism Board would provide facilitation to these events/activities including promoting them as tourist attractions to overseas visitors;
 - (b) the reason of requiring the organizer of the Hong Kong Bazaars Festival to submit a certificate by a registered engineer certifying that the venue had complied with the building safety requirement ("建築安全證明書") before displaying the publicity boards/banners at the venue;
 - (c) the case of the Kam Sheung Road Flea Market (a privately-run bazaar operated by the MTR Corporation Limited ("MTRCL")) and the Administration's follow-up actions with the imminent closure of

- the Market including whether CEDB would discuss with MTRCL to explore ways (e.g. relocation) for the Market to continue operation;
- (d) arrangement of the consultation to be conducted by the Energizing Kowloon East Office with bazaar organizers and relevant community organizations (besides non-profit making organizations) to gauge their views in taking forward the initiative of "setting up a weekend flea market on the Tourism Node site at the former airport runway tip" as announced in the Policy Agenda 2017;
- (e) the issue raised at the meeting on 13 October 2017 on which the Administration's response was outstanding:
 - (i) a table comparing the procedures in 2017 and 2018 for organizations/operators to apply for setting up LNY bazaars, so as to demonstrate measures taken by the Administration in streamlining the application procedures and enhancing the processing of applications;
- (f) the two issues raised at the meeting on 24 October 2017 on which the Administration's responses were outstanding:
 - (i) a list of open spaces at the rooftop of public markets that were managed by the Food and Environmental Hygiene Department and used for installing facilities (e.g. electrical and mechanical facilities); and
 - (ii) the Administration's response on whether the new-term Government would develop a concrete policy on bazaars.
- 12. Members noted that stall operators were allowed to cook food (instead of reheating pre-cooked food) for sale at the 6th Hong Kong Food Carnival recently organized in Kwai Chung Sports Ground. The Administration was requested to provide information on:
 - (a) the conditions under which stall operators would be allowed to cook food for sale in the Food Carnival;
 - (b) the licence(s) the operators required to apply for (e.g. Temporary Food Factory Licence, Fresh Provision Shop Licence, etc.) in the Food Carnival; and

- (c) whether the same conditions and licensing requirements could be applicable to other cooked food bazaars.
- 13. The Administration was requested to provide responses to:
 - (a) the request of some Subcommittee members for the Under Secretary for Food and Health to relay the following views to the Chief Executive:
 - (i) the Administration should appoint a Commissioner for Bazaars (" 墟 市 專 員 ") to coordinate efforts of and enhance communication among various government departments and parties during the application process for setting up bazaars; and
 - (ii) the Administration should provide a clear directive/concrete bazaar policy in the 2018 Policy Address;
 - (b) the views raised by deputations/individuals at the meeting and in their submissions, including the suggestions of (i) requiring only one 4.5kg CO2 type fire extinguisher for every two cooked food stalls if electricity or Liquefied Petroleum Gas was used; and (ii) allowing two or more stoves to be used in each cooked food stall; and
 - (c) the three motions passed at the meeting.

(*Post-meeting note*: The Chinese version of the Administration's written response was issued vide LC Paper No. CB(1)280/17-18(01) on 27 November 2017.)
