Action

I. Election of Chairman and Deputy Chairman

Election of Chairman

Mr LEUNG Yiu-chung, the member present who had the highest precedence, called for nominations for the chairmanship of the Subcommittee.

2. Mr IP Kin-yuen nominated Dr Fernando CHEUNG and Dr KWOK Ka-ki seconded the nomination. Dr Fernando CHEUNG accepted the nomination. There being no other nomination, Mr LEUNG Yiu-chung declared Dr Fernando CHEUNG elected as the Chairman of the Subcommittee. Dr Fernando CHEUNG then took the chair.

Election of Deputy Chairman

- 3. <u>Members</u> agreed to elect a deputy chairman for the Subcommittee. <u>The Chairman</u> called for nominations for the deputy chairmanship of the Subcommittee.
- 4. <u>Dr KWOK Ka-ki</u> nominated Mr SHIU Ka-chun and <u>Mr IP Kin-yuen</u> seconded the nomination. <u>Mr SHIU Ka-chun</u> accepted the nomination. There being no other nomination, <u>the Chairman</u> declared Mr SHIU Ka-chun elected as the Deputy Chairman of the Subcommittee.

II. Schedule of meetings and items for discussion

- 5. <u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).
- 6. <u>Members</u> noted a list of related issues deliberated by Panels [LC Paper No. CB(4)141/16-17(01)] and a submission from the Hong Kong Unison Limited [LC Paper No. CB(4)141/16-17(02)], which were tabled at the meeting.

- 7. <u>Members</u> suggested the following items for discussion by the Subcommittee:
 - (a) support measures for children from drug abusing families;
 - (b) support for students with special education needs, including the latest development on the pilot scheme on on-site pre-school rehabilitation services;
 - (c) services provided by the Integrated Children and Youth Services Centres;
 - (d) setting up of an inter-departmental Commission on Children;
 - (e) Law Reform Commission's consultation paper on sexual offences involving children and persons with mental impairment;
 - (f) issues related to child care services for children aged zero to two;
 - (g) issues related to the well-being and school life of children (e.g. causes of school disaffection and student suicide, implementation of "maximum homework hours" and "start school later", and provision of extra-curricular activities grant for needy students);
 - (h) provision of play equipment in children's playgrounds and barrier free facilities for disabled children;
 - (i) implementation progress of the Second Report of the Hong Kong Special Administrative Region under the United Nations Convention on the Rights of the Child;
 - (j) follow-up measures for children with elevated blood lead level in the incidents of excessive lead found in drinking water; and
 - (k) education support for ethnic minorities children.
- 8. At the suggestion of the Chairman, <u>members</u> agreed to discuss and receive views from deputations on support measures for children from drug abusing families at the next meeting.

9. <u>Members</u> agreed, in principle, to hold subsequent meetings on a monthly basis. The Secretariat would inform members of the dates of the next and subsequent meetings in due course.
