I. Children's expectation on the Government

Meeting with deputations/individuals and the Administration for agenda item I

<u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).

2. The Subcommittee received views from 41 deputations/individuals attending the meeting and four written submissions from organizations/individuals which/who had not attended/presented at the meeting. Their major views and concerns were summarized as below:

Constitutional issues

- (a) the next Chief Executive should unite Hong Kong people on all fronts, strive to improve their livelihood, uphold the rule of law, ensure the continuance of "one-country, two systems" and "Hong Kong people administering Hong Kong", implement genuine universal suffrage and improve the relationship between the executive authorities and the legislature;
- (b) the Government of the next term should genuinely give heed to the voices of young people when drawing up policies on education, employment, housing, etc;
- (c) the Government should set up an independent commission on children responsible for policies and initiatives affecting children's rights and welfare;

Education

- (d) children complained of lacking time for rest and leisure because of heavy homework, drilling exercises, tests and examinations. It was high time to conduct a comprehensive review on the existing education system and abolish the Territory-wide System Assessment ("TSA") to alleviate the study pressure of children;
- (e) to alleviate students' pressure arising from public examinations, the Administration should increase the places for higher education programmes, especially the publicly-funded degree programmes;

Action

- (f) the duration of each lesson at school should be shortened while recess and lunch break should be lengthened. The number of physical education lessons should be increased to enhance health and wellness of children;
- (g) diversified study pathways should be opened to students. Higher education institutions should offer programmes in a broad range of disciplines to nurture diverse talents for the society;
- (h) as e-learning was of growing importance, subsidies should be offered to grass-root children for acquiring suitable computers and internet access to facilitate their learning;
- (i) the Administration should step up its efforts to promote sign bilingualism in mainstream schools as well as higher education institutions to cater for the learning needs of students with hearing loss;
- (j) non-Chinese speaking ("NCS") students might have difficulties to blend into local schools. Parents of NCS students who were not well versed in both Chinese and English might have problems to communicate with schools:
- (k) subsidies should be provided for young people to participate in extra-curricular activities as well as overseas exchange programmes so as to broaden their horizons and diversify their learning experience;
- (l) the Administration should take concrete measures to prevent student suicides. Parent education should be enhanced to avoid parents from excessively boosting children's learning;
- (m) as reported by the media, the Po Leung Kuk Leadership Camps organized very harsh learning activities for their participating students. The Administration should put in place measures to monitor the quality of training camps for primary and secondary students;

Welfare

(n) under the Low-income Working Family Allowance ("LIFA") Scheme, if the family was not eligible for Basic Allowance in individual month(s), the family would not be eligible to apply for and would not be granted Child Allowance for the month(s)

Action

- concerned. This arrangement was not desirable for the interests of children in need;
- (o) the Comprehensive Social Security Assistance ("CSSA") Scheme and the Child Development Fund ("CDF") should be reviewed, with a view to supporting longer-term development of children from disadvantaged backgrounds;

Recreation and sports

- (p) the international BMX racing track in the Hong Kong Jockey Club International BMX Park ("the BMX Park") was the only qualified venue for BMX racing. However, it was in poor conditions due to a lack of maintenance and was closed subsequent to an accident in October 2016. BMX players could no longer train their racing skills at the track. The Administration should follow up with the service conditions of the BMX Park;
- (q) the Leisure and Cultural Services Department should organize more recreation and sports programmes for the public; and

Environmental protection

- (r) the Administration should improve air quality in Hong Kong.
- 3. On the views and concerns raised by members and deputations at the meeting, the Administration made the following responses –

Education

- (a) the Education Bureau ("EDB") attached great importance to the whole-person development of students. Each publicly-funded school was disbursed with different types of subsides such as the Operating Expenses Block Grant ("OEBG")/Expanded OEBG and other resources to provide students with different essential learning experiences. Schools could make use of relevant resources to organize life-wide learning activities for students' whole-person development as required in the curriculum;
- (b) EDB had issued a circular to schools reminding them to formulate an appropriate school-based homework and assessment policy and had encouraged sharing of good practices among schools. Parents might contact Regional Education Offices if they had any enquiries regarding the homework and assessment policy of the schools of their children;

- (c) a number of measures had been introduced to eliminate the incentives for over-drilling induced by TSA, such as having removed TSA from the Key Performance Measures for primary schools and not disclosing attainment rates to individual primary schools. The internal guidelines of EDB had explicitly reiterated that TSA data would not be used to assess the performance of schools. EDB had also issued letters to schools reminding them to make reference to prevailing circular on considering school-based homework and assessment arrangements to avoid over-drilling. The 2016 Tryout Study (Primary 3), which received positive feedback from participating schools, parents-teacher associations and school sponsoring bodies, would be extended to invite all schools to join. The Administration would continue to seek views of various stakeholders regarding the implementation of TSA;
- (d) the Administration strived to offer diversified pathways to students through the New Senior Secondary curriculum. For example, Applied Learning ("ApL"), in combination with the core and elective subjects, helped provide theoretical and applied learning opportunities, and develop students' career aspirations for further studies and work. Institutions in general valued the learning experiences students acquired in ApL. ApL subjects were used as elective subjects, or considered for award of extra bonus or additional information, varying by programmes. The reporting of students' performance in ApL subjects would be refined to "Attained", "Attained with Distinction (I)" and "Attained with Distinction (II)", effective from the Hong Kong Diploma of Secondary Education Examination in 2018;
- (e) under the "WiFi 900" Scheme, each school was provided with a one-off funding of \$100,000 for acquisition of mobile computing devices. Schools could make use of this funding to purchase appropriate e-learning devices for students' use;
- (f) EDB had all along been encouraging teachers to adopt the most appropriate teaching mode for students with hearing loss having regard to their abilities and needs. Relevant training programmes were provided to teachers. Meanwhile, a working group had been formed under the Rehabilitation Advisory Committee of the Labour and Welfare Bureau to promote the use of sign language in the community;

Welfare

(g) the Administration was mindful of alleviating inter-generation poverty. Examples of relevant initiatives were the CSSA Scheme, LIFA Scheme and CDF; and

Recreation and sports

- (h) the BMX Park was managed and operated by the Cycling Association of Hong Kong, China Limited ("CAHK"). In order to improve the conditions of the Park, CAHK had invited tender for the maintenance works of the Park. The tender was cancelled twice as either no tender had been received or prices received were above the estimated contract sum. The Administration would maintain contact with CAHK regarding the conditions of the Park and relay deputations' concerns to the Commissioner for Sports.
- 4. <u>The Chairman</u> requested the Administration to provide written response to the views and concerns raised by deputations and members at the meeting.

- 5. <u>The Chairman</u> advised that as a large number of deputations had indicated their intention to express views on children's expectation on the Government, the Subcommittee would arrange another meeting on 25 March 2017 at 3:30 pm to continue to receive views from the public.
