I. Rights of refugee and asylum seeking children

(LC Paper No. CB(4)1432/16-17(01) -- Paper provided by the Administration)

Meeting with deputations/individuals and the Administration for agenda item I

The Subcommittee deliberated (index of proceedings attached at **Annex**).

2. The Subcommittee received views from 24 deputations/individuals attending the meeting and a written submission from a deputation which had not attended the meeting. The major views and concerns of deputations/individuals were summarized as follows:

Unified screening mechanism

(a) the screening procedures of the unified screening mechanism ("USM") for claims for non-refoulement protection might take years to complete. If the claims were rejected by the Immigration Department ("ImmD"), a refugee or an asylum seeker could appeal to the Torture Claims Appeal Board and file a judicial review in the High Court. This meant that refugees and asylum seekers might stay in Hong Kong for a considerably long period of time and face more challenges such as daily survival, mental stress and cultural difference. The Administration should consider ways to speed up the process;

- (b) under USM, the claims of refugee and asylum seeking children and their father and/or mother were processed in one go. If their parents were from different countries of origin and their claims were unsubstantiated, they would return to their own countries respectively. Under these circumstances, refugee and asylum seeking children might have to be separated from their parents and were vulnerable to human trafficking and inhumane treatment. The claims of these children should be considered independently for their best interests;
- (c) the Administration should better protect the rights of refugee and asylum seeking children in Hong Kong in accordance with the United Nations Convention on the Rights of the Child;
- (d) refugees and asylum seekers could not leave Hong Kong pending the outcome of their claims. Otherwise, their claims would be treated as withdrawn. The Administration was urged to consider approving refugee and asylum seeking children to join overseas study tours or competitions on a discretionary basis;
- (e) the Administration should not set up detention camps to detain refugees and asylum seekers;
- (f) given the small number of refugees and asylum seekers in Hong Kong, ImmD should issue identity documents to them and permit them to reside in Hong Kong;

Support to refugee and asylum seeking children

- (g) the in-kind assistance currently provided by the International Social Service Hong Kong Branch ("ISS-HK"), as commissioned by the Social Welfare Department ("SWD"), was limited in capacity. The Administration should improve social welfare support to ensure basic needs of the refugee and asylum seeking children were met;
- (h) \$1,200 E-token provided by ISS-HK to each refugee and asylum seeker per month for purchase of food items could hardly meet their fundamental needs;
- (i) basic necessities such as washing powder, toilet papers, baby items were distributed by ISS-HK on a monthly basis to refugees and asylum seekers. However, it was reported that the supply of baby items such as disposable diapers were insufficient;

- (j) refugees and asylum seekers were to find their own flats in Hong Kong. However, the monthly rent allowance of \$1,500 per adult and \$750 per child given by ISS-HK was not enough to rent a house in Hong Kong;
- (k) ISS-HK provided refugees and asylum seekers with transportation allowance (\$200-\$420 per month) for appointments with ImmD, doctors and lawyers. The Administration was urged to provide more transportation allowance to these children who were in need of regular medical appointments at hospitals;
- (1) as many refugees and asylum seekers did not understand Chinese or English, they encountered difficulties in applying for birth certificates for their newborns given the absence of free translation/interpretation services;
- (m) while parents in Hong Kong were normally required to attend the Birth Registry once to obtain the birth certificate, refugees and asylum seekers were required to attend twice and took about fifty days before the certificate was issued. Without the birth certificate, their children could not register for medical services;
- (n) refugee and asylum seeking children whose removal was unlikely for a considerable length of time would only be provided schooling on a case-by-case basis. It was hoped that these children could be given same education opportunities as children in Hong Kong;
- (o) refugee and asylum seeking children had difficulties enrolling in schools as some schools were unwilling to admit them;
- (p) refugees and asylum seekers had difficulties in paying for uniforms, books, meals, extra-curricular activities for their children because they were not allowed to work in Hong Kong and the student financial assistance granted on a case-by-case basis would only be disbursed several months after the start of each school year. It would be more desirable to streamline the relevant application procedures to ensure that adequate financial assistance should be provided to these families before school year commenced;
- (q) after graduating from secondary schools, young refugees and asylum seekers were often denied access to higher education and were not allowed to take up employment. Many of them were idle at home and were frustrated about their uncertain future;

- (r) support measures were hardly available for refugee and asylum seeking children with special educational needs;
- (s) when refugees and asylum seekers used medical services provided by public hospitals, they were required to pay for the medical expenses chargeable for "non-eligible persons". Those with financial difficulties could apply for a one-off medical fee waiver at public hospitals and clinics or with SWD. To better address their medical needs, the Administration could consider making recommendations for annual or half-year waiver of medical expenses to them as needed;
- (t) refugee and asylum seeking children were vulnerable to psychological health problems. Sensitivity training should be provided for all front-line medical staff and social workers to enhance their professional capability in handling and accommodating special needs of these children;
- (u) assistance provided to refugee and asylum seeking children should be equivalent to the levels of Comprehensive Social Security Assistance, giving the high standard of living in Hong Kong. For instance, allowance should be given for purchase of eye glasses;
- (v) special grant for dental treatment items, such as dentures, scaling, fillings, should be provided to refugee and asylum seeking children; and
- (w) refugee and asylum seeking children were not eligible for public services, such as borrowing books from public libraries. Non-government organizations ("NGOs") should be enlisted to provide them with the necessary social support.
- 3. Members shared the views raised by deputations attending the meeting and expressed concerns about the inadequacy of assistance rendered to refugee and asylum seeking children. They opined that the Administration had international obligations to protect the rights of these children and to ensure that the support rendered to them was in compliance with international standards.
- 4. On the views and concerns raised by members and deputations at the meeting, the Administration made the following responses:

Unified screening mechanism

(a) the United Nations Convention relating to the Status of Refugees had never applied to Hong Kong. The Administration had always

- maintained a firm policy of not granting asylum and not determining or recognizing refugee status of anyone. Claimants who lodged non-refoulement claims to resist removal from Hong Kong would not be treated as "refugees" or "asylum seekers". Regardless of the outcome of their non-refoulement claims, their immigration status as illegal immigrants or overstayers would not change; they were not permitted to reside in Hong Kong;
- (b) the Administration was mindful that non-refoulement claims should be handled with a high standard of procedural fairness and would continue its efforts to expedite screening of claims and removing those whose claims had been finally rejected;
- (c) under USM, non-refoulement claimants had all reasonable opportunities to provide facts for establishing their claims. They were provided with publicly-funded legal assistance and interpretation service. In general, the grounds of a non-refoulement claim of a minor were the same as those of his/her father and/or mother. If non-refoulement claimants (including minors) had special needs, such needs might be raised to ImmD for appropriate arrangements;
- (d) non-refoulement claimants did not have a right to enter and remain in Hong Kong. If they left Hong Kong for whatever reasons, their claims would be treated as withdrawn and must not be re-opened;
- (e) the Administration had all along updated the Legislative Council's Panel on Security on the comprehensive review of the strategy of handling non-refoulement commenced in 2016;
- (f) on the suggestion of detention centre made by some members of the public, the Administration maintained an open mind on this issue. Yet, this suggestion warranted careful consideration as it involved challenges from legal, public security and resources perspectives;

Support to minors of non-refoulement claimants

(g) since 2006, SWD had commissioned ISS-HK, a non-governmental organization, through established and regular tendering procedures to offer humanitarian assistance to non-refoulement claimants in need on a case-by-case basis to prevent them from becoming destitute. Non-refoulement claimants would receive in-kind assistance from ISS-HK monthly based on individual needs and circumstances. For special cases with extra needs, ISS-HK might adjust the amount of assistance, subject to an assessment of the

- actual situation based on justifications and documental proofs provided. SWD welcomed stakeholders' feedback on the services provided by ISS-HK and would carefully and constantly review the level of assistance for the claimants;
- (h) under the humanitarian assistance programme, the monthly rent allowance was at \$1,500 and \$750 for each adult and child respectively. Non-refoulement claimants might pool together their rent allowance to rent premises. If they encounter difficulties in securing suitable accommodation, they could approach social workers or ISS-HK for assistance;
- (i) eligible non-refoulement claimants were provided with petty cash, ranging from \$200-\$420 per month, to meet travelling needs for various purposes. The transportation allowance also allowed them to have a small buffer to meet non-routine journeys, such as urgent medical appointments. The actual amount of allowance depended on their location of residence and the number of routine journeys. Additional transportation allowance for attending school, etc. would be provided upon individual case needs and relevant documental proofs available;
- (j) if minors of non-refoulement claimants would not be removed from Hong Kong in the foreseeable future and would wish to attend school whilst in Hong Kong, the Education Bureau ("EDB") would arrange for their school placements in public sector primary or secondary schools as appropriate upon confirmation from ImmD that there were no comments on allowing these children to attend schools in Hong Kong. Kindergartens were privately run and student admission was a school-based matter. EDB had reminded kindergartens to note the salient points in their school-based admission policies, such as issues related to the Race Discrimination Ordinance (Cap. 602). Non-refoulement claimants could approach EDB direct if they encountered problems in schooling arrangement of their children;
- (k) a six-month full-time Initiation Programme and 60-hour Induction Programme were offered by EDB for newly-arrived non-Chinese speaking children in Hong Kong, including minors of nonrefoulement claimants, to help them adapt to the local social environment and education system;
- (l) apart from considering applications for tuition fee subsidy on a need basis, Student Finance Office provided various student financial assistance schemes, including the Kindergarten and Child Care Centre Fee Remission Scheme, the Grant for School-related

Expenses for Kindergarten Students, the School Textbook Assistance Scheme, the Student Travel Subsidy Scheme and the Subsidy Scheme for Internet Access Charges, covering students from pre-primary to secondary levels to ensure that no students in Hong Kong would be denied access to education because of lack of means. Kindergartens were encouraged to handle with flexibility for the upfront payment in case individual students had encountered financial difficulties;

- (m) the Hospital Authority ("HA") or SWD would grant one-off waivers of medical expenses at public clinics or hospitals to non-refoulement claimants on a case-by-case basis. To assess each application, HA, ISS-HK and SWD could verify the identity of non-refoulement claimants by virtue of the recognizance form issued under Section 36(1) of the Immigration Ordinance (Cap. 115) (commonly known as "Form No. 8".) Should there be doubt on their identity, the concerned department or institution might seek verification with ImmD through the existing coordination mechanism. HA and SWD would further ascertain whether there were changes in their financial and social situation. In connection with assessing these applications, HA and SWD would consider exploring possible enhancement measures to facilitate exchange of information with ImmD;
- (n) if there was a genuine need, non-refoulement claimants, no matter adults or minors, could apply for reimbursement from ISS-HK for purchase of eye-glasses;
- (o) the Department of Health ("DH") operated the Student Health Service which provided a comprehensive range of promotive and preventive health services to primary and secondary school students. The School Dental Care Service under DH also provided dental health care for primary school students. Services were provided regardless of local residence status of the students. Medical fee and charges would be waived for those with waiver certificate issued by SWD; and
- (p) NGOs servicing non-refoulement claimants could join the partnership schemes in collaboration with the Hong Kong Public Libraries to provide community-based library services to their service targets.

- 5. <u>The Chairman</u> requested the Administration to provide the following information:
 - (a) the assistance-in-kind items and amount of transportation allowance provided by ISS-HK to non-refoulement claimants under the humanitarian assistance programme;
 - (b) the reasons for SWD commissioning ISS-HK to offer humanitarian assistance to non-refoulement claimants for more than 10 years; and
 - (c) a written response to the views and concerns raised by the deputations and members at the meeting.
