Meeting with deputations/individuals and the Administration for agenda item I

Members expressed regret at the Education Bureau's ("EDB") attendance arrangement at the meeting and requested for an explanation from the Bureau.

(*Post-meeting note*: The Administration's written response was issued to members vide LC Paper CB(4)498/17-18 on 17 January 2018.)

- 2. <u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex I**).
- 3. The Subcommittee received views from 39 deputations/individuals attending the meeting and 12 written submissions from deputations which had not attended the meeting. The major views and concerns of deputations/individuals were summarized as follows:
 - (a) according to Article 31 of the United Nations Convention on the Rights of the Child ("the Convention"), every child should have the right to rest and leisure, to engage in play and recreational activities and to participate in cultural life and the arts. However, students in Hong Kong were subject to an overload of homework, tests and examinations that deprived them of these basic rights;
 - (b) the education system in Hong Kong, which was exam and homework-oriented rather than student-centric, failed to develop each child's personality, talents and abilities to the fullest as stipulated in Article 29 of the Convention;
 - (c) as parents in Hong Kong often got mindful and nervous about their children's performance, children had a very tight schedule every day. They had to rush to attend tutorial classes and interest classes, do endless homework, and prepare for dictations, tests and examinations after long class hours. The long hours and hard work imposed on them would hamper their physical and psychological development;
 - (d) negative effects of excessive homework and examinations included children's frustration and exhaustion, lack of play, rest and family time and loss of interest in learning. Schools should refrain from unduly overburdening their students with homework, tests and examinations so as to ensure that they had sufficient time for rest and leisure to pursue their personal interest. The Administration should review the prevailing education system, with a view to alleviating

- students' academic pressure and fostering a balanced development and a healthy lifestyle for them;
- (e) pre-school students who were not supposed to have any pressure were suffering from academic pressure. For the purpose of catching up with the academic level of primary education, students attending nursery were asked to write with pencils/pens while kindergarten ("KG") students were assigned to do mechanical copying as homework. The Administration should re-examine the interface between KG and primary education;
- (f) many SEN students in mainstream schools were fed up with their studies. Schools should take into account SEN students' needs in curriculum development, differentiate homework and assessment to suit their abilities. The Administration should conduct a holistic review on the implementation of the integrated education policy, allocate additional resources to early identify SEN students as well as better support their teaching and learning, and the need for greater social equity in the broader public education system;
- (g) whole-day primary schooling was supposed to be more favourable to students, however, its implementation had deviated from its intended purpose of providing an environment conducive to an all-round and balanced education for students. In reality, time was not arranged for students to do their assignments in schools. Recess and lunch were cut short. Consideration should be given to group all taughtlessons in the morning and free up the afternoon for homework and extra-curricular activities. Duration of taught lessons should be shortened while the total time of recess and lunch break should be maintained at 100 minutes a day;
- (h) although EDB had issued guidelines to urge schools to formulate an appropriate school-based homework policy, schools still assigned heavy homework to students. EDB should suggest "an upper homework time limit" for all schools and ensure that schools had formulated and implemented the policy;
- (i) in formulating school-based homework and assessment policy, schools should take into account parents' views, strike a balance between the quality and quantity of homework, take into due consideration of learning diversity among students, and conduct regular reviews to ensure students have sufficient time for rests, enjoying the company of family members, playing games or doing physical exercises, pursuing personal interests, and developing a healthy lifestyle;

- (j) schools should carry out measures to reduce homework load and homework time to alleviate pressure of students. For instance, capping the amount of time spent on homework each day, allowing students to finish part of their homework assignments within school hours, assigning less or no homework during weekends, arranging at least one long holiday homework-free, and providing tutorial sessions to give less able students extra individual guidance on homework;
- (k) homework was meant to help children and the teacher know which skills were missing and what needed improvement. Parents should be educated not to correct their children's homework or not to do the homework for their children;
- (l) unnecessary tests or assessments, such as the Basic Competency Assessment Research Study ("BCA") at Primary Three level, should be abolished. Schools and students should be allowed to choose whether to take part in the School-based Assessment of the Hong Kong Diploma of Secondary Education Examination. Parents and students should participate in TSA at Primary Six and Secondary Three levels of their own accord;
- (m) traditionally, marks were deducted for every mistake a student made in dictations. To give students a sense of achievement, schools could consider giving points for every correct answer;
- (n) students were susceptible to emotional problems because of the burden of learning and pressure of exams. There were increasing risks of child suicide and domestic violence triggered by growing pressure to study. There should be sufficient social workers, counseling personnel and education psychologists at schools to early identify students with mental health issues and help needy students handle their problems. The policy of one school one social worker for each primary school should be implemented as early as possible. Teachers' workload should be reduced so as to enable them to have more capacity in helping students resolve their academic and emotional problems;
- (o) many students and parents viewed universities as a meal ticket for a job. However, to avoid undue pressure of students caused by public examinations, the Administration should increase the number of places of subsidized degree programmes and provide diversified pathways to secondary students. As some parents might derail their children's choice if they did not want to go to a university, the

Administration should strengthen the promotion of vocational and professional education and training and promote the recognition of qualifications under the Qualifications Framework to change parents' entrenched perception of Applied Learning subjects as a second choice;

- (p) the Administration could collaborate with non-governmental organizations and higher institutions to enhance parent education so as to prevent parents from excessively boosting their children's learning and focusing too much on academic scores;
- (q) schools and the Administration should teach children how to handle pressure;
- (r) the Administration should provide more family-friendly measures to support parents, such as introducing standard working hours, increasing the provision of child care services and after-school care services, and providing more recreation facilities for children; and
- (s) the Commission on Children to be set up by the Administration should extensively canvass views of children for the formulation of children-related policies, and assess the impact of prevailing policies to ensure the best interests of children.
- 4. Sharing deputations' views, members expressed grave concerns about students' tight schedule and undue pressure. They appealed to the Administration for taking concrete measures to address the problems, such as reviewing the curriculum of junior primary schools in light of the characteristics of children. The Chairman called on the Administration to relay their views to various councils, boards and committees under the aegis of EDB.
- 5. On the views and concerns raised by members and deputations at the meeting, the Administration made the following responses:
 - (a) the Administration noted the views expressed by members and deputations. Relevant Bureaux/Departments would strengthen its support services for students under their respective purview;
 - (b) EDB monitored the implementation of its guidelines on the homework policy through the established mechanism, such as focus inspections, regular school visits and external school reviews, etc. Given the diverse learning needs and abilities of students, it was unprofessional to set standard homework time on an across-the-board basis;

<u>Action</u>

- (c) to effectively support students in learning, schools and parents had to work together to foster a close home-school partnership. Parents might take the initiative to approach schools regarding the homework load. If parents had concerns about the school-based homework policy, they could approach Regional Education Offices of EDB direct; and
- (d) assessments, such as BCA, were conducted with the aim of providing feedback to schools for improvement in learning and teaching. The Administration would decide on the future arrangements of BCA upon completion of its review.
- 6. <u>The Chairman</u> requested the Administration to provide a written response to the views and concerns raised by deputations and members at the meeting.
