I. Election of Chairman and Deputy Chairman

Signification of membership

Mr James TO, the member present who had the highest precedence, presided at the meeting.

Prof Joseph LEE requested to put on record that he had originally 2. signified through the System for Signification of Membership and Attendance at Meetings and other Activities ("the System") not to join the Subcommittee on Issues Relating to Shopping Centres, Markets and Carparks in Public Rental Housing Estates and Home Ownership Scheme Estates ("the Subcommittee") and not to attend this He subsequently instructed his office at about 5:30 pm on 5 January 2018 to re-signify to join the Subcommittee and to attend this meeting through the His office had done so as per his instruction, but found on 6 January 2018 that his name was not on the membership list of the Subcommittee. He and his office had sought clarification with the Clerk. The Clerk responded that by the deadline for signification of membership (i.e. 5 January 2018 at 12:00 midnight), the Secretariat's system log only showed his re-signification to attend the meeting. There was no record showing that he had signified to join the Subcommittee. To express his dissatisfaction over the operation of the System, he had written to the Secretary General asking for an explanation and a review of the System. Mr James TO explained that the Clerk had mentioned the case to him before the meeting and confirmed that the Secretariat's computer record did not show that Prof LEE had signified to join the Subcommittee. He, as the presiding member, hence had no discretion to accept Prof LEE's membership under such circumstances. Prof LEE could make an application to the elected Chairman for late membership if he so wished.

Election of Chairman

- 3. <u>Mr James TO</u> called for nominations for the chairmanship of the Subcommittee. <u>Mr LEUNG Yiu-chung</u> nominated Dr KWOK Ka-ki and the nomination was seconded by <u>Mr Andrew WAN</u>. <u>Mr HO Kai-ming</u> nominated Mr Jeffrey LAM and the nomination was seconded by <u>Dr LO Wai-kwok</u>. Both <u>Dr KWOK</u> and <u>Mr LAM</u> accepted the nomination.
- 4. <u>Mr James TO</u> announced a vote by secret ballot. There was a tie vote and Mr TO drew lots to determine his casting vote according to paragraphs 11 and 12 of Appendix IV to the House Rules.

5. In accordance with the lot drawn, <u>Mr James TO</u> declared Mr Jeffrey LAM elected as the Chairman of the Subcommittee. <u>Mr LAM</u> took the chair.

Election of Deputy Chairman

- 6. <u>The Chairman</u> invited nominations for the deputy chairmanship. <u>Ms Alice MAK</u> nominated Mr HO Kai-ming and the nomination was seconded by <u>Dr LO Wai-kwok</u>. <u>Ms Claudia MO</u> nominated Dr KWOK Ka-ki and the nomination was seconded by <u>Mr Alvin YEUNG</u>. Both <u>Mr HO</u> and <u>Dr KWOK</u> accepted the nomination.
- 7. <u>The Chairman</u> announced a vote by secret ballot. As there was a tie vote, <u>the Chairman</u> drew lots to determine his casting vote. According to the lot drawn, <u>the Chairman</u> declared Mr HO Kai-ming elected as the Deputy Chairman of the Subcommittee.

8. <u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).

9. <u>The Chairman</u> said that he would work out the date of the next meeting with the Secretariat and inform members in due course.
