The term "e-waste" is added to the Waste Disposal Ordinance (Cap. 354) by section 12(3) of the Promotion of Recycling and Proper Disposal (Electrical Equipment and Electronic Equipment) (Amendment) Ordinance 2016. The term, in essence, refers to an abandoned piece of regulated electrical equipment that is specified in Schedule 6 to the Product Ecoresponsibility Ordinance (Cap. 603).

disposal (i.e. storage, treatment, reprocessing and recycling) of e-waste without a licence under section 16 of WDO would commence;

- (b) whether the Administration would consider deferring commencement of the prohibition against disposal of e-waste without a licence or introducing a grace period, so that the recycling trade would have more time to upgrade their facilities/operations in order to meet the relevant licensing requirements, and could continue to engage in e-waste recycling pending approval of their licence applications, and the reasons if the Administration would not consider so; and

Overpayment or underpayment of recycling levies would be rectified upon the registered supplier's submission of the discrepancy list, together with the audit report, to the Director of Environmental Protection ("DEP").	
		Mr CHAN asked about the reasons for introducing short-term registration for REE suppliers. The Administration explained that the short-term registration was proposed based on the relevant deliberation at the Bills Committee for the Promotion of Recycling and Proper Disposal (Electrical Equipment and Electronic Equipment) (Amendment) Bill 2015, and intended for suppliers who only operated the business of distributing REE in Hong Kong for a short period of time and in a limited scale, such as exhibition of REE conducted in Hong Kong by non-local exhibitors. While an ordinary registered supplier would need to submit quarterly returns to DEP, a short-term registered supplier would only need to submit a return covering the entire term of the short
