Discussion

Deputy Secretary (Transport) 3 (Acting) briefed the Subcommittee on the Road Tunnels (Government) Regulation 2017, Tsing Ma Control Area (Tolls, Fees and Charges) (Amendment) Regulation 2017 and Tsing Sha Control Area (Tolls, Fees and Charges) (Amendment) Regulation 2017 (L.N. 34 to L.N. 36 of 2017 respectively) ("the Amendment Regulations") to effect toll payment of government tolled tunnels and roads through electronic payment ("e-payment") facilities. With the aid of a powerpoint presentation, Chief Transport Officer/Tunnels and Tsing Ma 1, Transport Department introduced the features and operation of "stop-and-go" e-payment facilities.

(Post-meeting note: a set of the powerpoint presentation material was issued to members on 10 April 2017 vide LC Paper No. CB(4)823/16-17(01).)

The Subcommittee deliberated (index of proceedings attached at **Annex**).

Action

Completion of the scrutiny

2. The Subcommittee completed the scrutiny of the Amendment Regulations and would not propose any amendments to them.

3. The Subcommittee noted that the Chairman would move a motion to extend the scrutiny period of the Amendment Regulations at the Council meeting of 12 April 2017. If the motion was carried, the scrutiny period of the Amendment Regulations would be extended to the Council meeting of 10 May 2017 and the deadline for giving notice of amendments to the Amendment Regulations would be 2 May 2017.

(Post-meeting note: the motion to extend the scrutiny period of the Amendment Regulations was not dealt with at the Council meeting of 12 April 2017 due to unfinished business on the Agenda of the Council meeting. The scrutiny period for the Amendment Regulations has therefore expired at that Council meeting.)

4. The Subcommittee also noted that the Chairman would report the deliberations of the Subcommittee to the House Committee meeting on 28 April 2017.
