The Subcommittee completed clause-by-clause examination of the six items of subsidiary legislation gazetted on 21 April 2017 (L.N. 60 to L.N. 65) and the proposed resolution under section 12 of the Fixed Penalty (Criminal Proceedings) Ordinance (Cap. 240) ("the proposed resolution"), and would not move amendments to them (index of proceedings is in **Annex**).

Legislative timetable

2. Members noted the following legislative timetable:
 - (a) for L.N. 60 to L.N. 65 which were subject to the negative vetting procedure: if the scrutiny period was extended by resolution to the Council meeting of 14 June 2017, the deadline for giving notice to move amendments, if any, would be 7 June 2017; if the proposed resolution to extend the scrutiny period of L.N. 60 to L.N. 65 was not dealt with at the Council meeting of 24 May 2017, the scrutiny period would expire at the said Council meeting; and
 - (b) for the proposed resolution which was subject to the positive vetting procedure: the Administration planned to give fresh notice for moving the proposed resolution at the Council meeting of 28 June 2017. The deadline for giving notice to move amendments, if any, would be 21 June 2017.
3. Members also noted that the Chairman would report the Subcommittee's deliberations to the House Committee on 2 June 2017.

(Post-meeting note: At the Council meeting of 24 May 2017, the motion to extend the scrutiny period of L.N. 60 to L.N. 65 to 7 June 2017 was passed.)
