I. Election of Chairman

Dr KWOK Ka-ki was elected Chairman of the Subcommittee.

2. <u>Members</u> agreed that there was no need to elect a Deputy Chairman.

II. Meeting with the Administration

3. <u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).

Action

Amendments to be proposed by members

4. <u>Dr Junius HO</u> indicated his intention to propose amendments to the Smoking (Public Health) (Notices) (Amendment) Order 2017 ("the Amendment Order") in relation to the coverage of health warning on the two largest surfaces of the packet and retail container of tobacco products.

Follow-up actions required of the Administration

Admin 5. <u>The Subcommittee</u> requested the Administration to:

- (a) provide a list of participants from the tobacco industry attending the briefing organized by the Administration in November 2016 on technical issues relating to the implementation of the proposed amendments to the requirements of the health warning and indication of tar and nicotine yields on packet or retail container of tobacco products;
- (b) provide information about the details of, including the financial resources and manpower involved for, the publicity and public education activities to be carried out by the Administration to raise the public's awareness of the harmful effects of smoking before and six months after the coming into operation of the Amendment Order (i.e. from 21 April 2017 to 20 April 2018), as well as one year after the expiry of the six-month transitional period for sale of tobacco products with pre-amendment health warnings (i.e. from 21 April 2018 to 20 April 2019); and
- (c) advise whether the Administration would introduce plain packaging for tobacco products; and if so, the timetable for such; and if not, the reason(s) for not doing so.

Invitation of public views

6. <u>Members</u> agreed to receive views from the public on the Amendment Order. In line with usual practice, a general notice would be posted on the Legislative Council website and invitation letters would be issued to the 18 District Councils for the purpose.

Extension of scrutiny period

7. <u>Members</u> agreed that the Chairman would give notice to move a proposed resolution at the Council meeting of 17 May 2017 to extend the scrutiny period of the Amendment Order, so as to allow more time for the

Subcommittee to study the Amendment Order. Members noted that if the proposed resolution for extending the scrutiny period of the Amendment Order was not be dealt with at the Council meeting of 17 May 2017, it would then be dealt with at the Council meeting of 24 May 2017. If the proposed resolution was passed at the Council meeting, the period for amending the Amendment Order would be extended to the Council meeting of 14 June 2017; otherwise, the period for amending the Amendment Order would expire at the Council meeting of 24 May 2017.

(*Post-meeting note*: At the Council meeting of 24 May 2017, the resolution to extend the scrutiny period of the Amendment Order to the Council meeting of 14 June 2017 was passed.)

Date of future meetings

8. <u>Members</u> agreed that the next two meetings of the Subcommittee would be held on 16 May 2017 at 2:30 pm and 23 May 2017 at 2:45 pm to meet with the Administration and to receive views from the public respectively.

In his view, this would not undermine the effectiveness of the health warning. The Administration's advice that transparent seal was already used on soft pack cigarette packets in the market. The trade might also consider making the seal blend in with the design of the remaining space (i.e. 15% of the two largest surfaces) for displaying the brand name. Mr WONG Ting-kwong remarked that change of sealing materials would incur cost to the trade.	
001507 - 002102	Chairman Mr SHIU Ka-fai Admin	Mr SHIU Ka-fai expressed dissatisfaction that the Administration did not take heed of the views expressed in the motion passed by the Panel on Health Services on 20 March 2017, which urged the Government to reduce the coverage of the health warnings on the retail containers of cigars to 60% of the front surface and 90% of the back surface of the containers ("the motion on cigars"). Given that the Administration's current proposal of requiring the health warning to cover 100% of one of the two largest surfaces and 70% of the other largest surfaces of the retail containers of cigars could not address the trade's concern that the authenticity seals of the products would largely be covered by the health warnings, he urged the Administration to make reference to the practice of overseas jurisdictions. The Administration's advice that apart from the two largest surfaces of the retail container of cigars, the cigar industry could still make use of the other surfaces of the container for display of brand names and authenticity seals. 		view, the proposal under the Amendment Order was appropriate and it already provided greater flexibility to the cigar trade.	
002103 - 003959	Chairman Ms Alice MAK Clerk Admin Mr YIU Si-wing Mr CHAN Han-pan	In response to Ms Alice MAK's enquiry, the Clerk's elaboration about the legislative timetable of the Amendment Order. To tackle the technical issue that the health warnings would be obscured by the seal of soft pack cigarettes if it was not in transparent form, Mr CHAN Han-pan urged the Administration to design a new version of the 12 forms of health warning for soft pack cigarettes; and Ms Alice MAK suggested that the Administration should either allow the seal of soft pack cigarettes to partially obscure the health warnings or lower the increase in the coverage of health warning for soft pack cigarettes. The Administration's advice that: (a) the proposed new paragraph 3(8) of the Smoking (Public Health) (Notice) Order (Cap. 371B) ("the Order") provided, among others, that the health warning should not be obscured by any part of the lid of the packet or container when it was closed; an affixture to the packet or container; the wrapping of the packet or container; an affixture to that wrapping; or anything contained in that wrapping. Any	
		amendments to cater for the case of soft pack cigarettes would require the introduction of a clear definition of what constituted soft pack cigarettes and the taking into account of the varied sizes of the seals for such packets; and (b) the Amendment Order sought to remove the existing requirement that the top side of the health warning had to be no more than 12 millimeters from the top of the surface on which the health warning appeared. In effect, the health warnings could be positioned at the lower part of the packet such that space would be available on the top 15% of the two largest surfaces of the packet for accommodating the	
		trade mark and the seal. Mr CHAN han-pan's enquiry about the proposed adaptation period and Mr YIU Si-wing's enquiry as to whether there was consensus amongst the trade on the proposed adaptation period. Ms Alice MAK was of the view that the adaptation period should be further extended to provide more time for the tobacco trade to prepare and implement the new requirements.	
		The Administration's advice that to its understanding, there should be no great technical difficulties for the trade to comply with the new health warning requirements. To allow more time for the trade to get through existing stock, the adaptation period had already been extended from six months as originally proposed at an earlier time to 12 months upon gazettal of the Amendment Order on 21 April 2017. While the Amendment Order would come into operation on 21 October 2017, sale of tobacco products carrying the present form of health warnings would be allowed until 21 April 2018 (i.e. 12 months from the date of gazettal).

		On Mr CHAN Chi-chuen's enquiry about whether the Administration would introduce plain packaging for tobacco products in the future and his view that if so, local statistics should be provided to justify the proposal, the Administration advised that it would evaluate in due course after implementation of the legislative proposals the planning for further measures, including the introduction of plain packaging. According to the studies conducted by the Hong Kong Council on Smoking and Health and The University of Hong Kong ("HKU"), packets and retail containers of tobacco products were useful means of disseminating the messages on the harm of tobacco use and smoking cessation.	
		Sharing the cigar trade's concern and making reference to the practice in other jurisdictions (such as Thailand) where the coverage of health warning was different for the case of cigars, Mr CHAN Chi-chuen considered that the coverage of the health warnings on the largest surface on the front and back of a retail container of cigars should respectively be reduced from 70% as proposed to 60%, and from 100% as proposed to 90%. In response, the Administration advised that as a reference, retail containers of cigars as well as other tobacco products were all subject to the plain packaging requirements in Australia.	
004805 - 005324	Chairman Dr Junius HO Admin	Dr Junius HO's enquiry as to whether the Administration would consider reducing the increase in the coverage of health warning from at least 85% to at least 70% of the two largest surfaces of the packet or retail container of tobacco products in order to addressing the tobacco trade's concern over the seal of soft pack cigarettes; and the Administration's response that the current proposal, which had been put forth in May 2015, had wide support from the healthcare sector and the education sector.	
		On Dr Junius HO's suggestion that the tobacco trade should be allowed to carry out the design work of some, say, two, of the 12 forms of health warnings, the Administration advised that according to the Guidelines of Article 5.3 of the World Health Organization Framework Convention on Tobacco Control ("WTO FCTC"), the interests of tobacco industry were in direct conflict with the goals of public health. The tobacco industry should not be a partner in any initiative linked to setting or implementing public health policies. Dr Junius HO's view that engaging the trade to design the forms of health warning would not contravene Article 5.3 of the above Guidelines.

		Mr SHIU Ka-fai and Mr WONG Ting-kwong's concern about the Administration's counting of the 12-month adaptation period began from the date on which the Amendment Order was published in the Gazette. While the Administration had already provided the tobacco trade with an electronic archive version of the new forms of health warning upon gazettal of the Amendment Order, it was unreasonable to expect that the trade would start to modify the packaging of their products during the scrutiny period of the Amendment Bill as Members might propose resolutions to amend the proposed forms of health warning.	
		The Administration's reiteration that retail containers of cigars were subject to the same plain packaging requirements as other tobacco products for example in Australia and that there should be adequate time for the tobacco trade to get through their stock during the proposed adaptation period which would end on 21 April 2018; and its advice that:	
		(a) Article 10 of WTO FCTC required each Party to, among others, implement effective measures for public disclosure of information about the toxic constituents of the tobacco products and the emissions that they might produce. The indication of tar and nicotine yields appearing on a packet or retail containers of cigarettes would help to remind smokers that smoking contain hazardous substances; and	
		(b) apart from the smoking cessation services provided by the Hospital Authority, a range of free community-based smoking cessation services, which included counselling and consultations by doctors or Chinese medicine practitioners and targeted services to smokers among ethnic minorities, were being provided by non-governmental organizations.
