# Subcommittee on Smoking (Public Health) (Notices) (Amendment) Order 2017

# Amendments proposed by the Government

In view of the concerns expressed by subcommittee members and the trade, the Government proposes to move the following amendments to the Amendment Order –

- (a) providing flexibility for affixing the seal of soft packs;
- (b) providing health warning images of a landscape orientation; and
- (c) extending the adaptation period by two months.

The detailed justifications are set out in the ensuing paragraphs.

### Amendments related to soft packs

2. We have expressed at various occasions as well as in our papers CB(2)859/16-17(12) (Revised) and CB(2)1494/16-17(02) that transparent seals are already used on cigarette packets in the market, and their use should not be an insurmountable hurdle for the trade. Given the views of members, we have now drawn up a new set of health warning images catering for cigarette packets with seals, with size and positioning restrictions for the seal. The seal must be affixed to the top part of the two surfaces that bear the health warning and the surface that adjoins the top of those two surfaces. The following requirements also apply –

- (a) the packet does not have a lid that, when closed, forms part of a surface that bears the health warning;
- (b) the packet bears one specified seal that partially obscures the health warning appearing on a surface of the packet; and
- (c) the area of the health warning so obscured does not exceed 23 mm in width and 14 mm in length.

# Health warning images of landscape orientation

4. In view of the concerns expressed by subcommittee members, the Government will provide an additional set of health warning images, of a landscape orientation, to cater for different tobacco packets. The relevant images are at <u>Annex B</u>.

# Adaptation period

5. With amendments being proposed to the Amendment Order, the Government will extend the adaption period by two months, i.e., starting from 21 December 2017(instead of 21 October 2017), we would allow tobacco products carrying the present form or the new form of health warnings to be put to sale; and from 21 June 2018 onwards (instead of 21 April 2018), tobacco products put to sale in Hong Kong should only carry the new form of health warnings. The trade will have a full 12-month adaptation period, as in the last amendment exercise, following the scrutiny by the subcommittee and formal adoption of the Amendment Order.

6. The draft resolution to be moved by the Government is at <u>Annex C</u> for reference.

# Submissions to the Legislative Council

7. We notice that members of the public and the trade, including the Hong Kong Council on Smoking and Health and the tobacco companies as well as trade associations have made submissions to the Legislative Council (LegCo) again. The Government's response to the various issues and concerns has been set out in various papers tabled at LegCo for discussion, including CB(2)1456/14-15(07), CB(2)1808/14-15(01), CB(2)386/16-17(05), CB(2)991/16-17(12) and CB(2)859/16-17(12)(Revised) which are accessible for public information on the website of LegCo.
