Consideration of Chapter 1 of the Director of Audit's Report No. 68 (the Audit Report)

Government's support and monitoring of charities

As requested in your letter dated 29 May 2017, I append the requested information below.

(a) & (b)

A copy of Lease N is at **Annex 1**.

According to clause (6)(i) of the Special Conditions of Lease N, the Grantee "shall not erect or maintain on the lot any building or buildings other than a building or buildings comprising a headquarters including assembly hall, gymnasium, offices, shop, hostel, dormitory, canteen, staff quarters and such other ancillary accommodation and facilities as shall be approved by the Director of Social Welfare (now the Secretary for Home Affairs)". According to the Lands Department ("LandsD"), the terms "hostel" and "hotel" are generally interchangeable in the interpretation of land leases and both allow

lodging under lease. In granting Lease N, the Executive Council ("ExCo") has taken into account that revenue would be generated from Grantee N's income-generating facilities, hence allowing for reduction and eventual elimination of the Government's annual subvention for Grantee N. In this connection, it was the intention of the ExCo to allow the hostel to provide service to the general public so as to generate income for Grantee N.

As regards the catering facilities, the canteen should be open to members of Grantee N only. In June 2015, the Home Affairs Bureau ("HAB") was alerted by FEHD that the canteen, which was open to the public, should comply with the relevant lease conditions. Upon the request of HAB, Grantee N took action subsequently to obtain planning permission from the Town Planning Board and a temporary waiver from LandsD to permit the use of the canteen for restaurant purpose.

At present, Grantee N's hostel also consists of a Western restaurant and a lounge. Since these catering facilities are ancillary to the hostel, they could serve the general public. In light of the recommendations in the Director of Audit's Report, we are ascertaining with LandsD and the Planning Department ("PlanD") that the operation of the Western restaurant and lounge comply with the relevant land administration and planning requirements.

- (c) Grantee N paid a lump sum premium of \$30,200,000, which has covered all the income-generating facilities.
- (d) Grantee N wrote to the Director of Social Welfare in June 1985, indicating that "it is anticipated that the income generated will be employed to repay the loan...Thereafter, it would be possible for an appropriate reduction to be made to the Government's annual subvention". This has given effect to ExCo's understanding that income generated from the income generating facilities at Grantee N's headquarters would enable Grantee N to gradually cease to be reliant on the Government's subvention. A copy of the letter is at **Annex 2**.
- (e) In determining the level of subvention reduction, HAB would have regard to Grantee N's contribution to youth development in Hong Kong, its financial position and resources needed in the future. Before 2000, in addition to the above factors, the Social Welfare Department ("SWD") also took into account the construction cost for the headquarters and loan repayment progress of Grantee N. As Grantee N had repaid its construction loan before 2000, the construction cost and repayment of construction loan are not part of HAB's consideration in determining the level of subvention reduction.

- —— (f) The level of subvention to Grantee N since 2000 is set out in **Annex 3**.
 - (g) Since 2000, Grantee N has not submitted independent statement of accounts of the income-generating facilities of its headquarters and the vehicle park to HAB. However, the relevant accounts have been incorporated in Grantee N's annual financial reports, which are submitted to HAB annually. In light of the recommendations of the Director of Audit's Report, HAB asked Grantee N to reactivate the Management Committee in May 2017 and to submit independent statement of accounts of the income-generating facilities of its headquarters and the vehicle park.
 - (h) Meetings of the Management Committee had not been convened since 1998. When Grantee N reactivated the Management Committee in May 2017 upon HAB's request, there was no change to the Management Committee's scope and terms of reference. There were slight updates to the membership to reflect the change of supporting bureau from SWD to HAB.

While HAB had not requested Grantee N to convene meetings of the Management Committee before early 2017, after HAB assumed the role of supporting bureau for Grantee N in 2000, the representative of HAB has been attending Grantee N's Executive Committee meetings, which discuss Grantee N's financial matters as a standing item, as an observer.

(i) According to the Constitution of Grantee N, in between meetings of the Council of Grantee N, the Executive Committee shall be the authority of Grantee N in respect of major policy decisions, coordination with the Chief Commissioner, control of funds and resources and financial support. The current membership is set out in **Annex 4**.

A total of 105 meetings of the Executive Committee were held from January 2000 to May 2017. A schedule of the meetings is set out in **Annex 5**. At all the meetings, the Executive Committee made regular report on the operation of the income-generating facilities of the headquarters and vehicle park. The income and expenditure of the income-generating facilities were also discussed together with the annual budget of Grantee N.

(j) In 2004-05 and 2005-06, HAB reduced the subvention for most subvented youth uniformed groups, including reducing the subvention for Grantee N by \$0.54 million and \$0.67 million respectively. Apart from the general reduction in these two years, we agree that HAB had not initiated negotiations with Grantee N to discuss

additional subvention reduction specific to Grantee N during the period from 2000-01 to 2009-10, so we generally agree with the statement in the report.

- (k) The ExCo's decision did not specify a timeline for achieving the objective of eventual elimination of Grantee N's subvention. In light of the recommendations of the Director of Audit's Report, HAB has resumed the negotiation with Grantee N with a view to agreeing on the level and timetable of further reducing Grantee N's subvention. In this process, HAB would take into account Grantee N's contribution to youth development in Hong Kong, its financial position and resources needed in the future. If HAB determines that the ExCo's understanding of eventual elimination of subvention could not be achieved, HAB would seek ExCo's endorsement for variation.
- (1) The canteen commenced operation in July 1994 and obtained a General Restaurant Licence in February 1996. The Western restaurant and lounge commenced operation in October 1993 and August 1995 respectively. Such uses are prescribed in clause (6)(i) of the Special Conditions of Lease N mentioned in (a) above.

For the canteen, HAB was alerted by FEHD in June 2015 that the canteen, which was open to the public, should comply with the relevant lease conditions. In July and December 2015, HAB informed FEHD and LandsD respectively that the restaurant could not be regarded as an ancillary facility to Grantee N's headquarters, and hence did not comply with the relevant lease condition. Upon HAB's request, Grantee N took action subsequently to apply for a planning permission from the Town Planning Board and a temporary waiver from LandsD to permit the use of the canteen space for restaurant purpose. In January 2016, HAB informed LandsD that it supported Grantee N's waiver application subject to the imposition of full administrative fee and waiver fee. The planning permission and temporary waiver were granted in December 2016 and March 2017 respectively.

For the Western restaurant and lounge, since they are ancillary facilities to the hostel, they could serve the general public. In response to the recommendations in the Director of Audit's Report, we are ascertaining with LandsD and PlanD that the operation of the two catering facilities complies with the relevant land administration and planning requirements.

(m) At present, HAB processes land applications and monitors and enforces lease conditions in accordance with the protocol issued by LandsD in 2014. In light of the recommendations in the Director of Audit's Report, we shall consider the need of formulating further

guidelines to assist HAB staff in monitoring and enforcing lease conditions.

Thank you for your letter ref. SWD 14/5124/48 dated 23rd May, 1985 addressed to the Chief Commissioner, Mr. C.S. Chau. He is at present away from Hong Kong on annual leave but before he left, I was given instruction to reply on his behalf.

We are glad to hear that you may be able to recommend a higher level of support for facilities at our new Headquarters. I now submit to you an assessment of the possible income generating facilities from the in our schedule of accommodation and the Sketch Design June 1983 prepared by our Architect.

It is anticipated that the income generated will be employed to repay the loan (plus interest) from the Jockey Club or other financial institutions over a period of years. Thereafter, it would be possible for an appropriate reduction to be made to the Government's annual subvention to the Association.

We do appreciate that application to the Lotteries Fund for a capital grant to cover 100% of the cost of constructing, fitting-out and equipping the supported facilities may be unrealistic but we are hopeful to receive more sympathetic. consideration since we are forced to vacate our existing Headquarters building to the Government. We believe it is only fair for the Government to reprovisioning and to reinstating all the former and existing facilities which we are now enjoying at

You now may wish to reconsider the whole project and inform the Director of Lands in order that the total premium may be re-assessed and a formal submission to Executive Council prepared without further delay. I am taking the liberty to copy this letter to him for his early information.
