**31. Staff establishment and salary structure in primary schools**

Members shared the concern of the primary school sector that while the qualifications and level of responsibilities of primary school teachers and principals were comparable to those of their secondary school counterparts, the salary scales of the former compared much less favourably than those of the latter. At the meeting on 11 April 2016, the Panel passed a motion urging the Administration to expeditiously conduct a review on the existing arrangements.

In its written response, the Administration advised that as staff establishment and salary structure of primary schools were complex matters involving a wide scope of issues, it would require time to deliberate the subject.

On behalf of the Panel, the Chairman wrote to the Administration expressing disappointment with its response, which did not give any positive undertaking to carry out a review. The Secretary for Education acknowledged the concerns of members and the school sector for serious consideration, and reiterated that as the subject was complex, the Administration would map out the way forward and update the Panel on further progress at an appropriate time.

At the meeting on 28 October 2016, Hon IP Kin-yuen proposed to follow up the subject.

**32. Teaching and non-teaching manpower of special schools**

### **Issues related school premises and facilities**

#### **33. Issues related to primary schools operating in matchbox-style and sub-standard premises**

At the meeting on 22 March 2016, the Panel met with representatives of the school sector and the Administration to discuss issues related to reprovisioning of sub-standard premises. Members were concerned that there were still 28 public sector primary schools operating in matchbox-style sub-standard premises in public housing estates constructed decades ago. To obtain first-hand understanding on the difficulties faced by these schools, the Panel, accompanied by the Under Secretary for Education, paid a visit to three primary schools accommodated in matchbox-style school premises in April 2016.

To follow up the school visit and provide a forum for the Administration and the school sector to explore short-, mid- and long-term measures, the Panel Chairman convened two closed meetings in mid-May and July 2016, at which good progress was made. Members were informed that the Administration had visited more matchbox-style primary schools and engaged a consultant to examine feasible ways to tackle common problems arising from the design of these school premises. Meanwhile, the Subsidized Primary School Council had coordinated information on the problems faced by individual schools for follow-up by the Administration. Members considered that the Panel should continue to follow up the matter and handle the problems faced by other sub-standard school premises in stages.

At the meeting on 28 October 2016, Hon IP Kin-yuen proposed to follow up this subject.

The Administration proposed to report on the arrangements and progress of measures on improvement of facilities for matchbox-style school premises in the first quarter of 2017.
