Thank you for your letter of 25 January 2017. The progress and timetable for disposing of Tuen Mun Areas 38, 40, 46 and 49 for the development of modern logistics facilities are set out in the following paragraphs.

### Tuen Mun Areas 38 and 49

We have reserved two sites in Tuen Mun West totalling some 10 ha for high value-added logistics development, comprising a site of about 3.5 ha in Tuen Mun Area 49 and another of about 6.5 ha in Tuen Mun Area 38. We are working on the preparatory works for the disposal of Tuen Mun Area 49, with a view to submitting the planning application for the Town Planning Board's approval next year so as to release the site for logistics development in one to two years. As for Tuen Mun Area 38, it is currently used as a temporary fill bank and we will continue to liaise with the departments concerned on releasing the site for modern logistics use as early as practicable.

## Tuen Mun Areas 40 and 46

The Government is examining the feasibility and merits of using Tuen Mun Areas 40 and 46 for modern logistics development. The Planning Department and the Civil Engineering and Development Department jointly commissioned the "Planning and Engineering Study for Tuen Mun Areas 40 and 46 and the Adjoining Areas" in May 2013 to review the land use in the areas. The preliminary findings suggested that part of the areas is suitable for modern logistics/green industry uses. The proposed uses could meet the land demand of the two industries on one hand and create employment opportunities on the other. Based on the views collected from Stage 1 Community Engagement on the proposed land use in late 2015 as well as the planning and engineering assessments, the Government will formulate the Recommended Outline Development Plan and initial development programme.
