Legislative Council Panel on Health Services Proposal to amend the health warnings on packets and retail containers of tobacco products

At the Legislative Council Panel on Health Services (the Panel) meeting on 19 December 2016, the Government briefed Members on the progress of the proposal to amend the health warnings on packets and retail containers of tobacco products. Members requested the Government to provide information on the following –

- (a) the smoking prevalence trend of the population age group of 15 to 30 over the last decade; and
- (b) the number of summons and fixed penalty notices issued by the Tobacco Control Office for the offence of smoking in statutory

indoor no smoking areas since the amended Smoking (Public Health) Ordinance (Cap. 371) and the Fixed Penalty (Smoking Offences) (Cap. 600) came into force on 1 January 2007 and 1 September 2009 respectively.

Our response to the above is at Annex.
