As an additional requirement for a C&A home, any 2 persons being a home manager, an ancillary worker, a care worker, a health worker or a nurse shall be on duty between 6 p.m. and 7 a.m.

² Under EBPS, the minimum staffing requirements are set with reference to the actual number of beds in the home and on the basis of each staff working eight hours a day. The staffing requirements set out in the table above are the minimum requirements for an EA1 Home providing 100 C&A places.
