Occupational Safety Condition of the Hong Kong-Zhuhai-Macao Bridge ("HZMB") Projects

I refer to the letter from the Secretariat of the Panel on Manpower dated 11 May 2017, enclosing a letter of 10 May 2017 from the then-legislator Ms LAU Siu-lai addressed to the Chairman of the Panel. The Administration is requested to provide further information concerning the occupational safety of the HZMB projects. The Labour Department ("LD") sets out its reply as follows.

With regard to disclosure of the names of the principal contractors and sub-contractors involved in the prosecution cases as listed in Annex II of CB(2)1357/16-17(05) where the legal proceedings have been completed, LD has considered further advice from the Department of Justice ("DoJ"). In light of the advice and with reference to the Code on Access to Information ("the Code"), the names of defendants and relevant information of the cases heard and convicted in the past two years are set out in Annex.
