Civil Service-related Matters Featured in the 2017-18 Budget

Purpose

This paper provides some highlights on the civil service-related matters featured in the 2017-18 Budget.

Civil service establishment

- 2. While encouraging other bureaux/departments ("B/Ds") to enhance their efficiency through internal redeployment, re-prioritisation, streamlining and re-engineering, we provide them with additional manpower for implementing new policies and improving existing services through creation of new posts where justified.
- 3. The 2017-18 Draft Estimates of Expenditure provide for 3 378 additional civil service posts in various B/Ds, representing a year-on-year increase of 1.9% over the 2016-17 Revised Estimates (i.e. 178 327 posts). The change in the civil service establishment by B/Ds in 2017-18 is shown at **Annex**. In 2017-18, about 400 posts will be created in B/Ds for replacing non-civil service contract positions for which the long-term need has been established. Subject to the approval of the 2017-18 Draft Estimates by the Legislative Council, the civil service establishment is estimated to stand at 181 705 posts at the end of March 2018.

Financial provisions for work related to management of the civil service

4. The 2017-18 Draft Estimates of Expenditure seek the following financial provisions which are directly related to the policy area of management of the civil service -

- (a) Head 37 Department of Health: Programme 7 "Medical and Dental Treatment for Civil Servants": \$1,521.9 million;
- (b) Head 46 General Expenses of the Civil Service: \$3,826.7 million;
- (c) Head 120 Pensions: Programme 1 "Public and Judicial Service Pension Benefits": \$35,364.9 million;
- (d) Head 136 Public Service Commission Secretariat: \$30.4 million;
- (e) Head 143 Government Secretariat: Civil Service Bureau: \$600.6 million; and
- (f) Head 174 Joint Secretariat for the Advisory Bodies on Civil Service and Judicial Salaries and Conditions of Service: \$33.1 million.
- 5. The provision of \$1,521.9 million sought under Head 37 (paragraph 4(a) above) is for providing medical and dental services for serving civil servants, pensioners and their eligible dependants at Families Clinics and government dental clinics, as well as for payment and reimbursement of medical fees and For the former, an allocation of \$888.5 million is proposed, hospital charges. representing an increase of \$109.1 million (or 14.0%) over the 2016-17 Revised The additional provision is mainly for setting up additional Estimate. specialised dental surgeries, enhancing clinical psychology service and operating the new consultation rooms in Fanling Families Clinic on a full-year basis. Regarding the payment and reimbursement of medical fees and hospital charges, an allocation of \$633.4 million is proposed, representing an increase of \$53.4 million (or 9.2%) over the 2016-17 Revised Estimate. The additional provision is mainly for meeting the anticipated increase in applications for reimbursement of medical expenses from eligible persons.
- 6. Of the total provision sought under Head 46 (paragraph 4(b) above), an amount of \$582.1 million is for payment of local and overseas education allowances to eligible civil servants. This represents an increase of \$13.1 million (or 2.3%) over the 2016-17 Revised Estimate. Over time, the provision for local education allowance for civil servants will be reduced as recruits to the civil service since 1 June 2000 are no longer eligible for it. Likewise, the provision for overseas education allowance will also be reduced as recruits to the civil service since 1 August 1996 are no longer eligible for it. The remaining

provision sought is mainly for housing allowances, passages, the Long and Meritorious Service Travel Award Scheme, payments to estates of deceased officers, etc., which represents an increase of \$473.8 million (or 17.1%) over the 2016-17 Revised Estimate.

- 7. Of the total provision sought under Head 120 (paragraph 4(c) above), an amount of \$34,155.0 million is for pension payments to eligible retired public officers. This represents an increase of \$3,059.9 million (or 9.8%) over the 2016-17 Revised Estimate. The increase is due to an estimated increase in the number of new retirees in 2017-18 and the full-year effect of pension payments to those retiring in 2016-17. As at the end of March 2016, the present value of Government liability on pensions was \$874.7 billion.
- 8. Since 1 June 2000, new recruits to the civil service are employed on terms which attract retirement benefits under either the Mandatory Provident Fund ("MPF") Scheme or the Civil Service Provident Fund ("CSPF") Scheme. In the 2017-18 Draft Estimates of Expenditure, a total provision of \$3,948.7 million (under the expenditure heads of individual B/Ds) is sought for contributions to these Schemes. This represents an increase of \$700.8 million (or 21.6%) over the 2016-17 Revised Estimate, mainly due to an estimated increase in the number of new MPF/CSPF members in 2017-18.
- 9. The total provision sought under Head 136 (paragraph 4(d) above) is \$30.4 million. This represents an increase of \$5.4 million (or 21.6%) over the 2016-17 Revised Estimate. It is mainly due to the provision for four additional posts created in 2016-17 and a projected increase in departmental expenses.
- 10. The total provision sought under Head 143 (paragraph 4(e) above) is \$600.6 million. This represents an increase of \$23 million (or 4.0%) over the 2016-17 Revised Estimate. It is mainly due to increased salary provision for six additional posts in 2017-18, full-year salary provision for eight additional posts created in 2016-17 and salary increments for existing staff in 2017-18; and projected increase in training expenses.
- 11. The total provision sought under Head 174 (paragraph 4(f) above) is \$33.1 million. This represents an increase of \$2.7 million (or 8.9%) over the 2016-17 Revised Estimate. It is mainly due to the increase in provision for the conduct of a review on Pay Level Survey and Starting Salaries Survey, partly offset by reduced requirement for salary payments due to staff changes.
