		The Administration advised that: (a) Subject to the funding approval to be granted by FC, the Administration would fund all the public infrastructure works ("PIWs") that served to support the whole WKCD, and the works for the integrated basement. In July 2015, FC had approved about \$3 billion for implementing the first and second stages of the design, site investigation and construction works of the integrated basement. The Administration planned to seek funding approval from FC within the current legislative session for the construction of the remaining section of the underground road and associated works in Zone 3A of the integrated basement and the remaining works and essential enabling works for supporting the topside development in Zone 3B of the integrated basement, and would brief the Joint Subcommittee in the second quarter of 2017 on the funding proposals.	
		(b) In addition, the Administration would submit a funding application to FC within this legislative session for the construction of the proposed Artist Square Bridge ("ASB") connecting the MTR Kowloon Station/The Elements shopping mall and the Artist Square in WKCD, and the beautification works of the existing pedestrian subway across Austin Road West and Canton Road, and would brief the Joint Subcommittee in the second quarter of 2017 on the funding proposal.	
		In reply to Ms MO's further enquiry about the estimated cost for implementing ASB, the integrated basement and other PIWs, the Administration advised that the cost estimate for ASB could only be confirmed at a later stage. The estimated cost for implementing Zones 3A, 3B and 2B of the integrated basement and the associated PIWs as reported in previous meetings was about \$10 billion. However, the cost estimate for the remaining portions of the integrated basement (i.e. Zones 2A and 2C), which were to be implemented at a later stage, was not available yet.

		(b) Nurturing of audience was pivotal to preparing for the commissioning of the arts and cultural facilities in WKCD. As such, the Administration and WKCD should attach great importance to developing cultural software, in particular, cultivating public interest and appreciation ability in arts and culture at the community level and schools. She enquired about WKCDA's manpower resources and manpower plan for implementing or promoting arts and cultural education activities.	
		WKCDA responded that:	
		(a) The Authority recognized that the development of cultural software was important for the WKCD project and would continue its efforts in developing cultural software. The Authority had a dedicated team of 16 staff members to, among others, implement arts education and promotion activities.	
		(b) The M+ team had launched a docent volunteer programme to give regular tours of the exhibitions at the M+ Pavilion for students and other groups. Besides, the Authority had been conducting publicity for various events organized by WKCDA, such as displaying installations in the MTR stations for promotion of M+'s debut design exhibition, rolling out an outreach programme for school teachers in a bid to raise awareness about M+.	
		The Administration advised that invitations to the activities and events organized by WKCDA would be sent to members of the Joint Subcommittee.

		(a) given there were views that the duration of the M+ internship programme (i.e. six months) was too short for the interns to gain experience in museum practice, whether WKCDA would give consideration to extending the duration of each intake of the programme;	
		(b) noting that WKCDA had presented a production with a Taiwan performing arts group, whether the Authority would remove the word "National" from the names of Taiwanese arts institutions in publicity materials if their names contained the word "National"; and	
		(c) given that the construction works of the Lyric Theatre Complex ("LTC") were expected to be completed in around 2021, which was later than the original target completion date (i.e. 2020), to what extent the development of and financial arrangements for the WKCD facilities, including Xiqu Centre, LTC and M+, had been affected by the XRL project, in particular the vibration and noise disturbances arising from the project.	
		WKCDA advised that:	
		(a) The M+ team was determined to provide opportunities for the younger generation who were interested in developing a career in the museum field and to nurture talents for the future operation of M+. On top of providing employment for young people and long-term training for their junior staff, the M+ team offered short-term internship, which had been extended from three months to six months. The internship programme was intended to give fresh graduates or students during the summer vacation the opportunities to explore, participate and be stimulated.	
		(b) The Authority had modified the originally planned 1 200-seat Lyric Theatre to LTC by incorporating some of the Batch 2 facilities (including two theatre-focused units) into the original dance-focused Lyric Theatre to advance their provision. The reconfiguration of multiple performance venues in one single complex would have consequential effect on the design and

		construction schedule of LTC. On the other hand, the XRL project in itself was already a known factor when designing the WKCD facilities. WKCDA would design the WKCD facilities, including Xiqu Centre, M+ and LTC, to accommodate the vibration and noise arising from the operation of the railway lines in the vicinity with the provisions of mitigation measures and appropriate designs.	
005045-005453	Mr CHAN Chi-chuen Administration	Referring to Annex A to the discussion paper (LC Paper No. CB(1)297/16-17(02)), Mr CHAN Chi-chuen sought elaboration on the funding arrangements for the implementation of Batch 3 facilities. The Administration advised that: (a) The endowment fund of \$21.6 billion to WKCDA and the investment income would be sufficient to cover the costs of the design and construction of Batch 1, most of Batch 2 and related facilities such as retail, dining and entertainment ("RDE") facilities. As regards Batch 3 facilities, the Administration and WKCDA had been proactively exploring alternative financial arrangements with a view to identifying alternative funding/financing options for WKCDA to enable the delivery of Batch 3 facilities. The Administration would brief the Joint Subcommittee on the proposed arrangements in due course. (b) Since the site originally planned for the Centre for Contemporary Performance ("CCP") and Medium Theatre II was being occupied by the XRL project, WKCDA had proposed to incorporate Medium Theatre II and one of the black box theatres in CCP, which were Batch 2 facilities, into LTC, thereby advancing the delivery of these facilities. (c) The Administration had also been working with WKCDA to identify alternative approaches to take forward the development of the Exhibition Centre and the Musical Theatre, which had the potential to	
		be commercially viable and could be delivered through public-private partnership. The design of the Musical Theatre, which resembled Broadway Theatres, could accommodate touring and long running musicals.

		In response to Mr CHAN's further enquiry on whether the Musical Theatre would be more likely to be developed through public-private partnership, while the remaining Batch 3 facilities would be subject to alternative financial arrangements, the Administration gave an affirmative reply.

		(b) whether the land occupied by these building blocks belonged to the Government, WKCDA or the MTR Corporation Limited ("MTRCL");	
		(c) the funding arrangements and target completion schedule for Batch 3 facilities;	
		(d) whether any land parcels planned for Batch 3 facilities would be turned into sites for property development; and	
		(e) the Administration and WKCDA should avoid co-operating with private developers to develop the arts and cultural facilities at WKCD, as this would enable private developers to gain huge benefits by using public resources.	
		The Administration responded that:	
		(a) Those building blocks coloured in grey in the schematic plan referred to hotel, office or residential ("HOR") developments, which accounted for less than 50% of the total Gross Floor Area ("GFA") of WKCD. As most of the land within Zones 2A, 2B and 2C of the integrated basement was currently occupied by the MTR Corporation Limited as works areas/work sites for the construction of the West Kowloon Terminus of XRL, implementation of the topside developments within these zones (which mainly included RDE facilities and HOR developments) would be affected. There was therefore no schedule yet at this stage for HOR developments within these zones.

		(b) Under the existing arrangement, WKCDA was responsible for the development and management of the arts and cultural facilities as well as RDE facilities in WKCD. The Government owned the development right in respect of HOR developments in WKCD, and the land sale proceeds from the disposal of the HOR sites belonged to the Government.	
		(c) All land parcels planned for Batch 3 facilities under the approved Development Plan of WKCD would be used for the development of arts and cultural facilities. The Administration had not given up the development of these facilities. Indeed, the Administration and WKCDA had been proactively exploring alternative financial arrangements for WKCDA to implement them. The Administration and WKCDA would report to the Joint Subcommittee on the outcome in this regard in due course.	
010000- 010433	Mr CHU Hoi-dick Administration	Mr CHU Hoi-dick opined that, as WKCD was one single zone, it was unreasonable and against public expectation that some sites in WKCD, i.e. the sites for HOR developments, were used to generate benefits for private developers rather than the WKCD project. The Administration advised that: (a) When the upfront endowment of \$21.6 billion had been granted to WKCDA in 2008, it was envisaged that the rental proceeds from the RDE facilities would provide a major source of recurrent income for WKCDA to run the arts and cultural facilities in WKCD. However, there had been significant escalation of construction cost in Hong Kong since the approval of the endowment in 2008. Besides, due to the extended development timeframe and as a large portion of the RDE facilities were located in areas still being occupied by MTRCL, development of the RDE facilities and hence realization of RDE income had been significantly delayed.	
		(b) As mentioned by the then Chief Secretary for Administration at the meeting of the former Joint Subcommittee in May 2016, in view of the substantial funding gap, the Administration had been working closely with WKCDA to explore alternative financial arrangements for bridging the

One possible alternative financing/funding option being explored was to leverage the commercial developments in WKCD, so as to enable WKCDA to generate income to cover the costs of implementing the WKCD project. 010434-010953	Ms Claudia MO Administraton WKCDA	Ms Claudia MO raised/expressed the following enquiries/views: (a) apart from the amount of \$10 billion to be sought for developing part of the integrated basement, whether the WKCD project would require extra funding from the Government in the future; (b) given the uncertainty about the implementation of Batch 3 facilities and that WKCDA had been identifying alternative funding options such as public-private partnership, whether Batch 3 facilities would be privatized, and whether WKCDA had received enthusiastic response from the private sector; and (c) Hong Kong people did not expect that part of the WKCD project would be implemented for commercial purposes, which would deviate from the initial objective of the project. The Administration and WKCDA advised that: (a) Based on the phased implementation arrangement and as previsouly reported, the estimated total amount of funding sought/to be sought for implementing Zones 3A, 3B and 2B of the integrated basement and the associated PIWs would be \$10 billion. However, the cost estimate for the remaining portions of the integrated basement (i.e. Zones 2A and 2C), which were to be implemented at a later stage, was not available yet. The Administration would be in a better position to provide a more accurate estimate for the whole integrated basement project when the development timeframe for the later phases was known.	
		(b) The Administration and WKCDA were committed to taking forward the WKCD project in a pragmatic manner. To enable the implementation of Batch 3 facilities as planned, WKCDA had been

		exploring public-private partnership options and private sector involvement for some of the venues with commercial elements that might be constructed and operated by commercial service providers (i.e. the Exhibition Centre and the Musical Theatre). The remaining venues of Batch 3 facilities, i.e. the Great Theatre, the Music Centre and the Medium Theatre I, would be developed and operated by WKCDA.	
		(c) To enhance the overall financial viability of the core arts and cultural facilities in WKCD, the Authority had all along advocated the integration of appropriate commercial elements with some venues. For example, the Musical Theatre had been identified as one of the venues with commercial elements, the development of which would be subject to public-private partnership options. While different arts groups had been looking for performing arts venues in Hong Kong for staging their performances, there was a lack of suitable commercial theatre space for such events.

		(a) WKCDA had reviewed the viability of the Mega Performance Venue to be developed through some forms of public-private partnership. Taking into account the findings of a study relating to the establishment of the Mega Performance Venue and the territory-wide development in Hong Kong, in particular the Government would press ahead with the 50 000-seat stadium in the Kai Tak Sports Park project, the Board of WKCDA considered it not suitable to take forward the construction of the Mega Performance Venue in WKCD.	
		(b) The Exhibition Centre was one of the arts and cultural facilities of WKCD. The site designated for Exhibition Centre development was zoned "Other Specified Uses" annotated "Arts, Cultural, Entertainment and Commercial Uses" and hence an application under Section 16 of the Town Planning Ordinance was not anticipated to be necessary at this stage. The Exhibition Centre would be developed in accordance with the development parameters stipulated in the Development Plan of WKCD approved by the Chief Executive-in-Council in 2013.

Up to three organizations might operate in the Resident Company Centre.	
		(b) The Authority had been in discussion with the Xiqu industry to explore methods to help preserve and reinvent the archives of Xiqu/Cantonese Opera. At the same time, it had been working on collection of scripts of Xiqu/Cantonese Opera performances and development of an online database for relevant documentation.	
		(c) A distinctive feature of the Xiqu Centre was the location of the main theatre at the top part of the building, allowing the space below to be utilized for learning, rehearsals and exhibitions, and providing a large atrium for public use. The Authority would carefully consider how the atrium could be put into best use.

WKCDA advised that: (a) The winning design would be on display at the Nursery Park Sunset Lawn area near the waterfront and adjacent to the existing food kiosk. 		(a) why the Competition did not accept elder participants, who might also require a platform to demonstrate their competence; and
