**Extension of consultation period for the
proposed procedures for dealing with filibusters**

On 29 March 2017, the Committee on Rules of Procedure ("CRoP") issued a questionnaire vide LC Paper No. CROP 34/16-17 to invite Members' views on (a) a proposed procedure for allocation of time to debates at the Committee stage of bills; and (b) two proposed procedures for handling voluminous amendments to bills. The deadline for the consultation was 5 April 2017.

2. A group of 35 Members have subsequently submitted a joint letter to Hon Paul TSE Wai-chun, Chairman of CRoP, requesting that the consultation period be extended to the end of April, to allow more time for Members' consideration of the matter. A copy of the letter is in **Appendix**.

3. After careful consideration of the Members' request and taking into account the significance and complexity of the issues under consultation, the Chairman has directed that the consultation period be extended to **Tuesday, 25 April 2017**. Members are invited to give their views by completing and returning the questionnaire by this date.
