Construction Workers Registration Ordinance (Amendment of Schedules 1 and 1A) Notice 2016

INTRODUCTION

Under section 63A of the Construction Workers Registration Ordinance (Chapter 583) (CWRO), the Secretary for Development (SDEV) has made the Construction Workers Registration (Exemption) Regulation ("the Exemption Regulation") (**Annex A**) to exempt specified construction work and persons from the application of certain prohibition provisions of CWRO.

2. Under section 65 of CWRO, SDEV has also made the Construction Workers Registration Ordinance (Amendment of Schedules 1 and 1A) Notice 2016 ("the Amendment Notice") (Annex B) to amend Schedule 1 of CWRO to increase the number of designated trade divisions from 139 to 142, to amend Schedule 1A of CWRO to provide for the relevant work across arrangements, and to provide relevant transitional arrangements.

BACKGROUND AND JUSTIFICATIONS

3. CWRO was enacted in July 2004. Its prohibition requirements are implemented in phases. Phase one prohibition was smoothly implemented in September 2007. The remaining phase of prohibition, which is yet to be implemented, is commonly called

"designated workers for designated skills" requirement ² (DWDS requirement).

- 4. In anticipation that some stakeholders would encounter difficulties upon implementation of the DWDS requirement, we introduced the Construction Workers Registration (Amendment) Ordinance 2014³ (CWR(A)O) to LegCo in April 2014. After scrutiny by LegCo, CWR(A)O was enacted on 18 December 2014 and took effect on 1 April 2015.
- 5. CWR(A)O has pre-set the commencement date for the DWDS requirement at two years following the commencement of CWR(A)O in order to set a clear goal for the construction industry to prepare for it. With CWR(A)O took effect on 1 April 2015, the DWDS requirement will come into operation⁴ on 1 April 2017⁵.
- 6. CWR(A)O has also added section 63A to CWRO to empower SDEV making a regulation to exempt specified construction work and persons from the DWDS requirement. Details of the exemption proposal have been worked out and consulted with stakeholders. Before finalising the exemption proposal, we comprehensively reviewed the details in early 2016 and consulted the Construction Workers Registration Board (CWRB) ⁶ as well as other key stakeholders including trade associations and labour unions.

The DWDS requirement forbids any registered worker from carrying out skill work unless the worker is a registered skilled/semi-skilled worker of relevant trade division or under instruction and supervision of another person who is a registered skilled/semi-skilled worker of the relevant trade divisions. The provisions under CWRO that are not yet in operation, including sections 3(2) to (4), 4, 5(Partly), 6(Partly) and 48(1)(b) to (d), are related to DWDS requirement.

We will closely monitor the implementation of the DWDS requirement and widely consult stakeholders before SDEV considers appointing an appropriate day to extend the DWDS requirement to all construction work.

The Construction Workers Registration Board is formed under the Construction Industry Council to perform the registration function under CWRO.

7. Further, CWR(A)O has revamped the construction workers registration system⁷. In formulating the amendment proposal, the Construction Industry Council (CIC) have received requests for addition of other trade divisions, including "false ceiling installer", "partition (metal frame) installer" and "cable jointer (dead cable)" (Three Trade Divisions) but there was insufficient time to process the requests before the finalisation of the amendment proposal in April 2014. After due deliberation, CIC and industry stakeholders have recently reached consensus to add the Three Trade Divisions. On 11 May 2016, CIC formally requested SDEV to amend CWRO for addition of the Three Trade Divisions.

The Exemption Regulation

8. Pursuant to section 63A of CWRO, SDEV has made the Exemption Regulation to provide exemption from the DWDS requirement in three aspects, namely "emergency construction work", "small scale construction work" and "persons who are exempted under other specified ordinances".

Exemption for "Emergency Construction Work"

- 9. To allow contractors taking immediate action under emergency situation in the interests of the public, the Exemption Regulation exempts specified emergency construction work from the DWDS requirement for a period of 72 hours counting from the time at which the responsible contractor becomes aware of the emergency. Upon becoming aware of the emergency, the contractor must notify CIC of the commencement of the emergency work within 48 hours, and must submit a record of the emergency work to CIC within 96 hours.
- 10. In devising the proposed exemption for emergency construction work, we have taken into account all relevant factors including necessity, trade practice and safety consideration⁸. The specified emergency construction work includes the emergency work for saving human life, preventing personal injury, preventing damage to property, or preventing serious interruption or disruption to a public transport system or utility service. After due discussions and

⁷ CWR(A)O has revamped the registration system to change the registration basis from "trade" to "trade division", to create new "trade divisions", as necessary, to allow concerned workers to register under their respective modular skills, to allow skilled workers working across similar "skills", and to create "master" trade division for registration encouraging development of multiple skills. It has modified the 99 trades under CWRO Schedule 1 to 37 trades and 139 trade divisions.

consultation with stakeholders, the skill work to be exempted is limited to the ones involving the skills of the 47 designated trade divisions at Schedule 1 of the Exemption Regulation. In addition, the proposed exemption will not in any way waive the legal liabilities⁹ of relevant proprietors/employers in safeguarding the safety and health of workers/employees at work.

Exemption for "Small scale Construction Work"

11. According to the construction trade practices, some small scale construction work only requires relatively lower skill level of various trade divisions and is normally carried out by registered general workers. These general workers may not possess the full skill set or attain the required skill level to register under the relevant trade divisions involved in their work. To allow these general workers to continue their work, the Exemption Regulation exempts certain small scale construction work from the DWDS requirement. Similar to the exemption for emergency construction work, the skill work to be exempted is limited to the ones involving the skills of the 47 designated trade divisions at Schedule 1 to the Exemption Regulation. Details of the exemption, worked out after due discussions in the Task Force on Amendments to CWRO¹⁰ and consultation with stakeholders, are at Schedules 2 and 3 to the Exemption Regulation.

Exemption for Person already Exempted under other Specified Ordinances

12. In order not to affect the operation of the existing exemptions under the Gas Safety (Registration of Gas Installers and Gas Contractors) Regulations (Cap. 51D), the Electricity Ordinance (Cap. 406) and the Lifts and Escalators Ordinance (Cap. 618), the Exemption Regulation exempts a person from the DWDS requirement as and when the person is already exempted similar requirement under these Ordinances¹¹.

⁹ The Factories and Industrial Undertakings Ordinance (Cap. 59) and the Occupational Safety and Health Ordinance (Cap. 509) have set out the legal requirements for proprietors/employers to protect the safety and health of workers/employees at work, including those engaged in emergency construction work and rescue work.

We have explained to the Bills Committee for the Bill of CWR(A)O the exemption for person already exempted under other specified ordinances vide LegCo Paper No. CB(1)1684/13-14(03) (response to paragraph 8 refers).

Addition of Trade Divisions

13. Based on CIC's request as stated in paragraph 7 above, SDEV has made the Amendment Notice pursuant to section 65 of CWRO to amend Schedule 1 of CWRO for adding the Three Trade Divisions, to amend Schedule 1A of CWRO to provide for the relevant work across arrangements 12, and to provide relevant transitional provisions¹³. The description of skills, registration qualifications and work across arrangements of the Three Trade Divisions are at Annex C.

 - The skills of "false ceiling installer" and "partition (metal 14. frame) installer" are not covered under CWRO. The addition of these two trade divisions was initiated by the relevant labour union in late 2013. Based on the established mechanism¹⁴ of adding new trade divisions, CIC has scrutinised the labour union's request and industry consensus was reached in May 2016.
 - 15. In addition, according to existing trade practices, there are workers who may concentrate only on the skill of "cable jointer (dead cable)" which is a modular skill of an existing trade division "cable jointer (power)". The addition of this trade division was initiated in late 2013 by a working group of CIC in order to facilitate these workers to seek registration to meet the DWDS requirement. trade division was not added at that time to CWR(A)O because more time was required to consult industry stakeholders. In May 2016, industry consensus was reached for such addition.
 - To recognize the working experience and ensure smooth 16. transition of senior workers, based on CIC's request, the Amendment Notice introduces a one-off grandfathering arrangement for those workers of the Three Trade Divisions who will have possessed an aggregate of not less than 10 years' relevant work experience upon addition of the Three Trade Divisions. Following similar arrangement under CWR(A)O, eligible workers may directly apply for registration as registered skilled workers of the relevant new trade divisions within 18 months upon the addition of the Three Trade Divisions.

The work across arrangement is stipulated under section 3A of CWRO, which allows registered skilled workers of certain trade divisions to carry out the skilled work of other specified trade division(s) of similar work nature, but not to provide instruction and supervision to other workers for such work. The work across arrangement is applicable to the relevant trade divisions specified in Schedule 1A of CWRO.

Pursuant to section 65 of CWRO, SDEV may by notice published in the Gazette amend the Schedules of CWRO, and that notice may contain any incidental, supplementary, consequential, transitional or saving provision that may be necessary or expedient due to the notice.

application is acceptable only if a fair and reasonable reason exists.

THE EXEMPTION REGULATION AND AMENDMENT NOTICE

- 17. The main provisions of the Exemption Regulation are as follows
 - (a) **Part 1** contains preliminary provisions. It provides for the commencement of the Exemption Regulation and the definition of expression used in the regulation.
 - (b) **Parts 2 and 3** contain provisions relating to the exemptions for emergency construction work and small scale construction work (paragraphs 9 to 11 above refer).
 - (c) **Part 4** contains provisions relating to the exemption for persons already exempted under other specified ordinances (paragraph 12 above refers).
- 18. The main provisions of the Amendment Notice are as follows
 - (a) **Part 1** contains preliminary provisions. It provides for the commencement of the Amendment Notice.
 - (b) **Part 2** contains provisions to amend Schedule 1 of CWRO to increase the number of designated trade divisions from 139 to 142, and to amend Schedule 1A of CWRO to provide for the work across arrangements (paragraphs 13 to 15 above refer).
 - (c) **Part 3** contains transitional provisions required due to the amendments to the Schedule 1 of CWRO, including, inter alia, the one-off senior workers registration arrangements for the Three Trade Divisions (paragraph 16 above refers).

LEGISLATIVE TIMETABLE

19. The legislative timetable is as follows –

IMPLICATIONS OF THE PROPOSAL

20. The proposal is in conformity with the Basic Law, including the provisions concerning human rights. On economic implications, the Exemption Regulation can facilitate the smooth implementation of the DWDS requirement under CWRO, which would enhance the quality and standards of the construction industry to the benefit of the long-term development of the sector. The proposal has no financial and civil service, productivity, environmental, sustainability or family implications. The proposal does not affect the current binding effect of CWRO or its subsidiary legislation.

PUBLIC CONSULTATION

- 21. For the Exemption Regulation, we conducted extensive discussions and consultation with relevant industry stakeholders during the process of formulating the CWR(A)O from 2010 to 2013, amounting to more than 100 meetings (including 5 sessions of construction industry-wide consultation forums which are opened to the general public). We also consulted CWRB as well as other key stakeholders including trade associations and labour unions in early 2016 before finalising the regulation.
- 22. For the Amendment Notice, CIC conducted extensive discussions and consultation with the relevant industry stakeholders, and have reached consensus with the stakeholders before requesting SDEV to amend CWRO for adding the Three Trade Divisions.
- 23. On 8 November 2016, we briefed the LegCo Panel on Development on the enactment of the Exemption Regulation and the addition of the Three Trade Divisions under CWRO, and the legislative timetable. No objection was raised to the proposal.

¹⁵ For the Amendment Notice, pursuant to its section 1(1) and subject to its section 1(2), it is to commence on 1 April 2017. For the Exemption Regulation, pursuant to its section 1(1) and subject to its section 1(2), it is to commence on the date on which section 3(2) of CWRO comes into operation. SDEV will make a commencement notice by early 2017 to effect the remaining provisions (including section 3(2)) of CWRO on 1 April 2017.

PUBLICITY

- 24. A spokesperson will be available to handle the media and public enquiries.
- 25. For implementing the Exemption Regulation and the Amendment Notice, CIC will launch a series of publicity and promotional activities aiming at giving industry stakeholders a better understanding of the requirements. Preliminary activities include issuing relevant guidelines, launching a smartphone application to disseminate useful information, promoting key requirements at construction sites and conducting briefing sessions for industry stakeholders.
- 26. For information, to prepare for implementing the DWDS requirement under CWRO on 1 April 2017, CIC launched an extensive publicity and promotional campaign since January 2015. Details of the publicity and promotional activities are set out at **Annex D**.

Part 2

Construction Workers Registration (Exemption) Regulation

(Made by the Secretary for Development under section 63A of the Construction Workers Registration Ordinance (Cap. 583))

Part 1

Preliminary

1. Commencement

- (1) Subject to subsection (2), this Regulation comes into operation on the day on which section 3(2) of the Construction Workers Registration Ordinance (Cap. 583) comes into operation.
- (2) Items 25 and 31 of Schedule 1 and items 14 and 18 of Schedule 3 come into operation on the expiry of 24 months beginning on the day on which section 3(2) of the Construction Workers Registration Ordinance (Cap. 583) comes into operation.

2. Interpretation

In this Regulation—

required skills (規定技能), in relation to a designated trade division, means the skills described in column 3 of Schedule 1 to the Ordinance opposite the trade division.

Part 2

Construction Workers Registration (Exemption) Regulation

Exemption for Emergency Construction Work

3. Interpretation of Part 2

In this Part-

controller (主管), in relation to a construction site, means—

- (a) the principal contractor for the site; or
- (b) if there is no principal contractor for the site, a person who has control over, or is in charge of, the site;
- emergency work (緊急工作) means any construction work reasonably required to be carried out immediately on a construction site due to an emergency, for one or more of the following purposes—
 - (a) saving human life;
 - (b) preventing personal injury;
 - (c) preventing damage to property;
 - (d) preventing serious interruption or disruption to a public transport system or utility service;
- material time (關鍵時間), in relation to any emergency work on a construction site, means the earliest time at which a controller of the construction site becomes aware of the emergency due to which the work is required.

4. Exemption for emergency work

- (1) This section applies to any emergency work that-
 - (a) involves any required skills of a designated trade division specified in column 2 of Schedule 1 (Schedule 1 required skills); and

- (b) is carried out on a construction site within 72 hours immediately after the material time.
- (2) To the extent of the involvement of the Schedule 1 required skills in carrying out the emergency work—
 - (a) the emergency work is exempted from sections 3(2), 3A, 4 and 48(1)(b) of the Ordinance; and
 - (b) the following persons are exempted from section 4A of the Ordinance—
 - (i) the employer of a person personally carrying out the emergency work;
 - (ii) the principal contractor for the construction site.

5. Duty to notify and submit record

- (1) If any emergency work specified in section 4(1)(a) is carried out on a construction site within 48 hours immediately after the material time, a controller of the construction site must, within that period, notify the Council of the time at which the emergency work commences.
- (2) The notification must be made in a specified form.
- (3) A controller of a construction site on which any emergency work specified in section 4(1) is carried out must, within 96 hours immediately after the material time, submit to the Council a record of the emergency work.
- (4) The record must be submitted in a specified form.
- (5) A person who, without reasonable excuse, contravenes subsection (1) or (3) commits an offence and is liable on conviction to a fine at level 3.

Part 3

Construction Workers Registration (Exemption) Regulation

Exemption for Small Scale Construction Work

- 6. Exemption for specified small scale construction work
 - (1) Subsection (2) applies to any construction work described in column 2 of Schedule 2 that—
 - (a) is carried out on a construction site;
 - (b) involves any required skills of a designated trade division specified in column 2 of Schedule 1 (Schedule 1 required skills); and
 - (c) meets all the requirements set out in column 3 of Schedule 2 opposite the description (applicable requirements) when the construction work commences.
 - (2) Throughout the period during which the construction work meets all the applicable requirements and to the extent of the involvement of the Schedule 1 required skills in carrying out the construction work—
 - (a) the construction work is exempted from sections 3(2), 3A, 4 and 48(1)(b) of the Ordinance; and
 - (b) the following persons are exempted from section 4A of the Ordinance—
 - (i) the employer of a person personally carrying out the construction work;
 - (ii) the principal contractor for the construction site.
 - (3) Subsection (4) applies to any construction work described in column 2 of Schedule 2 that—
 - (a) is carried out on a construction site;
 - (b) involves any Schedule 1 required skills; and

- (c) does not meet all the applicable requirements when the construction work commences.
- (4) Throughout the period during which any uncompleted part of the construction work meets all the applicable requirements and to the extent of the involvement of the Schedule 1 required skills in carrying out that part of the construction work—
 - (a) that part of the construction work is exempted from sections 3(2), 3A, 4 and 48(1)(b) of the Ordinance; and
 - (b) the following persons are exempted from section 4A of the Ordinance—
 - (i) the employer of a person personally carrying out that part of the construction work;
 - (ii) the principal contractor for the construction site.

7. Exemption for small scale construction work involving certain designated trade divisions

- (1) Subsection (2) applies to any construction work that-
 - (a) is carried out on a construction site;
 - (b) involves any required skills of a designated trade division specified in column 2 of Schedule 3 (Schedule 3 required skills); and
 - (c) meets all the requirements set out in column 3 of Schedule 3 opposite the trade division (applicable requirements) when the construction work commences.
- (2) Throughout the period during which the construction work meets all the applicable requirements and to the extent of the involvement of the Schedule 3 required skills in carrying out the construction work—
 - (a) the construction work is exempted from sections 3(2), 3A, 4 and 48(1)(b) of the Ordinance; and

- (b) the following persons are exempted from section 4A of the Ordinance—
 - (i) the employer of a person personally carrying out the construction work:
 - (ii) the principal contractor for the construction site.
- (3) Subsection (4) applies to any construction work that—
 - (a) is carried out on a construction site;
 - (b) involves any Schedule 3 required skills; and
 - (c) does not meet all the applicable requirements when the construction work commences.
- (4) Throughout the period during which any uncompleted part of the construction work meets all the applicable requirements and to the extent of the involvement of the Schedule 3 required skills in carrying out that part of the construction work—
 - (a) that part of the construction work is exempted from sections 3(2), 3A, 4 and 48(1)(b) of the Ordinance; and
 - (b) the following persons are exempted from section 4A of the Ordinance—
 - (i) the employer of a person personally carrying out that part of the construction work;
 - (ii) the principal contractor for the construction site.

8. Exemption for small value construction work

- (1) This section applies to any construction work carried out on a construction site—
 - (a) that involves any required skills of a designated trade division specified in column 2 of Schedule 1 (Schedule 1 required skills); and
 - (b) the value of which does not exceed \$100,000.

- (2) To the extent of the involvement of the Schedule 1 required skills in carrying out the construction work—
 - (a) the construction work is exempted from sections 3(2), 3A, 4 and 48(1)(b) of the Ordinance; and
 - (b) the following persons are exempted from section 4A of the Ordinance—
 - (i) the employer of a person personally carrying out the construction work;
 - (ii) the principal contractor for the construction site.
- (3) However, subsection (2) does not apply if—
 - (a) contiguous to the construction work there is any other construction work; and
 - (b) the total value of the construction work and that other construction work exceeds \$100,000.
- (4) In this section—
- construction contract (建造合約) has the meaning given by section 2(1) of the Construction Industry Council Ordinance (Cap. 587);

value (價值)—

- (a) for any construction work that is carried out under a construction contract—
 - (i) subject to subparagraph (ii), means the consideration attributable to the construction work as stated in, or ascertainable by reference to, the contract; or
 - (ii) if the consideration referred to in subparagraph (i) is below the reasonable consideration to be expected on the open market for the carrying out of the construction work, means that reasonable consideration: or

(b) for any construction work that is not carried out under a construction contract, means the reasonable consideration to be expected on the open market for the carrying out of the construction work.

Construction Workers Registration (Exemption) Regulation

- (5) For the purposes of paragraphs (a)(ii) and (b) of the definition of *value* in subsection (4), the Council may, when ascertaining the reasonable consideration to be expected on the open market for the carrying out of any construction work, have regard to all or any of the following matters—
 - (a) the cost or value of materials used in the construction work:
 - (b) the cost or value of time, work and labour involved in the construction work;
 - (c) the equipment used in the construction work;
 - (d) such overhead costs incurred in relation to the construction work as the Council considers reasonable;
 - (e) the reasonable profit to be expected on the open market for the carrying out of the construction work;
 - (f) any other matters that the Council considers appropriate.

Part 4

Exemption Based on Other Enactments

- Exemption for person exempted under other enactments 9.
 - (1) This section applies if—
 - (a) a person who is a registered construction worker personally carries out on a construction site construction work that involves any required skills of a designated trade division specified in column 2 of Schedule 4 (Schedule 4 required skills);
 - an exemption specified in column 3 of Schedule 4 opposite the trade division is granted to the person, or to a class of persons to which the person belongs; and
 - (c) the exemption is in force at the time when the person carries out the construction work.
 - (2) In carrying out the construction work, the person is exempted from sections 3(2), 3A, 4 and 48(1)(b) of the Ordinance to the extent of the involvement of the Schedule 4 required skills—
 - (a) covered by the exemption mentioned in subsection (1)(b); and
 - (b) applied by the person in carrying out the construction
 - In relation to the person's carrying out of the construction work, the person's employer and the principal contractor for the construction site are exempted from section 4A of the Ordinance to the extent of the involvement of the Schedule 4 required skills as described in subsection (2)(a) and (b).

Explanatory Note

Under the Construction Workers Registration Ordinance (Cap. 583) (*principal Ordinance*), a person is prohibited from carrying out, without proper registration, construction work that involves any skills described in column 3 of Schedule 1 to the principal Ordinance (*required skills*) opposite a trade division set out in column 2 of that Schedule (*designated trade division*).

- 2. The main purpose of this Regulation is to exempt the following construction work from the application of certain prohibition provisions of the principal Ordinance (including the one specified in paragraph 1) (prohibition provisions)—
 - (a) any emergency construction work that—
 - (i) involves any required skills of a designated trade division specified in column 2 of Schedule 1 to this Regulation (*specified trade division*); and
 - (ii) is carried out on a construction site within 72 hours immediately after a controller of the construction site concerned becomes aware of the emergency;
 - (b) any small scale construction work that-
 - (i) is described in column 2 of Schedule 2 to this Regulation;
 - (ii) is carried out on a construction site;
 - (iii) involves any required skills of a specified trade division; and
 - (iv) meets all the requirements set out in column 3 of that Schedule opposite the description;
 - (c) any small scale construction work that—
 - (i) is carried out on a construction site;

Paragraph 3

- (ii) involves any required skills of a designated trade division specified in column 2 of Schedule 3 to this Regulation; and
- (iii) meets all the requirements set out in column 3 of that Schedule opposite the trade division;
- (d) any small value construction work--
 - (i) that is carried out on a construction site;
 - (ii) that involves any required skills of a specified trade division; and
 - (iii) the value of which does not exceed \$100,000.
- 3. This Regulation also exempts from the application of the prohibition provisions a registered construction worker who—
 - (a) has been granted an exemption specified in column 3 of Schedule 4 to this Regulation (specified exemption); and
 - (b) personally carries out construction work that involves any required skills of a designated trade division specified in column 2 of that Schedule, which are covered by the specified exemption.
- 4. Section 4A of the principal Ordinance imposes certain duty on the employer of certain registered construction workers and the principal contractor. Non-compliance of the duty is an offence. This Regulation further exempts the following persons from the application of that section—
 - (a) the employer of a person personally carrying out the construction work specified in paragraph 2 or 3;
 - (b) the principal contractor for the relevant construction site.
- 5. The exemptions under this Regulation are limited to the extent of the involvement of the relevant required skills in carrying out the construction work.

Explanatory Note

Under the Construction Workers Registration Ordinance (Cap. 583) (*principal Ordinance*), construction workers are to be registered by reference to a trade division set out in column 2 of Schedule 1 to the principal Ordinance (*designated trade division*). At present, there are 139 designated trade divisions.

- 2. This Notice amends Schedule 1 to the principal Ordinance (*Schedule 1*) to increase the number of designated trade divisions to 142. Three trade divisions are added to column 2 of Schedule 1—they are "False Ceiling Installer", "Partition (Metal Frame) Installer" and "Cable Jointer (Dead Cable)" (see section 3).
- 3. The amendments to Schedule 1 are to come into operation on 1 April 2017.
- 4. Transitional arrangements are required due to the amendments made to Schedule 1. These arrangements are provided for in Part 3 (see sections 5 to 8).
- 5. This Notice also amends the new Schedule 1A (*Schedule 1A*) added by section 36 of the Construction Workers Registration (Amendment) Ordinance 2014 (22 of 2014) to the principal Ordinance (see section 4).

Note-

Section 36 of the Construction Workers Registration (Amendment) Ordinance 2014 (22 of 2014) is to come into operation on 1 April 2017.

- 6. The amendments to Schedule 1A are to come into operation on the expiry of 24 months beginning on the day on which section 3(2) of the principal Ordinance comes into operation. Once the amendments come into force—
 - (a) a registered skilled worker for the designated trade division "Joiner" may carry out construction work

involving skills required for the designated trade division "False Ceiling Installer" or "Partition (Metal Frame) Installer";

- (b) a registered skilled worker for the designated trade division "Metal Worker" may carry out construction work involving skills required for the designated trade division "False Ceiling Installer" or "Partition (Metal Frame) Installer"; and
- (c) a registered skilled worker for the designated trade division "False Ceiling Installer" may carry out construction work involving skills required for the designated trade division "Partition (Metal Frame) Installer".

The Three Trade Divisions

The description of skills, registration qualifications and work across arrangements of the Three Trade Divisions, viz "false ceiling installer", "partition (metal frame) installer" and "cable jointer (dead cable)", are tabulated below.

- 2. For "false ceiling installer" and "partition (metal frame) installer" (the skills are currently not covered under CWRO), the DWDS requirement will apply to these two trade divisions starting from 1 April 2019 to allow 24-month for relevant workers to register. The exemption arrangements involving these two trade divisions are provided in the Exemption Regulation.
- 3. For "cable jointer (dead cable)", the DWDS requirement will apply to this trade division starting from 1 April 2017 as it is a modular skill of an existing trade division "cable jointer (power)". There is no exemption involving this trade division.
