SMOKING (PUBLIC HEALTH) ORDINANCE (CAP. 371)

SMOKING (PUBLIC HEALTH) (NOTICES) (AMENDMENT) ORDER 2017

INTRODUCTION

On 18 April 2017, the Secretary for Food and Health (SFH), in exercise of the power under section 18(2) of the Smoking (Public Health) Ordinance (Cap. 371), made the Smoking (Public Health) (Notices) (Amendment) Order 2017 ("the Amendment Order") at <u>Annex A</u> to amend the requirements of the health warning and indication of tar and nicotine yields on packet or retail container of tobacco products under the Smoking (Public Health) (Notices) Order (Cap. 371 sub. leg. B).

JUSTIFICATIONS

Background

- 2. At present, the Smoking (Public Health) (Notices) Order (Cap. 371B) stipulates that the health warning should cover at least 50% of the two largest surfaces of packet or retail container of cigarettes, cigar, pipe tobacco and cigarette tobacco in accordance with the prescribed forms and pictures. The existing Smoking (Public Health) (Notices) Order are at **Annex B.** The existing batch of health warning pictures has been used since 2007.
- 3. The World Health Organization (WHO) Guidelines recommend that two or more sets of health warnings and messages, specified from the outset, should be established to alternate after a specified period, such as every twelve to thirty-six months, as rotation of health warnings and messages and changes in their layout and design are important to maintain saliency and enhance impact. Also, the size of the health warnings and messages should cover more than 50% of the principal

display areas and aim to cover as much of the principal display areas as possible. In fact, the WHO has been advocating for plain packaging of tobacco products¹.

- 4. According to WHO Guidelines, the provision of specific sources for cessation help on tobacco packaging, such as a toll-free telephone "quitline" number, can be important in helping tobacco users to change their behaviour. Evidence also supports that the inclusion of a quitline number in health warning leads to increase in call volume to the quitline.
- 5. Having regard to the above, we propose to amend the prescribed forms (including specifications) of health warnings, the size and number of the health warnings and messages for packet or retail container of cigarettes under the Smoking (Public Health) (Notices) Order as follows
 - (a) the area of the graphic health warning shall be of a size that covers at least 85% of two largest surfaces of the packet and of the retail container;
 - (b) increases the number of forms of health warning from six to twelve;
 - (c) the following health warning message is to be included in the existing statement "HKSAR GOVERNMENT WARNING" / "香港特區政府忠告市民" –

"QUIT SMOKING FOR FUTURE GENERATIONS" / "請為你的下一代戒煙" and

"QUITLINE 1833 183" / "戒煙熱線:1833 183",

(d) the indication of tar and nicotine yields should appear on a surface other than a surface bearing the health warning.

¹ According to paragraph 46 of the Guidelines of Article 11 of FCTC, "plain packaging" is defined as "measures to restrict or prohibit the use of logos, colours, brand images or promotional information on packaging other than brand names and product names displayed in a standard colour and font style".

- 6. We propose to introduce similar changes to the graphical content and format for retail container of cigar, pipe tobacco or cigarette tobacco, except for the indication of tar and nicotine yields.
- 7. Having considered the operational issues expressed by the trade, we propose to adjust the graphical content and format requirements for retail container of cigarettes, cigar, pipe tobacco or cigarette tobacco as follows
 - (a) Technical requirement in relations to the tar and nicotine yield indication on the retail container of cigarettes

 Instead of printing the indication on a white background as required in the current legislation, there would be no restriction on the background colour of the tar and nicotine yields indication. Characters, letters and numbers, as long as clearly visible and in compliance with the requirements on font types and sizes, could be printed in black or white.
 - (b) Size of health warning requirement on the lid of a drum shape container

The English version of the same health warning would remain covering 50% of the surface area of the lid.

(c) Requirements for retail container of cigar, pipe tobacco or cigarette tobacco (except for the ones containing one cigar)

Under the adjusted proposal, with a view to providing greater flexibility, the health warning will cover 100% of one of the two largest surfaces and 70% of the other largest surface of the cigar box.

(d) Adaptation period

The full adaptation period is twelve months. Starting from 21 October 2017 (six months from the date of gazettal of the Amendment Order), we would allow both packets of tobacco products carrying the present form or the new form of health warnings to be put to sale.

Starting from 21 April 2018 (12 months from the date of gazettal of the Amendment Order), packets of tobacco products put to sale in Hong Kong should only carry the new form of health warnings as set out in the Amendment Order.

THE AMENDMENT ORDER

8. The Amendment Order amends Cap. 371B to amend the prescribed form (including specifications) of the health warning and indication of tar and nicotine yields on packet or retail container of tobacco products. Subject to scrutiny by the Legislative Council (LegCo) under section 34 of Cap. 1 of the laws of Hong Kong, the Amendment Order will come into operation on 21 October 2017 and provides another six months for adaptation that ends on the day that is six months after the commencement date.

LEGISLATIVE TIMETABLE

9. The legislative timetable is as follows –

IMPLICATIONS OF THE PROPOSAL

10. The Amendment Order is in conformity with the Basic Law, including the provisions concerning human rights. It will not affect the binding effect of the Smoking (Public Health) Ordinance. Additional staffing and financial implications, if any, arising from the implementation of the proposal will be absorbed within the existing manpower and financial resources of the Government. It has no economic, environmental and sustainability implications.

PUBLIC CONSULTATION

11. The Government consulted members of the Legislative Council Health Services Panel (HS Panel) in May 2015 and attended a special meeting with deputations on 6 July 2015. In May 2016, the Government issued a letter to the trade setting out the detailed specifications of the proposal. With a view to facilitating the trade's understanding, the Government organised a briefing on the technical issues relating to the implementation of the proposals in November 2016. The Government reported the progress at the HS Panel meeting on 19 December 2016 and attended another meeting with deputations on 17 January 2017. Subsequently, the Government attended the HS Panel meeting on 28 February and 20 March 2017 for further discussion of the proposal.

PUBLICITY

12. The Department of Health will inform local tobacco companies of the revision made to the prescribed form (including specifications) of the health warning and indication of tar and nicotine yields on packet or retail container of tobacco products. Information relevant to the Amendment Order can also be accessed through the Tobacco Control Office's website upon gazettal.

- (5) Despite subparagraph (4), if a packet or container is in the shape of a cylindrical drum—
 - (a) the health warning must be in one of the forms prescribed in Part 2A of the Schedule;
 - (b) the Chinese version of the warning—
 - (i) must appear on the curved surface of the drum; and
 - (ii) must cover at least 85% of the area of that surface; and
 - (c) the English version of the same warning—
 - (i) must appear on the top surface of the lid of the drum; and
 - (ii) must cover at least 50% of the area of that surface.
- (6) For subparagraphs (4)(a) and (5)(a), each form of the health warning prescribed in Part 2 or 2A of the Schedule must appear on the packets and retail containers of each brand of cigarette with equal frequency during any continuous period of 24 months.
- (7) The indication of tar and nicotine yields—
 - (a) must be in either of the forms prescribed in Part 2C of the Schedule; and

(b) must appear on a surface of each packet and of each retail container other than a surface bearing the health warning.

- (8) The health warning and indication of tar and nicotine yields appearing on a packet or retail container must not be obscured by—
 - (a) any part of the lid of the packet or container when it is closed;
 - (b) an affixture to the packet or container;
 - (c) the wrapping of the packet or container;
 - (d) an affixture to that wrapping; or
 - (e) anything contained in that wrapping.
- (9) The health warning and indication of tar and nicotine yields may appear on a label securely affixed to a packet or retail container if—
 - (a) the packet or container is made of metal or is a plastic drum; or
 - (b) the Commissioner of Customs and Excise approves the affixing of the label to the packet or container on being satisfied that—
 - it is not reasonable to expect to have had a health warning and an indication of tar and nicotine yields printed on the packet or container at the time of its manufacture; and
 - (ii) the approval is required for a limited period of time or in relation to a particular consignment of cigarettes only.".

 - (a) the Chinese version of the warning—
 - (i) must appear on the largest surface on the front of the container; and
 - (ii) must cover at least 70% of the area of that surface; and
 - (b) the English version of the same warning—

- (i) must appear on the largest surface on the back of the container; and
- (ii) must cover 100% of the area of that surface.
- (6) For a retail container of pipe tobacco or cigarette tobacco—
 - (a) the 2 surfaces bearing the warning must bear the Chinese version and English version of the same warning respectively; and
 - (b) each version of the warning must cover at least 85% of the area of the surface on which it appears.
- (7) Despite subparagraphs (4), (5) and (6), if a container is in the shape of a cylindrical drum—
 - (a) the health warning must be in one of the forms prescribed in Part 2A of the Schedule;
 - (b) the Chinese version of the warning—
 - (i) must appear on the curved surface of the drum; and
 - (ii) must cover at least 85% of the area of that surface; and
 - (c) the English version of the same warning—
 - (i) must appear on the top surface of the lid of the drum; and
 - (ii) must cover at least 50% of the area of that surface.
- (8) For subparagraphs (4)(a) and (7)(a), each form of the health warning prescribed in Part 2 or 2A of the Schedule must appear on the retail containers of each brand of cigar, pipe tobacco or cigarette tobacco with equal frequency during any continuous period of 24 months.







Explanatory Note

The main purpose of this Order is to amend the Smoking (Public Health) (Notices) Order (Cap. 371 sub. leg. B) (*principal Order*) to revise the requirements for health warnings on packets and retail containers of tobacco products.

- 2. Under the current law, each packet and retail container of cigarettes and each retail container of other tobacco products must bear a health warning in a prescribed form. The health warning must cover at least 50% of the areas of the 2 largest surfaces of the packet or retail container. At present, a total of 6 forms of health warnings are prescribed.
- 3. The Order amends paragraphs 3, 4A and 4AA of the principal Order—
 - (a) generally to increase the coverage of the health warning to 85% of the areas of the 2 largest surfaces of a packet or retail container;
 - (b) for a packet or retail container in the shape of a cylindrical drum, to increase the coverage of the health warning to 85% of the area of its curved surface (but the coverage for the lid remains to be 50%);
 - (c) for a retail container of cigars, to increase the relevant coverage to 70% (on the front) and 100% (on the back) of the areas of the largest surfaces concerned;
 - (d) to require the indication of tar and nicotine yields to be separately printed on a surface of a cigarette packet and retail container other than the surfaces bearing the health warning; and
 - (e) to make other minor textual amendments.

- 4. Parts II, IIA and IIB of the Schedule to the principal Order are repealed and replaced by the new Parts 2, 2A and 2B. The new Parts prescribe 12 new forms of health warning with new messages. In addition, there are technical changes to the specifications of the forms.
- 5. A new Part 2C is added to the Schedule to the principal Order to prescribe the forms and specifications of the indication of tar and nicotine yields on a packet and retail container of cigarettes.
- 6. The Order comes into operation on 21 October 2017. A transitional period of 6 months is provided for in the Order. In the premises, the Order provides a 12-month adaptation period from the date on which it is published in the Gazette.

- (1) For the purposes of section 8 of the Ordinance, this paragraph applies to any packet of cigarettes containing 20 or more cigarettes and any retail container of cigarette packets containing any number of cigarettes.
- (2) Subject to subparagraph (3), each cigarette packet and each retail container shall bear a health warning and indication of tar and nicotine yields in one of the forms set out in Part II of the Schedule.
- (3) For each brand of cigarette, each of the forms so set out shall be borne on the packets containing that brand of cigarette and on the retail containers containing those packets with equal frequency during any continuous period of 12 months.
 - (4) Subject to subparagraphs (5) and (8)—
 - (a) the health warning and indication of tar and nicotine yields shall appear on the 2 largest surfaces of the packet and of the retail container;
 - (b) one of those surfaces shall bear the Chinese version of the health warning and indication of tar and nicotine yields and the other surface shall bear the English version of the same health warning and indication of tar and nicotine yields; and
 - (c) the top side of the area containing the Chinese or English version of the health warning and indication of tar and nicotine yields shall be no more than 12 millimetres from the top of the surface on which that version appears.
- (5) If a packet or retail container is in the form of a drum, the Chinese version of the health warning and indication of tar and nicotine yields shall appear on the curved surface of the drum and the English version of the same health warning and indication of tar and nicotine yields shall appear on the lid.
- (6) The Chinese or English version of the health warning and indication of tar and nicotine yields shall be of a size that covers at least 50% of the area of the surface on which that version appears.
- (7) No health warning and indication of tar and nicotine yields shall appear in such a manner that it is obscured by any affixture to the packet or retail container, the wrapping of the packet or retail container or any affixture to the wrapping of the packet or retail container.
- (8) The health warning and indication of tar and nicotine yields may be printed on a label securely affixed to the packets or retail containers—
 - (a) if the packets or retail containers are made of metal or are plastic drums;
 - (b) with the approval of the Commissioner of Customs and Excise where he is satisfied that—
 - (i) the circumstances in which the packets or retail containers are in Hong Kong, or are to be brought to Hong Kong, are such that they could not reasonably be expected to have had printed on them a health warning and indication of tar and nicotine yields at the time of their manufacture; and
 - (ii) the approval is required for a limited period of time or in relation to a particular consignment of cigarettes only.

- (2) Subject to subparagraph (3), each retail container shall bear a health warning in one of the forms set out in Part IIA of the Schedule.
- (3) For each brand of cigar, pipe tobacco or cigarette tobacco, each of the forms so set out shall be borne on the retail containers containing that brand of cigar, pipe tobacco or cigarette tobacco with equal frequency during any continuous period of 12 months.
 - (4) Subject to subparagraphs (5) and (8)—
 - (a) the health warning shall appear on the 2 largest surfaces of the retail container; and
 - (b) one of those surfaces shall bear the Chinese version of the health warning and the other surface shall bear the English version of the same health warning.
- (5) If a retail container is in the form of a drum, the Chinese version of the health warning shall appear on the curved surface of the drum and the English version of the same health warning shall appear on the lid.
- (6) The Chinese or English version of the health warning shall be of a size that covers at least 50% of the area of the surface on which that version appears.
- (7) No health warning shall appear in such a manner that it is obscured by any affixture to the retail container, the wrapping of the retail container or any affixture to the wrapping of the retail container.
- (8) The health warning may be printed on a label securely affixed to the retail containers with the approval of the Commissioner of Customs and Excise where he is satisfied that the circumstances in which the retail containers are in Hong Kong, or are to be brought to Hong Kong, are such that they could not reasonably be expected to have had printed on them a health warning at the time of their manufacture.

- (5) No health warning shall appear in such a manner that it is obscured by any affixture to the retail container, the wrapping of the retail container or any affixture to the wrapping of the retail container.
- (6) The health warning may be printed on a label securely affixed to the retail containers with the approval of the Commissioner of Customs and Excise where he is satisfied that the circumstances in which the retail containers are in Hong Kong, or are to be brought to Hong Kong, are such that they could not reasonably be expected to have had printed on them a health warning at the time of their manufacture.
