Shipping and Port Control (Amendment) Regulation 2017

(Made by the Chief Executive in Council under section 80 of the
Shipping and Port Control Ordinance (Cap. 313))

1. Commencement

This Regulation comes into operation on 1 December 2017.

2. Shipping and Port Control Regulations amended

The Shipping and Port Control Regulations (Cap. 313 sub. leg. A) are amended as set out in sections 3 to 7.

3. Regulation 15 amended (failure of radiotelephone equipment)

(1) Regulation 15(1), Chinese text—

- (a) a vessel must not enter the Hong Kong Link Road Special Area No. 1 specified in paragraph 29 of the Fifth Schedule by crossing over the south-western boundary of the Special Area specified in paragraph 32 of that Schedule; or
- (b) a vessel must not enter the Hong Kong Link Road Special Area No. 2 specified in paragraph 30 of the Fifth Schedule by crossing over the north-eastern boundary of the Special Area specified in paragraph 33 of that Schedule.”.

- (b) a vessel which has a height exceeding that specified in paragraph 23(a) of the Fifth Schedule must not enter or pass through the Tuen Mun-Chek Lap Kok Link Area No. 2 specified in paragraph 23(b) of that Schedule; or
 - (c) a vessel which has a height exceeding that specified in paragraph 24(a) of the Fifth Schedule must not enter or pass through the Tuen Mun-Chek Lap Kok Link Area No. 3 specified in paragraph 24(b) of that Schedule.
- (3C) Except with the permission of the Director—
- (a) a vessel which has a height exceeding that specified in paragraph 25(a) of the Fifth Schedule must not enter or pass through the Hong Kong Link Road Area No. 1 specified in paragraph 25(b) of that Schedule;
 - (b) a vessel which has a height exceeding that specified in paragraph 26(a) of the Fifth Schedule must not enter or pass through the Hong Kong Link Road Area No. 2 specified in paragraph 26(b) of that Schedule;
 - (c) a vessel which has a height exceeding that specified in paragraph 27(a) of the Fifth Schedule must not enter or pass through the Hong Kong Link Road Area No. 3 specified in paragraph 27(b) of that Schedule; or
 - (d) a vessel which has a height exceeding that specified in paragraph 28(a) of the Fifth Schedule must not enter or pass through the Hong Kong Link Road Area No. 4 specified in paragraph 28(b) of that Schedule.

(3D) Except with the permission of the Director, a vessel which has an overall length exceeding 10 metres must not enter or pass through the Hong Kong Link Road Special Area No. 3 specified in paragraph 31 of the Fifth Schedule.”.

Explanatory Note

This Regulation amends the Shipping and Port Control Regulations (Cap. 313 sub. leg. A) (**Regulations**)—

- (a) to specify the geographical co-ordinates defining—
 - (i) the Tuen Mun-Chek Lap Kok Link Area No. 1;
 - (ii) the Tuen Mun-Chek Lap Kok Link Area No. 2;
 - (iii) the Tuen Mun-Chek Lap Kok Link Area No. 3;
 - (iv) the Hong Kong Link Road Area No. 1;
 - (v) the Hong Kong Link Road Area No. 2;
 - (vi) the Hong Kong Link Road Area No. 3;
 - (vii) the Hong Kong Link Road Area No. 4;
 - (viii) the Hong Kong Link Road Special Area No. 1;
 - (ix) the Hong Kong Link Road Special Area No. 2;
 - (x) the Hong Kong Link Road Special Area No. 3;
 - (xi) the South-Western Boundary of the Hong Kong Link Road Special Area No. 1; and
 - (xii) the North-Eastern Boundary of the Hong Kong Link Road Special Area No. 2;
- (b) to prohibit vessels exceeding certain heights from entering or passing through the areas mentioned in subparagraph (a)(i) to (vii);
- (c) to prohibit vessels from entering the area mentioned in subparagraph (a)(viii) by crossing over the boundary mentioned in subparagraph (a)(xi);
- (d) to prohibit vessels from entering the area mentioned in subparagraph (a)(ix) by crossing over the boundary mentioned in subparagraph (a)(xii);

- (e) to prohibit vessels of an overall length exceeding 10 metres from entering or passing through the area mentioned in subparagraph (a)(x); and
 - (f) to make minor textual amendments to the Chinese text of the Regulations.
