**財務委員會 2 月 9 日會議  
就 FCR(2017-18)56 的跟進事項**

- (a) 民政事務局網頁上的“私人遊樂場地契約下的開放計劃(為合資格外界團體而設的-政府部門除外)體育會所(非營舍)”的文件中是否沒有包括香港哥爾夫球會粉嶺設施(委員普遍稱為“粉嶺哥爾夫球會”)和沒有涵蓋該設施的原因。

答：由香港哥爾夫球會持有的粉嶺高爾夫球場用地，其現行租約是在 1999 年批出至 2020 年，2011-12 年續約條件訂立的開放體育設施計劃規定並不適用於粉嶺高爾夫球場，所以上述載於民政事務局網頁的文件並不包括粉嶺高爾夫球場。然而，香港哥爾夫球會於 2012 年開始，參照開放體育設施計劃的規定，自願開放其高爾夫球場及練習場予合資格外界團體使用。

連同粉嶺高爾夫球場在內，於 2011-12 年時租約仍未屆滿的契約用地共有 15 幅(有關用地的地點及承租人名稱已載於附件 A)，其中 3 幅用地的承租人已接受個別市民租用其設施，其餘用地的承租人已自願向合資格外界團體開放其設施，這些自願開放計劃的詳情已載於民政事務局網站：

答：粉嶺高爾夫球場用地於過去五年的季度報告已載於附件 B。

- (c) 當局就私人遊樂場地契約政策進行公眾諮詢前，會否率先公布由民政事務局成立的跨部門工作小組就私人遊樂場地契約政策進行的檢討工作的結果及建議，及公眾諮詢的流程為何。

答：民政事務局已於三月二十日至九月十九日期間就私人遊樂場地契約政策檢討進行公眾諮詢。公眾諮詢文件已臚列民政事務局成立的跨部門工作小組就契約政策的檢討結果及建議，有關文件已載於民政事務局網站：
