## I. Meeting with the Administration

#### Follow-up actions to be taken by the Administration

2. <u>The Bills Committee</u> requested the Administration to:

- (a) in respect of the escalator connecting B3 level and B4 level as shown in Section B-B in Annex 1 to Plan No. 1 in Schedule 2 to the Bill, clarify whether any part of such escalator was not shown in Section B-B and if so, whether such part fell within the Mainland Port Area or not; and clarify whether there were any other escalators connecting B2, B3 and/or B4 levels within the Mainland Port Area;
- (b) consider indicating in the form of a plan the location of the escalator(s) connecting B3 level and B2 level referred to in Note 1 in Annex 1 to Plan No. 1 in Schedule 2;
- (c) in respect of the marking "-4.0 mPD" shown in Section A-A in Annex 1 to Plan No. 1 in Schedule 2 and Note 3 in Plan No. 2, clarify whether the vertical limit of the Mainland Port Area at the Atrium as shown in Section A-A in Annex 1 to Plan No. 1 was the only exception to the vertical limit of the Mainland Port Area as stated in Note 3 in Plan No. 2; and
- (d) consider providing definitions for the phrases "train compartment", "passenger train" and "in operation" appearing in clause 5 of the Bill.

(*Post-meeting note*: The Chinese and English versions of the Administration's response 1 were issued to members vide LC Paper No. CB(4)1032/17-18(03) on 4 and 11 May 2018 respectively.)
