#### Election of Chairman

  - (c) how port inspections of fishing vessels carrying Antarctic marine living resources and seeking to enter Hong Kong waters would be conducted; and how to ensure that, in the event that a vessel seeking to enter Hong Kong was suspected of having had engaged in illegal, unreported and unregulated fishing activities, public officers concerned would have the necessary capability to undertake frontline enforcement work, in particular, handling the testing of toothfish samples; and
  - (d) the reasons for giving the Commission for the Conservation of Antarctic Marine Living Resources a legal personality in Hong Kong (clause 3 of the Bill); what "necessary" means in clause 3(b) of the Bill; and the exact function(s) to be performed by that Commission for the purposes of this Ordinance (if the Bill is passed).
