I. Meeting with the Administration

Draft amendments proposed by the Administration

2. The Bills Committee completed examining and did not raise objection to the draft amendments proposed by the Administration to the Electoral Legislation (Miscellaneous Amendments) Bill 2018 ("the Bill") as set out in its paper [LC Paper No. CB(2)458/18-19(01)]. In response to the observation given by the Legal Adviser to the Bills Committee, the Administration confirmed that the words "批註" after the words "選票上批註了" in the Chinese text of the proposed new section 51A(2)(c) and (d) of the Electoral Procedure (Chief Executive Election) Regulation (Cap. 541J) (as proposed to be added by the new clause 61A of the Bill) were redundant and should be deleted. The Administration undertook to provide after the meeting the revised draft amendments to the Bill for consideration by the Legal Adviser to the Bills Committee and onward circulation to members of the Bills Committee.

Legislative timetable

3. <u>The Chairman</u> said that pending the Administration's provision of the revised draft amendments to the Bill referred to in paragraph 2 above, the Bills Committee would complete the scrutiny of the Bill. <u>The Administration</u> proposed to resume the Second Reading debate on the Bill at the Council meeting of 16 January 2019. No members raised objection. <u>The Chairman</u> said that accordingly, he would report the deliberations of the Bills Committee to the House Committee on 4 January 2019. <u>Members</u> noted that the deadline for giving notice to move amendments to the Bill was 7 January 2019.
