

A BILL

To

Apply a sum not exceeding \$450,477,990,000 to the services of the Government in the financial year ending on 31 March 2019.

Enacted by the Legislative Council.

1. Short title

This Ordinance may be cited as the Appropriation Ordinance 2018.

2. Authorization of appropriation

The appropriation in the manner expressed in the Schedule of a sum not exceeding \$450,477,990,000 from the general revenue for the services of the Government in the financial year commencing on 1 April 2018, and ending on 31 March 2019, is authorized.

Explanatory Memorandum

This Bill seeks to authorize the appropriation of \$450,477,990,000 for the services of the Government in the financial year commencing on 1 April 2018. Clause 2 provides that this sum may be appropriated out of the general revenue in the manner set out in the Schedule.
