LEGISLATIVE COUNCIL BRIEF

SUPPLEMENTARY APPROPRIATION (2016-2017) BILL

INTRODUCTION

At the meeting of the Executive Council on 26 September 2017, the Council ADVISED and the Chief Executive ORDERED that the Supplementary Appropriation (2016-2017) Bill, at **Annex A**, seeking approval for supplementary appropriation of \$8,260,644,566.27 from the general revenue for the services of the Government in the 2016-17 financial year, should be introduced into the Legislative Council (LegCo).

JUSTIFICATIONS AND BACKGROUND

2. The Appropriation Ordinance 2016 authorised the expenditure of a total sum of \$426,197,511,000 from the general revenue for the services of the Government in the 2016-17 financial year and the provision for each head of expenditure as provided for in the 2016-17 estimates of expenditure.

3. In the course of the 2016-17 financial year, the Government has either sought the LegCo Finance Committee's approval for, or approved under delegated authority, supplementary provisions for various heads of expenditure mainly for meeting additional expenses arising from the 2016-17 civil service pay adjustment and provision of extra allowances to social security recipients. As required under section 8(8) of the Public Finance Ordinance (PFO), the Government has provided quarterly updates to LegCo on supplementary provisions approved.

4. The annual accounts for the 2016-17 financial year have been finalised. In accordance with section 9^{*} of the PFO, we need to introduce a Supplementary Appropriation Bill into LegCo as soon as practicable. The purpose is to reconcile the differences between the sums originally appropriated for each head of expenditure under the General Revenue Account and the actual expenditure if these sums are exceeded.

THE SUPPLEMENTARY APPROPRIATION (2016-2017) BILL (THE BILL)

5. For 34 of the 84 heads of expenditure under the General Revenue Account, the actual expenditure for the 2016-17 financial year has exceeded the original appropriation by a total of \$8,260,644,566.27, as detailed in Annex B. Accordingly, the Bill provides for a supplementary appropriation of this amount over and above the sum appropriated by the Appropriation Ordinance 2016.

^{*} Note Section 9 - "If at the close of account for any financial year it is found that expenditure charged to any head is in excess of the sum appropriated for that head by an Appropriation Ordinance, the excess shall be included in a Supplementary Appropriation Bill which shall be introduced into the Legislative Council as soon as practicable after the close of the financial year to which the excess expenditure relates."

1. Short title

Clause 1

This Ordinance may be cited as the Supplementary Appropriation (2016–2017) Ordinance.
