#### 1. Commencement

This Bylaw comes into operation on 1 June 2018.

# 2. Housing (Traffic Contraventions) (Fixed Penalty) Bylaw amended

#### "9A. Transitional provision—Housing (Traffic Contraventions) (Fixed Penalty) (Amendment) Bylaw 2018

- (1) Despite section 9(1), if a person receives a notice in Form 1 or 2 in the pre-amended Schedule 3 issued before 1 June 2018, the person may pay the fixed penalty within the period of time stated in the notice, personally or through the person's agent, at any magistracy specified in the notice.
- (2) If a person pays a fixed penalty under subsection (1), section 9(2), (3), (4) and (6) applies to the payment as if it were made under section 9(1) as in force immediately before 1 June 2018.



#### **Explanatory Note**

This Bylaw amends the Housing (Traffic Contraventions) (Fixed Penalty) Bylaw (Cap. 283 sub. leg. C) (*principal Bylaw*)—

- (a) to remove certain references related to the magistracies in the principal Bylaw, so that the fixed penalty payable under the principal Bylaw may no longer be paid at the magistracies;
- (b) to specify that the fixed penalty may be paid through the phone-banking service provided by banks;
- (c) to update Forms 1 and 2 in Schedule 3 to the principal Bylaw; and
- (d) to provide for transitional arrangements.

# Speech by the Secretary for Transport and Housing for Moving of the Motion proposed pursuant to the Housing (Traffic Contraventions) (Fixed Penalty) Bylaw (Cap. 283C) <u>at the Legislative Council Meeting on 21 March 2018</u>

Mr President,

I move that the motion under my name, as printed on the Agenda, be passed.

Currently, in accordance with the Fixed Penalty (Traffic Contraventions) Regulations (Cap. 237A), the Fixed Penalty (Criminal Proceedings) Regulations (Cap. 240A) or the Housing (Traffic Contraventions) (Fixed Penalty) Bylaw (Cap. 283C), a notice of fixed penalty and demand notice in relation to traffic contraventions may be issued. Persons involved in such traffic contraventions may pay the fixed penalty prior to the commencement of court proceedings by any of the means specified in the above regulations or bylaw and the relevant notices. The means of payment include by post addressed to the Treasury; personally or through an agent at any Post Office (other than a post office letter box or a mobile post office), or at any magistracy specified in the relevant notices; through any automated teller machine of a bank; by phone by using the service commonly known as PPS; or through the Internet.

2. The Judiciary has recently reviewed the matter in relation to

fixed penalty payments in the light of its institutional independence. As a matter of principle, if no court proceeding is initiated, any collection of fixed penalty payments is a matter between the Government and the person concerned. The Judiciary should not collect such payments, which are not court payments, on behalf of the Government. Moreover, as the Government will become one of the parties to a court case if so initiated later, the Judiciary does not consider it appropriate for the Magistrates' Courts to be involved in the payment processes before the initiation of the court case. This may affect the neutrality of the Judiciary, perceived or real. On the other hand, after a court case is initiated, the Judiciary considers it appropriate for the Magistrates' Courts to collect such payments. This is similar to the arrangements for other payments that may be ordered by the court arising from court proceedings.

3. Based on the above reasons, the Judiciary has proposed to remove the present payment collection functions of the Magistrates' Courts for fixed penalty in respect of traffic contraventions before any court proceedings are initiated. In practice, with various means of making fixed penalty payments in respect of traffic contraventions before any court proceedings are initiated, as set out above, the proposal should not cause any significant inconvenience to persons who intend to make such payments. On the Judiciary's proposal, the Transport and Housing Bureau and the Judiciary Administration submitted an information paper to the Legislative Council Panel on Administration of Justice and Legal Services on 18 July 2017. The members did not object to this proposal.

4. In addition, the means of payment specified in the relevant notices is not updated, including that fixed penalty payment can no longer be made through the website or kiosks under the "Electronic Service Delivery" Scheme; the URL addresses of websites of the Treasury and Hongkong Post have been changed; the means of payment through phone-banking service provided by banks has been provided under relatively newer statutory provisions; and it is proposed to delete the postal address of the Treasury to maintain flexibility.

5. In light of the above, I hereby move a motion under Section 30(1) of the Housing Ordinance to amend the relevant provisions, notice of fixed penalty, and demand notice of the Housing (Traffic Contraventions) (Fixed Penalty) Bylaw (Cap. 283C), to (a) remove references to Magistrates' Courts in respect of the collection of fixed penalty, including their addresses and office hours; (b) clearly specify that the fixed penalties may be paid through the phone-banking service provided by banks; and (c) update the means of payment via (i) the Internet and (ii) Hongkong Post. If this motion is passed, the amended Bylaw will come into effect on 1 June 2018.

6. Mr President, with these remarks, I invite Members to support this motion.
