# Reply:

To support Hong Kong residents in the Mainland and Taiwan, the Mainland and Taiwan Offices collect and update from time to time practical information, including on medical care, education and legal services etc., and disseminate such information through the production of information booklets and on the offices' websites to assist Hong Kong residents to adapt to living in the area.

2. The number of copies of information booklets (including the "Practical Guide for Hong Kong People Living in the Mainland" of Guangdong) published by the Mainland and Taiwan Offices in the past 5 financial years is as follows:

- 3. As publishing the information booklets is an integral part of the roles and functions of the Mainland and Taiwan Offices, the estimated expenditure involved cannot be separately singled out and itemised.
- 4. The information booklets providing practical guide to living in different areas are published by the respective Mainland and Taiwan Offices, with the exception of the "Practical Guide for Hong Kong People Living in the Mainland" of Guangdong which is jointly published by the Guangdong Economic and Trade Office (GDETO) and the Hong Kong Federation of Trade Unions (HKFTU). In this case, GDETO is responsible for all the editing and printing work (including paying the printing cost) while HKFTU is responsible for providing and updating part of the contents which is mainly on daily life matters. The "Practical Guide for Hong Kong People Living in the Mainland" of Guangdong is available for distribution not only at GDETO and its Liaison Units, but also at HKFTU and its enquiry service centres in Guangzhou, Shenzhen, Dongguan, Huizhou and Zhongshan.

#### Reply:

The Equal Opportunities Commission (EOC) has set up a Working Group on Education for Ethnic Minorities (Working Group) which comprises EOC members, academics, representatives of non-governmental organisations (NGOs), school sponsoring bodies, community leaders of ethnic minorities (EM), etc. Through a series of sharing sessions, the Working Group is collecting the views of Chinese language teachers, EM students and parents as well as NGOs on the current position of Chinese language learning by EM students. Upon completion of all sharing sessions in September, the Working Group will discuss and summarise the views collected and make a submission to the Government by end 2018. The work is covered by the EOC's internal manpower resources and does not involve additional provision from the Government.

2. As in the past, the Education Bureau and other relevant departments will make every effort to facilitate the work of the EOC.

The estimate for 2018-19 for "promotional activities on equal opportunities and human rights" is \$7,016,000, 43% lower than that of \$12,325,000 in 2017-18. In this regard,

- i) please list out in table form the "promotional activities" and "promotional activities on equal opportunities and human rights" organised by the Government last year and the expenditure involved.
- ii) what are the reasons for the drastic decrease in the expenditure by the Government? Also, how can the Government ensure that the related activities and promotion can sustain with the decrease in expenditure?

# Reply:

The provision for "promotional activities on equal opportunities and human rights" under "Other Charges" of Subhead 000 Operational Expenses is allocated to education and promotion activities in respect of children, sexual minorities, ethnic minorities (EMs) and fundamental human rights. The provision for "promotional activities" is allocated to the Mainland and Taiwan Offices (namely the Beijing Office and the Hong Kong Economic and Trade Offices (ETOs) in Guangdong, Shanghai, Chengdu and Wuhan, and the Hong Kong Economic, Trade and Cultural Office in Taiwan) to promote Hong Kong.

2. In 2017-18, the Constitutional and Mainland Affairs Bureau (CMAB) promoted equal opportunities and human rights on various fronts through different channels, including in respect of children, to implement the Children's Rights Education Funding Scheme, as well as to publish and distribute comic booklets of the Convention on the Rights of the Child; in respect of sexual minorities, to launch Equal Opportunities (Sexual Orientation)

Funding Scheme, to take various publicity measures such as Announcements in the Public Interest (API), advertisement, seminar and briefing session to promote equal opportunities for sexual minorities (including promotion of the Code of Practice against Discrimination in Employment on the Ground of Sexual Orientation) and to co-operate with Radio Television Hong Kong (RTHK) to produce a TV programme which makes reference to real-life scenarios encountered by the sexual minorities; in respect of EMs, to co-operate with RTHK to produce a TV series on integration with ethnic minorities and to organise media experience / school outreach programme and website design on racial equality; in respect of fundamental human rights, to conduct Human Rights Forum and Children's Rights Forum, and to take various publicity measures such as API and advertisement to promote the Code on Access to Information, etc. The revised estimate of the relevant work in 2017-18 is \$12.325 million.

- 3. Under the estimate for "promotional activities on equal opportunities and human rights" in 2017-18, CMAB included two one-off funding, namely a sum of \$3 million to the Equal Opportunities Commission (EOC) for promoting equal opportunities of ethnic minorities; and another \$1.63 million and \$0.5 million for the production of RTHK's television programmes titled "Rainbow Crossroad" and "Hong Kong, My Home" respectively. The public can now watch the above programmes on online platforms. Excluding the above two one-off provisions, the estimate for 2018-19 is similar to the previous year.
- 4. CMAB will also work with the EOC to ensure that it has adequate resources to discharge its functions and duties.
- 5. In 2017-18, the Mainland and Taiwan Offices showcase and promote Hong Kong's strengths through various channels by, amongst others, organising and participating in talks, exhibitions and seminars; organising and participating in public relations/cultural exchange functions/events; giving public speeches, media interviews and briefings; and issuing information circulars, newsletters and press releases. The revised estimate of the above work in 2017-18 is \$99.52 million.
- 6. In 2017-18, the Mainland Offices organised numerous activities in the Mainland to celebrate the 20th anniversary of the establishment of the Hong Kong Special Administrative Region, as well as prepared for the setting up of 3 liaison units (namely Zhejiang Liaison Unit under the Shanghai ETO, Guangxi Liaison Unit under the Guangdong ETO and Shaanxi Liaison Unit under the Chengdu ETO), thus contributing to a significant rise in the expenditure on publicity and promotion. With the conclusion of the celebration activities and the commencement of operation of the 3 liaison units, the estimate in 2018-19 has resumed to its normal level. The Mainland and Taiwan Offices will continue to promote Hong Kong through appropriate channels.

To follow up on Question Serial No. 1027 and Reply Serial No. CMAB083:

It is mentioned in the Question (Serial No. 1027) that the estimate for the Office of the Privacy Commissioner for Personal Data (PCPD) in 2018-19 is \$7.55 billion. The Bureau has also indicated in the Reply that PCPD received 17 127 cases of complaints and enquiries in 2017.

It is noted that an individual who suffers damage by reason of a contravention of a requirement under the Personal Data (Privacy) Ordinance by a data user may be entitled to compensation from that data user for that damage. Upon filing a complaint to PCPD, the individual who intends to institute proceedings to seek compensation from the data user concerned may apply to PCPD for legal assistance. In this connection, please advise on the following:

- 1. the number of complaints and enquiries received by the PCPD in the past 3 years;
- 2. the number of cases where the complainants had applied directly for legal assistance in the past 3 years, with a breakdown by the applications approved, applications granted with limited legal assistance, applications rejected and applications withdrawn by complainants;
- 3. the numbers of cases where the complainants had applied for legal assistance after mediation in the past 3 years, with a breakdown by the applications approved, applications granted with limited legal assistance, applications rejected and applications withdrawn by complainants;

At present, cases of the PCPD's Legal Assistance Scheme are mainly handled by its in-house lawyers, and external lawyers are engaged as necessary to provide assistance. In the past 3 years, the total expenditures on engaging external lawyers under the Legal Assistance Scheme are \$53,000 (2015/16), \$65,000 (2016/17) and \$34,000 (2017/18) respectively. In addition to handling legal assistance cases (including giving legal advice, representing clients in legal proceedings, carrying out mediation and providing other assistance), PCPD's in-house lawyers also perform the following major duties:

- (a) Handle cases of administrative appeal, judicial review and legal proceedings involving the PCPD, and follow up on cases involving offences (e.g. direct marketing) under the Personal Data (Privacy) Ordinance (the Ordinance) and refer them to the Police for criminal prosecution;
- (b) Conduct review on the Ordinance and comparative study with regard to social needs and international development of privacy law;
- (c) provide legal support to various departments of PCPD, including: advise on legal issues arising from complaints, enquires, compliance checks and investigation cases, as well as applications for automated matching processes; review investigation reports, enforcement notices and inspection reports as required; advise on projects or programmes involving major privacy risks; review press releases and replies to the media or Legislative Council; attend seminars, talks and meetings, etc., organised or participated by the PCPD as speakers to brief organisations and the public on the application of the Ordinance; draft or advise on PCPD's codes of practice and information leaflets; advise on PCPD's employment or other legal issues; and review legal documents and contracts involving the PCPD (such as tenancy agreements, service contracts and tender documents, etc.); and
- (d) provide advice in relation to personal data privacy to government departments and policy bureaux on legislative proposals, bills, administrative measures and public consultation.

# Reply:

Under section 6 of the Electoral Affairs Commission (Nominations Advisory Committees (Legislative Council)) Regulation (Cap. 541C) (the Regulation), a Returning Officer may seek the advice of the Nominations Advisory Committee (NAC) as to whether a particular candidate who has submitted a nomination form is eligible to be, or disqualified from being, nominated as a candidate. However, section 1(2)(a) of the Regulation also stipulates that the Regulation does not empower or require the NAC to advise Returning Officers on any matter relating to the requirements under section 40 of the Legislative Council Ordinance (Cap. 542).

2. In accordance with the Electoral Affairs Commission (Nominations Advisory Committees (Legislative Council)) Regulation, each NAC consists of one member. The NAC generally accepts applications and renders its advice in written form.

As stipulated in section 1(2)(a) of the Electoral Affairs Commission (Nominations Advisory Committees (Legislative Council)) Regulation (Cap. 541C) and section 1(2) of the Electoral Affairs Commission (Nominations Advisory Committees (District Councils)) Regulation (Cap. 541E), these Regulations do not empower or require the Nominations Advisory Committee to advise Returning Officers on any matter relating to the requirements under section 40 of the Legislative Council Ordinance (Cap. 542) and section 34 of the District Councils Ordinance (Cap. 547) respectively.
