Question:

Please provide the turnover rate of persons with disabilities placed under the Work Orientation and Placement Scheme (WOPS) after the completion of the allowance period.

Asked by: Hon CHEUNG Chiu-hung, Fernando (Member Question No.)

Reply:

The Labour Department (LD) has since 2015 lengthened its follow-up of the employment status of employees with disabilities placed under WOPS up to the twelfth month of their employment. In 2015 and 2016, LD recorded 811 and 816 placements under WOPS respectively. In these two years, the monthly turnover rates (i.e. the percentage of cases with employment contracts terminated out of the number of placements recorded in the respective year) of employees with disabilities after the completion of the eight-month allowance period under WOPS decreased from 4% at the ninth month of employment to 2% (2015) and 1% (2016) at the twelfth month of employment. Most of these cases involved the resignation of employees with disabilities. Dismissal by employers only accounted for a minority of the cases.

- (b) a detailed account of the number of officers involved and the start and end dates for each of the 2 temporary redeployments of the Occupational Safety Officer Grade staff of LD in 2017?

Reply:

(a) The number of inspections conducted by various divisional offices of OD under OSHB of LD in the past 3 years is provided in the table below:

The establishment of the above offices/teams of OD consists of Divisional Occupational Safety Officers, Occupational Safety Officers I and Occupational Safety Officers II. All of them were involved in conducting inspections. LD does not keep a breakdown of the inspections by rank.

(b) In the wake of a fatal industrial accident that happened at the Hong Kong-Zhuhai-Macao Bridge site on 29 March 2017, OD of LD internally redeployed 6 Occupational Safety Officers dedicated to assisting in the investigation and follow-up action of the accident on 30 March 2017. The redeployment arrangement ended on 28 September 2017 upon completion of the investigation and related work.

Moreover, in view of the spate of serious fatal industrial accidents in the construction industry in 2017 and the community's concern about construction safety, OD internally redeployed 19 frontline Occupational Safety Officers on 1 June 2017 to enhance the inspection and enforcement work targeting construction sites. The redeployment arrangement lasted until 31 March 2018.

Question:

Subsequent to Question Serial No. 0510 and Reply Serial No. LWB(L)062 about occupational injuries involving traffic accidents, would the Government provide:

- (a) the number of occupational fatalities involving traffic accidents in each year from 2013 to 2017, with a breakdown by type of vehicles;
- (b) the major causes of the above occupational fatalities?

Asked by: Hon POON Siu-ping (Member Question No.)

Reply:

- (a) The Labour Department (LD) does not keep a breakdown by type of vehicles.
- (b) There were 89 occupational fatalities involving local traffic accidents from 2013 to 2017, in which 35 deceased persons were drivers of the vehicles concerned, 5 were passengers and 33 were pedestrians at the time of the accidents. According to the information available to LD, the 73 cases were similar in nature to the causes of ordinary traffic accidents and were classified as traffic accidents and investigated by the Police.

For the remaining 16 cases, the deceased were all engaged in road/roadside work at the time of the accidents, with 6 of them carrying out road or roadside maintenance works. The causes of the accidents involved duty holders' failure to fully comply with the requirements set out in the relevant code of practice prescribed by the Highways Department, to formulate and implement an effective safe system of work and to take adequate safety measures, including improper work arrangements and inadequate supervision, poor traffic arrangements, etc. The remaining 10 cases involved workers such as security guards or cleansing workers working on roads with vehicular traffic. According to the information available to LD, these accidents were generally similar

in nature to traffic accidents involving pedestrians. The accidents were investigated and followed up by the Police as traffic accidents.

Reply:

In 2018-19, the Employment Agencies Administration (EAA) of the Labour Department has a staff establishment of 22 Labour Officer Grade and 8 Clerical Grade posts responsible for performing licensing duties, conducting inspections to EAs and investigating complaints, as well as other related publicity and educational work, etc. To conduct inspections of EAs providing placement service for FDHs is an integral part of EAA's work in the regulation of EAs, and the manpower involved cannot be separately identified.
