#### Question:

According to the Programme, the Commission will provide timely advice and assistance to the Urban Renewal Authority to build in corruption prevention safeguards in the implementation of Operation Building Bright (OBB) 2.0. In this connection, please provide in table form the number of complaints received by the ICAC concerning bid-rigging in OBB, the number of case files opened and the number of substantiated complaints involved in the past 3 years; the estimated manpower and expenditure involved in preventing bid-rigging in OBB, and the amount of resources to be spent by the Commission on publicity and education in disseminating anti-bid-rigging messages for the coming year.

<u>Asked by</u>: Hon CHAN Chi-chuen (Member Question No. (LegCo use): 53) <u>Reply</u>:

The Independent Commission Against Corruption (ICAC) has always strived to combat corruption in building management and maintenance (including corrupt bid-rigging activities), which affects people's livelihood and is an issue of public concern. The Operations Department of the ICAC has an established investigation group dedicated to the investigation of corruption cases in this regard. The group currently comprises 43 In addition, the Operations Department has further set up a task force officers. comprising 9 officers since April 2015 through redeployment of its resources and manpower to handle corruption complaints which involve bid-rigging. As Operation Building Bright (OBB) 2.0 is to be launched in mid-2018, the ICAC will heighten The dedicated vigilance and flexibly deploy resources to address the challenges. investigation group will adopt a "double barrel" strategy. On the one hand, pursuable complaints will be investigated, and prosecutions would be made if the complaints are found substantiated. On the other hand, apart from gathering evidence, the ICAC would also take timely intervention action, where appropriate, to frustrate possible corrupt bid-rigging activities at an early stage and alert owners of the potential risk of corruption in the granting of works contracts, so that owners can consider taking suitable preventive measures against bid-rigging, such as replacing the renovation contractor or consultant, or even re-organising the owners' corporation (OC) when necessary.

- Moreover, the ICAC has established an internal task force comprising officers from the Operations Department, Corruption Prevention Department and Community Relations Department to regularly conduct analyses and reviews on corruption in the building management industry, and to formulate a holistic strategy to combat corruption related to building management and maintenance. Externally, the ICAC works closely with relevant concern groups and government departments/bodies, including the Urban Renewal Authority (URA), Hong Kong Police Force, Home Affairs Department, Buildings Department and Competition Commission which has a specific mandate in fighting bid-rigging activities. As always, the ICAC will spare no effort in implementing the three-pronged approach with a view to eradicating corruption in the building management and maintenance industry through law enforcement, corruption prevention and community education.

- Apart from launching the Building Maintenance Toolkit and training videos, the ICAC will produce new promotional leaflets and launch thematic webpages on the Integrity and Quality Building Management Website to let owners, OCs and property management companies understand the corruption risks in building management and maintenance (including tendering of works contracts, supervision of works and payment procedures) and the relevant integrity management measures. The Toolkit has been uploaded to the ICAC Website for easy reference by the public. Moreover, the ICAC has also set up an enquiry hotline to handle public enquiries on corruption prevention matters with regard to building management and maintenance.
- Besides working closely with the relevant government departments, public bodies, building management professional bodies, district organisations and offices of members of the district councils to provide participating OCs and owners with tailor-made corruption prevention advice and preventive education services, the ICAC will also promote corruption prevention knowledge to owners of old buildings (including buildings without OCs) and equip them with the skills in managing the relevant corruption risks. They can also enquire and obtain information about clean building management through the ICAC Regional Offices, the enquiry hotline and the thematic website.

#### Question:

The estimated expenditure under Programme (1) for 2018-2019 is (\$m)84, representing an increase of 5.1% from the revised estimates for this year.

According to the staffing analysis, 4 posts will be created by the Independent Commission Against Corruption (ICAC). Please list out:

- 1) the posts concerned and their job nature;
- 2) the expenditure details of each of the posts;

3) the ICAC's annual estimates for expenditure on duty visits arising from the increasing number of cases requiring cross-boundary investigation.

Reply:

1. In 2018-19, the 4 posts to be created under Programme (1) consist of 1 post of Senior Commission Against Corruption Officer (SCACO), 1 post of Commission Against Corruption Officer (Upper) (CACO(U)) and 2 posts of Commission Against Corruption Officer (Middle/Lower) (CACO(M/L)). Among them, 3 new posts will be deployed to mainly provide corruption prevention services relating to mega infrastructure projects and controls over major construction materials in public works projects. Such preventive services include conducting assignment studies, reviewing tender documents, giving corruption prevention advice on contract letting and administration, attending tender opening/assessment meetings as observers and providing corruption prevention training to public officers and the relevant practitioners in a supervisory role. The other new post<sup>1</sup> will be deployed to enable the Independent Commission Against Corruption (ICAC) to provide effective training and consultancy services to other jurisdictions to fulfil the ICAC's obligations under the United Nations Convention Against Corruption to help other state parties, including countries along the route of Belt and Road which are expected to expand economic links with Hong Kong, in anti-corruption capacity building.

- 2. The notional annual mid-point salary value of the 4 posts is about \$4.5 million in total.
- 3. As the expenditure on cross-boundary investigation is a regular item which has already been included in the recurrent expenditure, and the actual expenditure will depend on operational needs, the ICAC has not made separate estimates for this end.

Apart from integrity management briefings, are there any other forms of activities? What are the staffing and performance indicators concerned?

- The Independent Commission Against Corruption (ICAC) will provide corruption prevention advice to the URA in respect of OBB 2.0 and the Fire Safety Improvement Works Subsidy Scheme. In collaboration with the URA and related organisations, the ICAC will brief participating owners' corporations (OCs) on corruption risks in building maintenance, consequences of corrupt conduct and measures to step up controls over maintenance projects through briefings or thematic seminars and visits to OCs, etc. Efforts will also be made to remind owners to actively participate in building management for effective monitoring of the building maintenance works.
- Apart from launching the Building Maintenance Toolkit and training videos, the ICAC will produce new promotional leaflets and launch thematic webpages on the Integrity and Quality Building Management Website to let owners, OCs and property management companies understand the corruption risks in building management and maintenance (including tendering of works contracts, supervision of works and payment procedures) and the relevant integrity management measures. - In 2017, the ICAC handled over 870 enquiries while the thematic website on building management and the online Toolkit recorded a hit rate of about 370 000 and 17 500 respectively. Besides, over 5 000 copies of the Toolkit and 17 000 sets of educational videos were distributed to owners, OCs and building management bodies, etc., through different channels.
- In 2018, the ICAC plans to reach 500 OCs or building management-related organisations through visits, talks, seminars and other publicity and education activities and brief 3 000 people on the relevant legislation and corruption prevention measures. It is also expected to reach 7 000 people, including OCs and owners participating in OBB 2.0 and the Fire Safety Improvement Works Subsidy Scheme, through exhibitions, district activities and promotional leaflets, etc.

#### Question:

Under Subhead 000 Operational Expenses, which item covers the expenditure on staff contract gratuities? Is the employer's contributions to the Mandatory Provident Fund Scheme of an employee during his/her contract period first deducted from the contract gratuity to be received by the employee? If so, what are the reasons?

Reply:

- The expenditure on staff contract gratuities is a Centre-funded item of the Government. The payment is released by the Treasury in accordance with the relevant legislations, regulations and rules.
- To cater for the Mandatory Provident Fund (MPF) system when implemented, the Government adjusted the arrangements for provision of contract gratuities in new contracts (for new recruits and serving staff) in December 1998. The adjustment provides that the contract gratuity payable to a contract staff member plus the employer's MPF contributions by the Government shall be the same as the specified rate before the implementation of the MPF system.
- Pursuant to Section 8(4) of the Independent Commission Against Corruption Ordinance, Cap. 204, the Commissioner and officers shall be employed subject to Government regulations and such administrative rules as apply generally to public officers. Thus, the aforesaid arrangements for contract gratuities and employer's MPF contributions also apply to contract staff of the Commission.

• In addition to the above, the CRD also provided enquiry services through its Regional Offices and the Integrity Building Management Enquiry Hotline to answer questions from OCs and owners and to help them reduce corruption risks in building maintenance. Moreover, the CRD set up an Integrity and Quality Building Management Website where information on anti-bribery legislation and preventive education services in relation to daily building management and maintenance is readily

accessible to the public. In 2016 and 2017, the Independent Commission Against Corruption handled over 780 and 870 enquiries respectively while the thematic website on building management recorded 350 000 and 370 000 views respectively. Meanwhile, the CRD has been working closely with the relevant government departments, professional bodies and district organisations to disseminate clean building management messages. The efforts made included inviting building management bodies and members of the district councils to assist in organising activities such as exhibitions, district activities, meet-the-public sessions and distributing promotional leaflets to hammer home clean building management messages.

• As the above preventive education services fall within the regular duties of the CRD and the 7 Regional Offices under its purview, no additional manpower or expenditure is involved.

The Government stated that a multi-faceted education and publicity programme will be launched for the rural elections in the coming year. Please provide details of such work, including the expenditure and manpower involved.

Reply:

Rural elections, including the Rural Representative Elections and the elections of the Executive Committees of Rural Committees as well as members of the Heung Yee Kuk, are governed by the Elections (Corrupt and Illegal Conduct) Ordinance (ECICO). As in the case of other public elections, the Independent Commission Against Corruption (ICAC) will launch a series of publicity and education initiatives for the candidates, election helpers and electors of the above elections to sustain its efforts to uphold clean public elections in Hong Kong. Details of the relevant initiatives are listed below:

- The Community Relations Department (CRD) will arrange briefing for candidates and their electioneering teams as well as attending the Candidates' Briefing organised by the Electoral Affairs Commission to explain the major provisions of the ECICO and highlight the points-to-note at elections;
- A "Clean Rural Elections" Information Booklet will be produced to help candidates, election agents and helpers understand the provisions and application of the ECICO;
- Leaflets on anti-vote-rigging and "Guidelines for Electors" will be produced with key points and Q&As to highlight the legislation requirements that electors should take note of;
- To promote clean election messages with a lively yet realistic approach, the ICAC will produce 3 new educational filmlets for the Rural Representative Election to remind stakeholders of the importance of abiding by the law;
- A Clean Election Enquiry Hotline will be set up to handle public enquiries about the ECICO;

- Clean election messages will be widely disseminated through roving exhibitions and other effective publicity channels; and
- A dedicate website on clean rural elections will be set up to introduce the publicity and education initiatives launched by the ICAC for the above.

The programme will be implemented between May 2018 and May 2019. The expenditure of \$1.9 million will be jointly borne by the ICAC and the Home Affairs Department while CRD will deploy existing manpower to implement the programme.

The estimated non-recurrent expenditure for the coming year is about two times higher than that for last year. What are the reasons? Please provide the details and, if possible, a breakdown in table form.

<u>Asked by</u>: Hon LAM Cheuk-ting (Member Question No. (LegCo use): 26) Reply:

- The estimate is the funding for implementing the preventive education and publicity initiatives by the Community Relations Department (CRD). For 2017-18, the total estimated non-recurrent expenditure for the CRD was \$1.8 million covering the expenses on producing a new publicity package for new arrivals and ethnic minorities (\$800,000) and rolling out a two-year "Youth Integrity Fest" programme (\$1 million for 2017-18 and \$3 million for 2018-19). The "Youth Integrity Fest" programme mainly consists of (i) a series of campus activities for primary, secondary and tertiary students; (ii) multimedia productions (including virtual reality and augmented reality products developed for experience programmes, web videos, four-panel short comics and online games); and (iii) a large-scale youth art fair. The expenditure of \$1 million for the first year of the programme was mainly for organising campus activities and partially covering the cost of the multimedia productions.
- In 2018-19, the CRD will continue to implement the "Youth Integrity Fest" programme for the second year. Apart from organising a large-scale youth art fair, relevant multimedia productions and publicity activities (with an estimated expenditure of \$3 million) will be launched to consolidate and pass on Hong Kong's probity culture and core value of integrity. In addition, the CRD will kick-start a number of new publicity activities including:
  - (1) A new web learning package comprising scenario-based videos will be produced

by making reference to recent cases (such as cases involving the offence of misconduct in public office) to provide civil servants with timely and user-friendly corruption prevention and integrity training in an interactive manner. The estimated expenditure of \$1 million on this item will be separately covered in 2 years (\$300,000 for 2018-19 and \$700,000 for 2019-20).

(2) A multimedia publicity programme will be launched using the outstanding entries of an anti-corruption Announcement in Public Interest (API) project organised for tertiary students in 2017-18 to further promote the core value of integrity to the young generation in an interesting way. The estimated expenditure on this item is \$2 million.

#### Question:

There were views in the community that the personnel appointment issues caused by the incumbent Commissioner when heading the ICAC had led to a major personnel upheaval in the ICAC which seriously damaged its credibility and staff morale. In this connection, did the Commission subsequently adopt any measures to enhance staff morale? If so, what were the measures? If not, what were the reasons?

Reply:

- In 2018-19, the estimated expenditure on salaries and allowances payable to the Commissioner of the ICAC is \$3.54 million.
- In the ICAC, personnel appointments are made according to the Commission's human resources management and operational needs and in strict accordance with the government regulations and guidelines.
- As observed by the management, staff morale in the Commission has been good as reflected from the steady decrease in the unnatural wastage rate of officers in departmental grades from 8.4% in 2007 to 2.6% in 2017. ICAC officers at various levels of all departments continue to display unwavering determination to resolutely carry out their anti-graft duties in a professional manner. The Commission also attaches great importance to staff morale and will continue to maintain effective communication with colleagues of all ranks with a view to understanding their concerns and listening to their views so as to take appropriate follow-up actions.
- The ICAC has a long established credibility with its work continuously supported by

the public and widely recognised by the international community. Since 2010, the Commission has engaged independent research agencies to conduct annual surveys. In the past 5 years, over 95% of the respondents considered the ICAC deserving their support. In the Corruption Perceptions Index 2017 released in late February 2018 by Transparency International, an international organisation committed to countering corruption, Hong Kong was ranked the 13<sup>th</sup> least corrupt place among 180 countries/territories, up two places from its ranking in 2016. Moreover, Hong Kong has been ranked the world's freest economy for 24 consecutive years by the Heritage Foundation in its Index of Economic Freedom released in early February which praised Hong Kong for upholding a clean society and its excellent track record in combating corruption.

At the conclusion of every investigation, the Independent Commission Against Corruption (ICAC) will submit the case to the Operations Review Committee for its scrutiny. In 2017, after the deliberations and on the recommendations of the Committee, the ICAC referred 74 government servants (involved in 40 concluded cases) to the respective bureaux or departments for consideration of disciplinary and/or administrative action. Despite the increase as compared to 55 government servants in 32 cases in 2016, no additional resources are required from the ICAC because the follow-up work is to be taken up by the respective bureaux or departments.

Under Programme (4), the Community Relations Department (CRD) will assist in the ICAC's efforts to provide training and advisory services to other jurisdictions to fulfil the ICAC's obligation under the United Nations Convention Against Corruption to help other state parties, including countries along the route of Belt and Road which are expected to expand economic links with Hong Kong, in anti-corruption capacity building. 1) Fluctuations have been observed in Hong Kong's rankings in some international anti-corruption surveys. Though Hong Kong was ranked the 13<sup>th</sup> least corrupt place in the Transparency International's Corruption Perceptions Index 2017, its ranking once dropped to a record low of the 18<sup>th</sup> in 2015. Has the Government put in place any specific measures to enhance the international community's positive perception of the anti-corruption work in Hong Kong? If so, what are the details; if not, what are the reasons?

2) The Government intends to share Hong Kong's wide experience in fighting corruption with countries along the route of Belt and Road. What are the details of the future work plan? What are the manpower and expenditure involved?

Reply:

1.

• Over the years, Hong Kong has been rated as one of the cleanest places in a number of international anti-corruption surveys, including the Transparency International's Corruption Perceptions Index (CPI) which consistently ranked Hong Kong one of the top 20 least corrupt places among over 100 countries/territories. In the CPI 2017 released in February this year, Hong Kong was ranked the 13<sup>th</sup> among 180 countries/territories, up 2 and 5 places as compared with that of 2016 and 2015 respectively.

- Since most of the international surveys concerned are based on perception rather than actual experience of the respondents, several high-profile Independent Commission Against Corruption (ICAC) cases in recent years might have affected some respondents' perception on the probity situation of Hong Kong. In addition, other factors such as changes to the survey methodologies and changes in the rankings of other countries/territories may also affect the scores and ranking of a place. According to the annual opinion surveys conducted by the ICAC over the years, corruption remains uncommon in Hong Kong with only a tiny proportion of respondents having come across corruption personally. To maintain Hong Kong's international reputation as a corruption-free city, the ICAC will continue to promote the probity situation of Hong Kong to the international community through different platforms.
- First of all, the ICAC will continue to brief visitors from overseas government and business organisations, law enforcement agencies and international institutions on Hong Kong's effective anti-corruption institution and efforts in integrity building. Besides, the Commission will organise international conferences and thematic seminars regularly to share Hong Kong's experience in combating corruption with the international community.
- The Commission will continue to invite senior executives of major international ranking agencies to visit Hong Kong. Through meetings with the senior officials of the ICAC as well as various government departments and organisations, they can gain first-hand understanding of the overall development and the actual probity situation of Hong Kong.
- Since the United Nations Convention Against Corruption (UNCAC) came into force for China in February 2006 and in parallel became applicable to Hong Kong, the ICAC has been designated by the Central People's Government as the authority to assist other State Parties in developing and implementing corruption prevention measures pursuant to the UNCAC. The ICAC will make continued efforts to assist the anti-corruption agencies (ACAs) of those countries/territories agreeable to the arrangements.
- In recent years, the Commission has also stepped up international publicity efforts by making effective use of online platforms. For example, through the one-stop platform "International Perspective" launched at ICAC's corporate website, overseas stakeholders can have access to and gain knowledge of Hong Kong's latest efforts in integrity building.
- The ICAC will continue to keep a close eye on anti-corruption related international rankings with a view to formulating international publicity and promotion strategies accordingly.
- 2. The ICAC is having close contact with the ACAs of Timor-Leste, Bangladesh and Sri Lanka and will provide officers of those ACAs with bespoke training in 2018. In view of the close business and trade relations between Hong Kong and ASEAN countries, the ICAC is also reaching out to the ACAs of those countries and will accord priority training support to them.

In 2018-19, the ICAC was allocated resources to create 3 posts of in the ranks of Commission Against Corruption Officer (Upper), Commission Against Corruption Officer (Middle/Lower) and Assistant Commission Against Corruption Officer respectively to implement the above-mentioned work. The total notional annual mid-point salary value of the 3 posts is about \$2.47 million. Other expenses including those incurred by officers for their visits to the ACAs of various countries and those for organising training programmes in 2018-19 are about \$600,000.

Reply:

- The Independent Commission Against Corruption (ICAC) will provide corruption prevention advice to the URA in respect of OBB 2.0 and the Fire Safety Improvement Works Subsidy Scheme. In collaboration with the URA and related organisations, the ICAC will brief participating OCs on corruption risks in building maintenance, consequences of corrupt conduct and measures to step up controls over maintenance projects through briefings or thematic seminars and visits to OCs, etc. Efforts will also be made to remind owners to actively participate in building management for effective monitoring of the building maintenance works.
- Apart from launching the Building Maintenance Toolkit and training videos, the ICAC

will produce new promotional leaflets and launch thematic webpages on the Integrity and Quality Building Management Website to let owners, OCs and property management companies understand the corruption risks in building management and maintenance (including tendering of works contracts, supervision of works and payment procedures) and the relevant integrity management measures. The Toolkit has been uploaded to the ICAC Website for easy reference by the public. Moreover, the ICAC has also set up an enquiry hotline to handle public enquiries on corruption prevention matters with regard to building management and maintenance.

- The target of OBB 2.0 is buildings with OCs. The ICAC will work closely with the relevant government departments, public bodies, building management professional bodies, district organisations and offices of members of the district councils to provide participating OCs and owners with tailor-made corruption prevention advice and preventive education services.
- Furthermore, upon request the ICAC will offer free, confidential and tailor-made corruption prevention advisory service to buildings with or without OCs. The ICAC will also work closely with the relevant government departments to promote corruption prevention knowledge to owners of old buildings (including buildings without OCs) and equip them with the skills in managing the relevant corruption risks. They can also enquire and obtain information about clean building management through the ICAC Regional Offices, the enquiry hotline and the thematic website.
- As corruption preventive education work relating to building management and maintenance is part of the ICAC's regular duties, the resources involved are included in the general operating expenses and no itemised budget is made.

Since the Hong Kong Section of the HZMB project has adopted the standard government public works procedures, it is already covered by the above corruption prevention work. The CPD also regularly meets with the senior management of the relevant bureaux and departments to discuss corruption prevention work plans, taking into account the latest corruption risks. As these are CPD's regular duties, no separate budget is made for individual infrastructure projects.

The Independent Commission Against Commission (ICAC) has always strived to combat corruption in building management and maintenance (including corrupt bid-rigging activities<sup>1</sup>), which affects people's livelihood and is an issue of public concern. The

In addition, the Operations Department has further set up a task force comprising 9 officers since April 2015 through redeployment of its resources and manpower to handle corruption complaints which involve bid-rigging.

The corruption complaints involving building maintenance in the three administrative districts of Kowloon West (Sham Shui Po, Yau Tsim Mong and Kowloon City) received by the ICAC in the past three years are listed in the annex. The ICAC does not maintain statistics on the time and costs incurred in handling each investigation, and therefore cannot provide the information requested.
