**Signature Project Scheme (Kwun Tong District) -
Construction of Music Fountains at Kwun Tong Promenade**

The Hon AU Nok-hin wrote to the Under Secretary for Home Affairs and District Officer (Kwun Tong) on 6 June 2018 to enquire about the “Construction of Music Fountains at Kwun Tong Promenade”. We replied on 11 June 2018 and undertook to provide in due course supplementary information on statistics on water decorations of Government departments. The supplementary information is set out in ensuing paragraphs.

2. Water decorations of the Government are under the purview of the Leisure and Cultural Services Department (LCSD) and the Housing Department (HD). According to their records, the number and current status of the water decorations for the past three years, i.e. between August 2015 and July 2018, are as follows:
