### **Purpose**

3. The House Committee formed four subcommittees to study items (1) to (6), items (7) to (9), item (10), as well as items (11) to (14) respectively in detail at its meeting on 25 May 2018. The first, second and fourth Subcommittees reported its deliberations at the House Committee meeting on 29 June 2018 vide LC Paper Nos. CB(4)1304/17-18, CB(1)1185/17-18 and CB(4)1305/17-18 respectively. The third Subcommittee made a verbal report at the House Committee meeting on the same date, and provided Members with a written report vide LC Paper No. CB(1)1213/17-18 on 4 July 2018.

4. In respect of items (15) and (16), the House Committee considered it not necessary to form any subcommittee to study these two items of subsidiary legislation.

*Note: (a) The House Committee formed a subcommittee to study the Food Adulteration (Metallic Contamination) (Amendment) Regulation 2018 (L.N. 113/2018) at its meeting on 15 June 2018. The President has given permission for Dr Hon Helena WONG, Deputy Chairman of the Subcommittee, to move a proposed resolution at the Council meeting of 4 July 2018 to extend the period for amending this item of subsidiary legislation to the first Council meeting of the next session.*

- (b) *The House Committee formed a subcommittee to study the Employment (Amendment) (No. 2) Ordinance 2018 (Commencement) Notice (L.N. 116/2018). Hon WONG Ting-kwong, Chairman of the Subcommittee, will give notice to move a proposed resolution at the Council meeting of 11 July 2018 to extend the period for amending this item of subsidiary legislation to the first Council meeting of the next session.*
