I. Election of Chairman

Mr James TO, the member who had the highest precedence among members present at the meeting, presided over the election of the Chairman. He invited nominations for the chairmanship of the Subcommittee.

- 2. <u>Mr SHIU Ka-fai</u> nominated Dr Priscilla LEUNG and the nomination was seconded by <u>Mr Jeffrey LAM</u>. <u>Dr Priscilla LEUNG</u> accepted the nomination. There being no other nominations, <u>Dr Priscilla LEUNG</u> was elected Chairman of the Subcommittee.
- 3. <u>Members</u> agreed that there was no need to elect a Deputy Chairman.

II. Meeting with the Administration

[LC Paper Nos. CB(4)982/17-18(01) and AW-275-010-005-004-P001]

4. <u>The Subcommittee</u> deliberated (index of proceedings attached at **Annex**).

(At 11:00 am, the Chairman ordered that the meeting be extended for 15 minutes to 11:15 am.)

<u>Submissions from deputations/members of the public and the suggestion of holding a public hearing</u>

5. <u>Members</u> noted that the Subcommittee had received 23 submissions from deputations/members of the public expressing views on the proposed appointments of two non-permanent judges from other common law jurisdictions ("CLNPJs"). The 23 submissions received were tabled at the meeting. The deputations/members of the public were generally concerned about the two judges' strong stand in supporting the rights of lesbian, gay, bisexual, and transgender ("LGBT") as well as same-sex marriage. Some of the deputations/members of the public had requested the Subcommittee to hold a public hearing to gauge public views on the proposed appointments of the two CLNPJs.

(*Post-meeting note*: The Subcommittee received a total of 60 submissions on the proposed appointments of the two CLNPJs. The submissions were issued to members vide LC

Paper Nos. CB(4)997/17-18 and CB(4)1028/17-18 on 30 April and 4 May 2018 respectively.)

- 6. <u>Members</u> expressed diverse views and had a lively debate on the suggestion of holding a public hearing to collect public views on the proposed appointments of the two CLNPJs. <u>The Subcommittee</u> also noted that the Administration and the Judiciary had raised objection to the holding of a public hearing, which, in their views, would run a high risk of politicizing the judicial appointment process and undermining judicial independence or the perception of it.
- 7. <u>The Chairman</u> put the proposal of holding a public hearing to vote, and the proposal was not supported by the majority of the members present. Accordingly, the Subcommittee decided not to hold a public hearing on the matter. <u>The Chairman</u> requested the Judiciary and the Administration to provide a written response to the concerns raised in the submissions.

(*Post-meeting note*: The Administration's written response to the concerns raised in the submissions was circulated to members vide LC Paper No. CB(4)1028/17-18 on 4 May 2018.)

Proposed senior judicial appointments

- 8. Noting from the submissions that there was wide public concern that the strong stand of the two judges in supporting LGBT's rights and same-sex marriages might affect their judgment on such cases and create apparent bias, members sought information on the existing mechanism in handling bias in judicial proceedings. Mr SHIU Ka-fai, Mr Holden CHOW and Ms Starry LEE particularly enquired whether the two judges would sit in the Court of Final Appeal ("CFA") if the appeal matters involved LGBT's rights or same-sex marriages.
- 9. <u>Secretary, Judicial Officers Recommendation Commission</u> ("SJORC") advised that, as stipulated in paragraphs 38 to 70 of the Guide to Judicial Conduct, there were established common law principles and practices in dealing with actual, presumed or apparent bias in judicial proceedings. CLNPJs were usually invited to sit as the fifth judge in CFA for hearing appeals. In selecting and inviting a CLNPJ to sit, the Chief Justice and CFA would take all relevant circumstances into account, including the availability of the judges, their particular expertise in certain areas of law and the nature of the cases to be heard, etc. CLNPJs, when sitting in CFA, were functioning as Hong Kong judges and were dealing with cases according to Hong Kong law.

- 10. Mr Paul TSE and Mr CHEUNG Kwok-kwan asked if the Judicial Officers Recommendation Commission ("JORC") would take into consideration the candidates' social values and background when formulating recommendations to the Chief Executive on appointment of CLNPJs. Mr CHAN Chi-chuen, Mr Jeremy TAM, Mr James TO, Mr AU Nok-hin, Dr Fernando CHEUNG and Mr Alvin YEUNG shared similar views that they did not consider it appropriate to take those factors into account when considering judicial appointments as it might politicize the process of judicial appointments.
- 11. <u>SJORC</u> stressed that JORC made recommendations on appointment of judges of CFA in strict accordance with Article 92 of the Basic Law and the professional qualifications stipulated in the Hong Kong Court of Final Appeal Ordinance (Cap. 484). In recommending the proposed appointments of the two CLNPJs, JORC considered that they fulfilled the requirements in terms of judicial and professional qualities. Other considerations, including backgrounds or personal views on political, social or economic issues, should not be taken into account because it might run a high risk of politicizing the process of judicial appointments.
- 12. <u>The Subcommittee</u> voted without a division and agreed to support the proposed senior judicial appointments. <u>The Subcommittee</u> completed its deliberations.

Endorsement of the Legislative Council

13. <u>Members</u> noted the Administration's intention to move a resolution to seek the Council's endorsement of the proposed appointments at the Council meeting of 30 May 2018.

(*Post-meeting note*: Members were informed that the Chairman would report the deliberations of the Subcommittee to the House Committee on 11 May 2018 vide LC Paper No. CB(4)1028/17-18 on 4 May 2018.)

III. Any other business

14. There being no other business, the meeting ended at 11:08 am.
