Action

I. Election of Chairman

Mr Paul TSE, the member who had the highest precedence among those present at the meeting, presided over the election of the Chairman of the Subcommittee. He invited nominations for the chairmanship of the Subcommittee.

2. <u>Mr Kenneth LEUNG</u> nominated Mr Dennis KWOK, and the nomination was seconded by Mr Alvin YEUNG. <u>Mr Dennis KWOK</u> accepted the nomination. There being no other nominations, <u>Mr Dennis KWOK</u> was declared the Chairman of the Subcommittee.

II. Meeting with The Law Society of Hong Kong

- 3. <u>Mr Paul TSE</u> and <u>Mr Kenneth LEUNG</u> declared that they were members of The Law Society of Hong Kong ("Law Society").
- 4. <u>Law Society</u> briefed members on the Practising Certificate (Solicitors) (Amendment) Rules 2018 ("the Amendment Rules").
- 5. <u>The Subcommittee</u> deliberated (index of proceedings in **Annex**).

Follow-up actions to be taken by The Law Society of Hong Kong

6. <u>Law Society</u> was requested to provide supplementary information on the followings:

- (a) In relation to the comments made by the Standing Committee on Legal Education and Training ("SCLET") on the Law Society's consultation exercise on the Common Entrance Examination ("CEE") undertaken by a research team appointed by the Law Society comprising academics from Nottingham Law School (UK), the Australian National University and the Institute of Advanced Legal Studies (University of London, UK) ("the CEE Consultation")¹:
 - (i) the cost incurred for the CEE Consultation;
 - (ii) the reasons for not releasing the findings of the CEE Consultation to the public, relevant stakeholders and, in particular, members of the Law Society whose fees for the practising certificates had been used for funding the CEE Consultation;
 - (iii) the reasons for declining SCLET's request for sharing the findings of the CEE Consultation with them;
 - (iv) whether and when the Law Society had consulted its members on CEE, and the factors for deciding whether to consult members; and
 - (v) the projected administrative costs for conducting CEE, in view of its possible impact on the financial vigor of the Law Society and hence the fees for practising certificates to be collected.
- (b) In respect of the Law Society's plan to establish the Law Society Examination ("LSE")²,
 - (i) whether the decision to establish LSE had been made;

- (v) estimated passing rates of candidates who sat for LSE;
- (vi) whether and when a consultation exercise on LSE would be conducted; and
- (vii) the projected administrative costs for conducting LSE, in view of its possible impact on the financial vigor of the Law Society and hence the fees for practising certificates to be collected.
- (c) Information on the projection of the demand of solicitors in Hong Kong in the future, and the details of such projection (if any).

(*Post-meeting note*: The response from the Law Society on the above request (LC Paper No. CB(4)1190/17-18(02)) was circulated to members via LC Paper No. CB(4)1190/17-18 on 4 June 2018.)
