<u>Action</u>

I. Examination of the Practising Certificate (Solicitors) (Amendment) Rules 2018

[LC Paper Nos. CB(4)1206/17-18(01) and (02), CB(4)1190/17-18(01) and (02), L.N. 82 of 2018, Legislative Council Brief, LC Paper Nos. LS58/17-18 and CB(4)1153/17-18(01)]

<u>The Chairman</u> referred to Mr Jimmy NG's letter dated 5 June 2018 and invited members' views on the late application for membership by Mr NG. <u>Members</u> agreed to accept Mr NG's late application for membership.

- 2. <u>Members</u> noted that The Law Society of Hong Kong ("Law Society") had responded to the Subcommittee's request for supplementary information raised at the last meeting. In its replies (LC Paper Nos. CB(4)1190/17-18(02) and CB(4)1206/17-18(02)), the Law Society indicated that since the major concern of members was on the Common Entrance Examination and Law Society Examination which were not relevant to the Practising Certificate (Solicitors) (Amendment) Rules 2018 ("Amendment Rules") under examination, it would not send representations to attend the present meeting.
- 3. <u>Mr Kenneth LEUNG</u>, <u>Mr Jimmy NG</u> and <u>Dr Junius HO</u> declared that they were members of the Law Society.
- 4. The Subcommittee deliberated (index of proceedings in **Annex**).

Follow-up actions to be taken by The Law Society of Hong Kong

Law Society 5. The Chairman directed the Clerk to write to the Law Society requesting it to provide supplementary information on the cost incurred by it in conducting the consultation exercise on the Common Entrance Examination undertaken by a research team appointed by the Law Society comprising academics from Nottingham Law School (UK), the Australian National University and the Institute of Advanced Legal Studies (University of London, UK). He said that the above information was first requested by the Subcommittee at its meeting on 29 May 2018, on the ground that the consultation exercise should have been funded from the practising certificate fees received by the Law Society so that it was relevant to the subsidiary legislation under examination.

(*Post-meeting note*: The letter from the Clerk was issued to the Law Society on 6 June 2018.)

The way forward

6. <u>Members</u> noted that the Chairman would move a motion at the Council meeting of 6 or 13 June 2018 to extend the scrutiny period of the Amendment Rules.

(*Post-meeting note*: When the Council meeting of 6 June 2018 was adjourned, the agenda on the proposed resolution to extend the scrutiny period for the Amendment Rules to the Council meeting of 4 July 2018 was not reached and was carried forward to the Council meeting of 13 June 2018. However, when the Council meeting of 13 June 2018 was adjourned, the agenda on the above proposed resolution was still not reached and the scrutiny period for the Amendment Rules expired at that Council meeting.)

7. <u>Members</u> agreed that subject to the Law Society's response to the above requested information and if no members raised any queries about the Law Society's response, the Subcommittee would deem to have completed scrutiny of the Amendment Rules and no further meeting would be held.

(*Post-meeting note*: The response from the Law Society (LC Paper No. CB(4)1229/17-18(02)) was issued to members via LC Paper No. CB(4)1229/17-18 on 12 June 2018. No comments from members were received on the above response by the deadline on 14 June 2018. Members were informed via LC Paper No. CB(4)1269/17-18 on 19 June 2018 that the Chairman would report the deliberations of the Subcommittee to the House Committee on 22 June 2018.)
