#### I Election of Chairman

Mr LEUNG Yiu-chung, the member who had the highest precedence among those present at the meeting, presided over the election of Chairman of the Subcommittee. He invited nominations for the chairmanship of the Subcommittee.

2. At that juncture, only the presiding member, Mr LEUNG Yiu-chung, and two other members, Mr WONG Ting-kwong and Mr POON Siu-ping, were present. The presiding member and the other two members present did not accept the nominations for the chairmanship. The presiding member then ordered that the meeting be temporarily suspended for 10 minutes until more members were present in order to continue with the election of Chairman of the Subcommittee. The election then resumed upon resumption of the meeting.

3. Mr HO Kai-ming was nominated by Mr LEUNG Yiu-chung and the nomination was seconded by Mr Fernando CHEUNG. Mr HO accepted the nomination. There being no other nomination, Mr HO Kai-ming was declared the Chairman of the Subcommittee. Mr HO then took over the chair. Members agreed that there was no need to elect a Deputy Chairman.

- 4. <u>The Administration</u> briefed members on the proposed resolutions under the Construction Industry Council Ordinance (Cap. 587) ("CICO") and the Pneumoconiosis and Mesothelioma (Compensation) Ordinance (Cap. 360) ("PMCO") ("the proposed resolutions").
- 5. <u>The Subcommittee</u> deliberated (index of proceedings attached at **Appendix**).

#### Follow-up actions

- 6. According to the Administration, a study was currently underway to review the feasibility of expanding the list of medical appliances specified in Part II of the Second Schedule to PMCO ("listed medical appliances") in respect of which reasonable expenses should be payable to eligible patients suffering from pneumoconiosis or mesothelioma (or both). The study was expected to be completed in 2018. On this, the Administration was requested to provide the following information:
  - (a) the kinds of medical appliances covered in the above study and the study progress;
  - (b) the timetable for respectively consulting the Pneumoconiosis Compensation Fund Board and the Labour Advisory Board on the recommendations of the above study, and for introducing relevant legislative amendments to the Legislative Council; and
  - administrative (c) whether any interim measures could be implemented to assist patients suffering from those pneumoconiosis or mesothelioma (or both) and needing to use non-listed medical appliances, such as breathing machines.

(*Post-meeting note*: The Administration's supplementary information was circulated to members vide LC Paper No. CB(1)1109/17-18(02) on 11 June 2018.)

7. Given the ambit of the proposed resolutions under scrutiny by the Subcommittee, the Chairman and members generally considered that the wider policy issues relating to the review of the statutory compensation under

PMCO largely fell outside the purview of the Subcommittee. The Subcommittee agreed that the relevant issues would be referred to the Panel on Manpower for following up where appropriate, including deciding whether and when a public hearing should be arranged to receive views from stakeholders, in particular the patients concerned, their families and relevant patient groups.

(*Post-meeting note*: The Clerk to Subcommittee referred the views of the Subcommittee on the wider policy issues relating to the review of the statutory compensation under PMCO to the Clerk to Panel on Manpower on 28 June 2018.)

#### Legislative timetable

8. The Chairman concluded that the Subcommittee had completed the scrutiny of the proposed resolutions. The Administration advised that in addition to the proposed resolutions under CICO and PMCO, the legislative exercise also involved the amendment of levy threshold under the Construction Workers Registration Ordinance (Cap. 583) ("CWRO"), which would be introduced into the Legislative Council for negative vetting after the passage of the proposed resolutions under CICO and PMCO. To avoid confusion to contractors paying the levies, the effective dates of the new levy thresholds under CICO, PMCO and CWRO had to be aligned. The Administration would advise the date of giving fresh notice to move the proposed resolutions later. Subject to the Administration's advice on the legislative timetable, members would be informed of the deadline for giving notice to amend the proposed resolutions in due course.

(*Post-meeting note*: Members were informed vide LC Paper No. CB(1)1092/17-18 on 8 June 2018 that the Administration had advised that it would give fresh notice to move the proposed resolutions at the Council meeting of 27 June 2018, and the Chairman would report the deliberations of the Subcommittee to the House Committee at its meeting on 15 June 2018. The deadline for Members to give notice to amend the proposed resolutions was 20 June 2018. No members raised objection to the above arrangement.)
