Members noted that section 34 of the Interpretation and General Clauses Ordinance (Cap. 1) does not apply to the Tai Lam Tunnel and Yuen Long Approach Road Ordinance (Amendment of Schedule 1) Notice 2018 (L.N. 145) and Western Harbour Crossing Ordinance (Amendment of Schedule 1) Notice 2018 (L.N. 146).
