## I. Election of Chairman and Deputy Chairman

#### **Election of Chairman**

# List of follow-up actions arising from the discussion at the meeting on 23 February 2018

The Administration was requested to provide supplementary information in greater details to address the following issues of concern raised by members:

- (a) the progress of development of the Hong Kong Children's Hospital ("HKCH") in respect of hardware and software development, particularly since 15 June 2015 when the Administration last updated the Panel on Health Services;
- (b) the governance structure for HKCH and the establishment, composition and membership size of its Hospital Governing Committee;
- (c) the scope of medical services to be provided by and the service capacity of HKCH upon commencement of operation in the fourth quarter of 2018 and how such services would benefit the public at large; whether and what other paediatric services were planned to be provided by HKCH at different stages of development and the timetable for provision of such services;
- (d) whether and how HKCH would, at a later stage, provide services and support for (i) patients suffering from rare diseases and their families and (ii) physically/mentally disabled children patients, e.g. provision of dental services and delivery of complex surgical services;
- (e) the cooperation between HKCH and the existing 13 paediatric departments of the regional public hospitals under the Hospital Authority ("HA") in the provision of paediatric services; the details of the hub-and-spoke model (hybrid model) for paediatric services to be implemented by HA upon commissioning of HKCH and the referral mechanism and treatment protocol under such service model;
- (f) (i) the manpower establishment and strength (including doctors, nurses and relevant health professionals) for HKCH, (ii) the ratio between senior and junior medical staff and (iii) the detailed staff deployment arrangements, including the duty shift and on-site call systems to be adopted;

- (g) the progress of staff recruitment and deployment for the commissioning of HKCH, the training plans for its medical staff, and the impact of deploying existing staff to HKCH on the existing and future medical and nursing manpower serving in the paediatric subspecialties in various HA hospitals with the consequential impact on the service quality of various public hospitals;
- (h) the provision of ancillary transport facilities to dovetail with the commissioning of HKCH;
- (i) floor plan/cross-section plan of the HKCH building; and
- (j) a list of medical equipment that HKCH would be provided with upon commissioning of service in the fourth quarter of 2018 and, if available, preferably with photos showing the equipment/facilities to be installed in the hospital.
