- 4. <u>The Chairman</u> concluded that the Subcommittee had completed its scrutiny work. <u>The Subcommittee</u> agreed that the Subcommittee Chairman would move a proposed resolution at the Council meeting of 11 July 2018 to extend the scrutiny period of the Commencement Notice to the first Council meeting of the next session. <u>Members</u> noted that if the scrutiny period was extended, the deadline for giving notice of

amendment, if any, would be five clear days before the first Council meeting of the next session. <u>The Subcommittee</u> further noted that the Chairman would give a verbal report on the deliberations of the Subcommittee at the House Committee meeting on 6 July 2018.

The Administration advised: (i) the Amendment Ordinance would come into operation after expiry of the full negative vetting period of the Commencement Notice, taking into account of the need to allow sufficient time for members to scrutinize the Commencement Notice and their right to propose to extend its scrutiny period by resolution to the first Council meeting in the next session; and (ii) review could be considered where appropriate after the Amendment Ordinance came into operation.

		Mr LUK's enquiry and the Administration's response regarding the publicity work of the Amendment Ordinance. To raise the general awareness of employees' protection, Mr LUK considered that public education of the Amendment Ordinance was necessary. The Administration advised that Mr LUK's view would be considered.

		The Chairman requested the Administration to take note of Mr WAN's view on the inadequacies of the Amendment Ordinance, e.g. employees who were employed under a fixed term contract might not be protected under the Amendment Ordinance. The Chairman considered that such concerns should be discussed by the Panel on Manpower.
