**1. Proposed amendment to the Import and Export (Registration) Regulations (Cap. 60E) for setting a cap on import and export declaration charges**

The 2018-19 Budget announced that the charge for each import and export declaration be capped at \$200. To take forward the measure, the Administration will amend the Import and Export (Registration) Regulations (Cap. 60E). The Administration will brief the Panel on the legislative proposal before introducing the relevant amendments into the Legislative Council.

**2. United Nations Sanctions (Amendment) Bill 2018**

The Administration will brief the Panel on the proposed amendments to the United Nations Sanctions Ordinance for enabling regulations made under the Ordinance to impose sanctions against terrorist groups (including Al-Qaida and the Islamic State of Iraq and the Levant) as decided by the United Nations Security Council.

**3. Progress of the development of Trade Single Window and Launch of Phase 1**

The Administration will brief the Panel on the latest progress of developing a Trade Single Window in Hong Kong following a phased approach, including the plan to launch Phase 1 in mid-2018 and the progress of the associated business process review, and the manpower proposal regarding directorate posts in the Single Window Project Management Office.

**4. Measures to support the Hong Kong Science and Technology Parks Corporation and the establishment of technology research clusters**

The Administration will seek the Panel's support on the proposal to provide resources for the Hong Kong Science and Technology Parks Corporation to construct research-related infrastructure and facilities and strengthen support to its tenants and incubates; as well as the establishment of two research clusters on healthcare technologies and on artificial intelligence and robotics technologies. The proposals will be submitted to the Finance Committee ("FC") for consideration afterwards.

The Administration will seek the Panel's support on the proposal to create a new Assistant Commissioner post in Innovation and Technology Commission to implement the new innovation and technology initiatives. The proposal will be submitted to the Establishment Subcommittee and FC for consideration afterwards.

At the Panel meeting on 21 November 2017, members considered Hon Michael TIEN's suggestion and raised no objection to hold a joint meeting with the Panel on Economic Development ("ED Panel") and Panel on Financial Affairs ("FA Panel") to discuss the relevant issues, taking into account that the discussion of the said item might likely involve various policy matters which would be of concern to members of the other two Panels. At the instruction of the Chairman, Hon Michael TIEN's suggestion had been referred to ED Panel and FA Panel for consideration. While both the Chairmen of ED Panel and FA Panel raised no objection to the proposed joint meeting, Hon Kenneth LEUNG, Chairman of FA Panel further suggested that the proposed joint meeting be held after the proposed joint duty visit of the two Panels to the Guangdong-Hong Kong-Macao Bay Area.

**11. Trade relations between the Mainland and Hong Kong**

A joint meeting of the Panel on Health Services ("HS Panel") and the Panel was held on 23 June 2015 to discuss and receive views from deputations on the item "Regulation and development of beauty services". At the Panel meeting on 21 April 2015, Dr Hon CHIANG Lai-wan requested that this item be retained in the List of outstanding items for discussion of the Panel. At the Panel meeting on 18 October 2016, Dr Hon Helena WONG suggested that the Panel should continue to follow up issues relating to regulation and development of beauty services.

At the Panel meeting on 21 February 2017, members agreed to Hon SHIU Ka-fai's proposal to set up a joint subcommittee under the Panel and HS Panel on issues relating to the regulation of devices and development of the beauty industry. HS Panel also agreed to the above proposal at its meeting held on 28 February 2017. The aforesaid joint subcommittee is currently on the waiting list of subcommittees on policy issues to be activated.

**14. Diversified development of industries in Hong Kong**

At the Panel meeting on 18 October 2016, Dr Hon Helena WONG suggested that the Administration should brief members on the latest development of the Government's initiatives to promote the diversified development of industries in Hong Kong. Members of the Panel on Economic Development should be invited to attend the relevant meeting for discussion.
