#### Legislative Council Panel on Economic Development Meeting on 22 January 2018

At the Legislative Council Panel on Economic Development meeting on 22 January 2018, during discussion of the item on the making and amending of subsidiary legislation under the Merchant Shipping (Safety) Ordinance (Cap. 369) and the Merchant Shipping (Prevention and Control of Pollution) Ordinance (Cap. 413) for implementing the requirements of three international conventions of the International Maritime Organization ("IMO"), Members requested information on the number of ocean-going vessels entering Hong Kong waters based on their places of registry, as well as the details of the control and management of ballast water of ships within Hong Kong waters. The requisite information is set out in the ensuing paragraphs.

### Number of Ocean-going Vessels Entering Hong Kong Waters

The breakdown of ocean-going vessels entering Hong Kong waters in the past three years based on their places of registry is set out at **Annex**.

#### Control and Management of Ballast Water within Hong Kong Waters

The Marine Department ("MD") will conduct random inspections to ensure that ocean-going vessels ("OGVs") have met the standards as set out in the International Convention for the Control and Management of Ships' Ballast Water and Sediments ("the Ballast Water Management Convention") of MD will examine the validity of a ship's certificate, the ballast water management system, as well as the mandatory documents required on board under the Ballast Water Management Convention, including a ballast water management plan and a ballast water record book. In case of doubt, MD can take ballast water samples for testing against the standards stipulated in the Ballast Water Management Convention to confirm whether the discharge procedures have been followed and standards have been met. Under our legislative proposal, MD may prosecute the ship owner and master if the discharge procedures are found to be non-compliant. MD may also inform the Flag Administration of the OGV concerned of any non-compliance identified to deter future occurrences.
