Action

I. Issues relating to the positioning and management of public markets and the Market Modernization Programme

(LC Paper Nos. CB(2)1544/17-18(01) to (02) and CB(2)1760/17-18(01) to (02))

The Subcommittee deliberated (index of proceedings attached at **Annex**).

2. The Subcommittee received oral representations from 37 deputations/individuals attending the meeting. Members also noted that one written submission from an individual not attending the meeting was received by the Subcommittee. The major views expressed by the deputations were summarized as follows:

- (a) in addition to serving as a major source of fresh food provisions for the general public, public markets should offer a variety of foods at cheaper prices so as to relieve the pressure of inflation on the general public and compete with the markets of Link Real Estate Investment Trust ("the Link");
- (b) the Administration should review the current Hong Kong Planning Standards and Guidelines in respect of the standard for the provision of public markets and set a clear planning criteria for public markets, such as provision of public markets based on the number of population in a district;
- (c) the Administration should build new public markets in Tung Chung, Tin Shui Wai and Hung Shui Kiu given their large areas and population, and also in some urban districts such as Tsz Wan Shan with a view to counteracting the Link's monopoly in the operation of markets within the district and providing the local residents with more choices;
- (d) the Administration should adopt a bottom-up approach in gauging public views on the building of new public markets, overhaul of public markets and in-situ redevelopment of public markets, by visiting the markets of individual districts, holding consultation sessions with stakeholders including District Councils, stall tenants and local residents on issues such as the type of improvement works needed for individual public markets and site selection for building new public markets or redeveloping existing ones;

- (e) the Administration should in the long term consider building multi-storey municipal complexes to incorporate public markets and cooked food centres as well as other community facilities such as libraries, sports venues and welfare facilities as the multi-purpose municipal complexes could better meet the daily needs of the local community and utilize land resources;
- (f) provision of air-conditioning ("A/C") systems was considered essential nowadays, and the Administration should bear the A/C charges for common areas in the public markets, as well as the maintenance costs of A/C systems, in order to encourage more stall tenants to support retrofitting A/C systems in their respective public markets. The Administration should expedite the retrofitting works of A/C systems so as to minimize impact on stall tenants and local residents. There was a suggestion that the Administration should provide ex-gratia payments to stall tenants to compensate for their loss of income during the full market closure for retrofitting works of A/C systems, and a waiver of rental should be granted when the markets reopened after completion of works; and
- (g) high occupancy rates in public markets did not necessarily reflect the vibrancy of public markets, as some tenants changed the use of stalls to personal use or storage without authorization. Other factors such as patronage and usage rate of public markets, and the actual number of stalls in operation should also be taken into account.

3. The Administration gave a consolidated response to the views expressed by the deputations/individuals as follows:

- (a) with the \$2 billion earmarked for the Market Modernization Programme ("MMP") and a dedicated team set up, the Food and Environmental Hygiene Department ("FEHD") would examine and address the hardware and software issues of the 99 public markets under its management, in order to meet the needs of the public;
- (b) regarding the provision of new public markets, consideration would be made on a case-by-case basis to ensure that the needs of individual districts were suitably met and a host of factors including the population of individual districts, market facilities

and fresh provision retail outlets available in the vicinity, and district planning would all be considered;

- (c) in building new public markets and identifying public markets for fundamental overhaul and in-situ redevelopment, the Food and Health Bureau and FEHD would coordinate with other relevant bureaux and departments, and optimize the use of land resources in line with the "single site, multiple use" principle. The Administration would also conduct minor improvement works where necessary;
- (d) the Administration would identify suitable public markets to conduct major overhaul, which would set a good example for modernizing other public markets in the future. Aberdeen Market was being considered as a possible candidate in this respect; and
- (e) the Administration stressed that the provision of A/C systems in public markets might not have direct relevance to their vibrancy. For improvement works in public markets, the Administration would consult the stakeholders as appropriate. It would follow up on the remaining 10 markets which had reached the 80% threshold of tenants' support for retrofitting A/C systems under MMP.

Motions moved by members

Motion 1

4. Mr CHAN Han-pan moved the following motion, which was seconded by Mr Steven HO:

鑒於特區政府在 2018-2019 年度《財政預算案》提到預留 20 億元，在未來 10 年推行街市現代化計劃("計劃")，全面檢視現有近百個街市的情況，改善設施，包括加快加裝冷氣、全面翻新或重建，本小組委員會促請政府：

- (1) 加快推行計劃的進度，盡快提出計劃的具體方案，並確保工程在設計、審批撥款、招標及施工等各階段取得合理進展，並定期向公眾交待計劃的進度；

- (2) 盡快檢討《香港規劃標準與準則》內有關公眾街市的規劃準則，以確保社區有足夠的街市檔位；
- (3) 積極就計劃詳情諮詢市民與街市檔戶的意見，確保各持份者的意見能得以充分反映；及
- (4) 就街市冷氣費的訂定上，要求只收取販商租用檔位面積的冷氣費，其餘公用範圍的冷氣費和維修費用則由政府承擔。

(Translation)

That, given \$2 billion will be earmarked for implementing a Market Modernization Programme ("MMP") over the next 10 years, which will entail a comprehensive review of nearly 100 existing markets and improvement works including early installation of air-conditioning ("A/C") systems, major overhaul or redevelopment as mentioned in the 2018-2019 Budget, this Subcommittee urges the Government to:

- (1) expedite the progress of implementing MMP, devise specific proposals for MMP expeditiously, ensure reasonable progress in different stages of the project including design, funding approval, tendering and construction etc., and inform the public on the progress of MMP on a regular basis;
- (2) review the planning standards for public market facilities as set out in the Hong Kong Planning Standards and Guidelines, with a view to ensuring an adequate supply of market stalls for the community;
- (3) consult members of the public and stall tenants on the details of MMP in a proactive manner and ensure that views from all stakeholders will be fully reflected; and
- (4) charge stall tenants A/C charges only for the actual floor area of their stalls, whereas A/C charges attributable to public areas of markets and other maintenance fees should be borne by the Government when determining A/C charges of public markets.

5. The Chairman decided that the motion was directly related to the agenda item, and members agreed to deal with the motion. The Chairman put the motion to vote. All members present voted in favour of the motion. The Chairman declared that the motion was carried.

Motion 2

6. Dr CHIANG Lai-wan moved the following motion:

就有關公眾街市的定位及管理事宜及街市現代化計劃，本小組委員會促請政府：

- (1) 全面檢討街市的使用率、缺乏空調等問題，並盡快提交街市現代化計劃的時間表，及早令各街市租戶及市民受惠；
- (2) 責成有關官員與各街市持份者溝通安裝冷氣事宜，例如為出售肉類的攤檔安裝封閉式冷氣，蔬果乾貨等攤檔則按實際情況而定；
- (3) 研究於街市長期空置的地方設置花圃、健身中心、公營診所等，以地盡其用；及
- (4) 就恢復街市養貓的政策諮詢各街市持份者，以期改善鼠患問題。

(Translation)

That, on issues relating to the positioning and management of public markets and the Market Modernization Programme ("MMP"), this Subcommittee urges the Government to:

- (1) conduct a comprehensive review on issues such as the utilization rate of markets and the lack of air-conditioning ("A/C") systems therein, and expeditiously submit a timetable for implementing MMP, with a view to benefiting the tenants of various markets and the public as early as possible;
- (2) instruct the officials concerned to communicate with the stakeholders of various markets on matters relating to the installation of A/C systems such as the installation of closed A/C systems for meat stalls and depending on the actual circumstances, for stalls selling vegetables, fruits and dried goods;
- (3) conduct a study on setting up planters, gym centres, public clinics, etc. in markets where there are space that has been left

vacant for a long period of time, with a view to fully utilizing land resources; and

- (4) consult the stakeholders of various markets on a policy of re-allowing the keeping of cats in markets, with a view to alleviating rodent problem.

7. The Chairman decided that the motion was directly related to the agenda item, and members agreed to deal with the motion. The Chairman put the motion to vote. All members present voted in favour of the motion. The Chairman declared that the motion was carried.

Follow-up action arising from the discussion

8. Concerning the motion proposed to be moved by Ms Claudia MO about the future development plan of Mong Kok Market which was closed in 2010, the Chairman said that as the proposed motion was not directly related to the agenda item and the matter involved various bureaux and departments, he decided that the proposed motion would not be dealt with. Nonetheless, the Chairman instructed the Clerk to forward Ms MO's proposed motion to the Administration for response.

II. Any other business

9. Mr Andrew WAN suggested that the Subcommittee should consider inviting deputations to give views on building new public markets in Tung Chung, Tin Shui Wai and Hung Shui Kiu, as well as on the subject relating to the standard for the provision of public markets at a future meeting.

10. The Chairman advised that the Clerk would consult the Chairman and liaise with the Administration on the date and items of discussion for the next meeting of the Subcommittee, which would be held after the summer recess. Members noted that the Secretariat would advise them of the meeting arrangements in due course.

The Administration adopted a positive attitude towards bottom-up and district-led proposals for organizing bazaars.
