Major Sports Events Matching Grant Scheme and District Sports Programmes Funding Scheme

Purpose

This paper seeks Members' views on the allocation of \$500 million to the new Major Sports Events Matching Grant Scheme and the allocation of \$100 million to the District Sports Programmes Funding Scheme.

Major Sports Events Matching Grant Scheme (Matching Grant Scheme)

Background of the Matching Grant Scheme

2. It is one of the Government's strategies to make Hong Kong a centre for major international sports events. Hosting of international sports events in Hong Kong provides opportunities for local athletes to compete on home ground and the general public to watch high-level competitions, thereby help promoting a strong sporting culture. In 2004, the Home Affairs Bureau (HAB) introduced the "M" Mark System to support "national sports associations" (NSAs) to host major international sports events through the provision of matching fund (i.e. a dollar-for-dollar matching grant provided to the event organiser in accordance to the cash sponsorship solicited from the commercial or private sectors) and direct grant, sourced from the Arts and Sport Development Fund (Sports Portion). In 2017, 13 major sports events have been supported by the "M" Mark System with a total of around \$15.99 million cash grant. Details of the "M" Mark System are set out in Annex A.

3. The Government announced in its Budget this year an allocation of \$500 million to the "Major Sports Events Matching Grant Scheme" (Matching Grant Scheme) to enhance the provision of existing matching grant under the "M" Mark System with a view to encouraging more sponsorships

from the private and business sector to support the NSAs to host more higher-level major sports events.

Considerations

- 4. Over the past decade, the eligibility criteria and the ceiling amount under the "M" Mark System have been reviewed from time to time to cope with the needs of hosting major sports events and inflation. Under the present System, the world championships, one-off championships or one-series championships may apply for both matching fund <u>and</u> direct grant, with \$6 million as the maximum amount available. Other "M" Mark events that are organised yearly are only eligible to apply for either the matching fund <u>or</u> direct grant. For matching fund, the maximum funding amount for an event is \$9 million in total for its first three years (no more than \$4 million per year) and a maximum of \$1.5 million per year from the fourth year onwards; for direct grant, the maximum funding amount is \$1.5 million for the first year, \$0.7 million for the second year and \$0.5 million for the third year.
- 5. When deliberating the details of the Matching Grant Scheme, we have met with NSAs that have organised "M" Mark events in the past five years, and those with experience in organising major competitions. A questionnaire survey was also conducted to collect their views.

Proposed Initial Recommendations

6. Having considered the views from stakeholders, we have reviewed the current "M" Mark System and made the following recommendations in relation to the Matching Grant Scheme to enhance support for the hosting of major sports events.

<u>Increase</u> in the funding level

7. Under the current "M" Mark System, no more than \$6 million of funding would be granted for an event. The funding level and arrangement hinges on whether the major sports event is a sustainable one. Most of the NSAs indicated that the current funding amount is insufficient to support their hosting of major events, and that events organised repeatedly year after year contribute no less than one-off world championships to local sports development. To provide better support and to simplify the funding arrangement, we recommend standardising the ceiling of matching fund to \$10

million for all events awarded with "M" Mark status and abolishing the sliding scale mechanism for the funding amount.

Expansion of the scope of funding

8. The current "M" Mark System provides support mainly to those major competitions of great significance in the international sports arena that are accredited by the relevant international sports federations. Nevertheless, constrained by the existing "M" Mark System, some world-class exhibition matches were unable to obtain funding support. To provide the public with more opportunities to watch high-level matches, we propose expanding the funding scope of the "M" Mark System to cover exhibition matches organised by local NSAs. These matches shall involve world-class athletes or teams, with a guaranteed attendance rate. With reference to the attendance rate for similar events², we consider that the exhibition matches held in football pitches should attract at least 15 000 paid admissions per match while for events held in other venues, the accumulated paid admissions should be at least 8 000 per event. As the nature of exhibition matches differ from the current "M" Mark events, we will consult the Sports Commission to establish a separate set of assessment criteria and funding mechanism.

To enhance the flexibility in the use of event surplus

9. At present, when an NSA records surplus upon completion of an "M" Mark event, it may retain the amount solely for the purpose of hosting the same event in subsequent years. The surplus must be returned to the Government if it has not been deployed within two years. Under the Matching Grant Scheme, if a surplus is recorded upon completion of an event, NSAs are only required to retain 25% of the total cash funding as reserve fund for organisating future "M" Mark events. To increase the flexibility in the use of such surplus to develop respective sports and to encourage NSAs to seek commercial and private sponsorships more actively, we recommend that if the amount of surplus exceeds 25% of the total amount of cash funding, the respective NSA may submit a proposal to HAB to set out how it plans to make use of the surplus (after deducting the reserve fund) for its sports development Subject to the approval of HAB, the NSA may use the surplus projects.

accordingly. All reserve fund must be returned to the Government if the respective NSA does not organise any "M" Mark event in four consecutive years.

Financial Implications

10. According to the above proposal and subject to the number of event applications received per year, we consider that the proposed allocation of \$500 million should be sufficient to meet the expenditure required under the Matching Grant Scheme in the coming five years. We will review the need to extend the Scheme in the light of its effectiveness.

District Sports Programmes Funding Scheme (Funding Scheme)

Background of the Funding Scheme

11. Promoting sports in the community is one of the three major objectives of the sports policy of the Government. Through promotion of community sports, we encourage more people to regularly participate in sports activities and help them develop a healthy lifestyle. To strengthen the promotion of sports at districts and to encourage wider participation, the Government announced in its Budget this year an allocation of \$100 million to launch the five-year Funding Scheme to provide additional resources for district sports associations (DSAs) 3 to organise more sports programmes, thereby building a strong sporting culture in the community.

Considerations

The role and advantages of DSAs

DSAs in the 18 districts have been, since their establishment, playing an important role in promoting sports development at the district level. With local networks, DSAs have unique advantages in promoting sports in the community. Through encouraging people in different age groups with varied abilities and interests to actively take part in sports, DSAs can help enhance the overall sporting culture in our society. Currently, DSAs organises a wide variety of activities, including district sports festivals (e.g. Yuen Long District

Sports Festival), sports fun days (e.g. Wan Chai Sports Carnival and Kwun Tong District Sports Carnival), squad trainings, competitions (e.g. New Territories Inter-district Football League), training courses, etc., covering a wide variety of sports including athletics, badminton, basketball, tennis, wushu and hiking etc. The programmes cater to the interests of people with different needs in the districts.

DSAs are also a cradle of athlete training and serve as the foundation for the development of elite sports. Most of the young athletes begin their pathway to sports by taking part in school or district sports activities. Encouraging DSAs to organise more district-based training programmes and competitions, children are encouraged to take up sports at an early stage. This will also help identify athletes with potential from districts to undergo progressive and systematic training. Under the existing mechanism, these athletes may be recommended to join different level of training squads to receive higher level of training and have a chance of becoming elite athletes.

Development of DSAs

14. At present, DSAs are receiving recurrent subvention from the HAD through the CSSS. In 2018-19, a total subvention of \$3 million has been allocated for DSAs to cover their administration and operation expenses. In addition, DSAs also obtain programmes funding mainly from District Council Funds, private donations and sponsorships. A summary of HAD subvention and District Council Funds received by DSAs in 2017-18 is set out in **Annex B**. District sports development is vital to the promotion of sports in the community. To encourage DSAs to organise a greater variety of sports programmes, it is necessary for us to provide additional resources to support their development in the long run.

Proposed Initial Recommendations of the Funding Scheme

15. Owing to the difference in population, socio-economic situation, size of district and the demand for sports programmes, the funding amount under the Scheme will be subject to the applications submitted by individual DSAs rather than evenly shared by the 18 districts. We recommend that each project under the Funding Scheme may receive a total funding of not more than \$2.5 million.

- 16. The Funding Scheme will provide funding for DSAs to organise new sports programmes or expand the scale of existing programmes. The types of programmes may include training courses, leisure classes, competitions, sports festivals and sports fun days. The target participants are not limited to any age group, which may cover the elderly, women and children.
- DSAs shall submit their applications to the HAB in the form of a proposal, which clearly sets out a detailed plan of programmes, expected outcomes, major deliverables, objectives and the approach of evaluating the effectiveness. Upon completion of activities, the subvented organisation must submit an activity report and a financial report, and evaluate the effectiveness in the promotion of sports in the community according to the measurable indicators set out in its proposal. The Funding Scheme is currently at its planning stage. After seeking Members' views, we will work out the funding guidelines and further consult DSAs and other stakeholders on the implementation details.

Financial Implications

18. It is recommended that an amount of \$100 million be allocated to launch the five-year Funding Scheme. We will review the need to extend the Funding Scheme in the light of its effectiveness.

Advice Sought

19. Members are invited to comment on the above two funding allocation proposals. Subject to Members' views, we shall seek the approval of the Finance Committee accordingly.
