B780CL - Site formation and infrastructure works for public housing development at Wang Chau, Yuen Long" (i.e. item no. 1 of the HG Panel's list of outstanding items for discussion (LC Paper No. CB(1)1051/17-18(02)). The notice of meeting and agenda had been issued to members of the two Panels vide LC Paper No. CB(1)1046/17-18 on 30 May 2018. The Chairman further advised that HG Panel had discussed with the Administration the proposal "Head 711 project no.
