Statistics on the utilisation of video visit facilities at correctional facilities

In response to Members' request during the briefing by the Secretary for Security on the Chief Executive's 2017 Policy Address at the meeting of the Panel on Security on 3 November 2017, I write to provide supplementary information on the utilisation of video visit facilities at correctional facilities.

Relatives and friends may conduct social visits on a person in custody at a correctional facility in accordance with the stipulations in Rule 48 of the Prison Rules (Cap. 234A). Persons in custody at correctional facilities equipped with video visit facilities may make an application to the institutional management in advance if they wish to receive a video visit from their relatives and friends. Upon approval, the relatives and friends may conduct the video visit at the Mongkok Counselling Centre of the Correctional Services Department (CSD).

Legal advisers may conduct legal visits on a person in custody at a correctional facility in accordance with the stipulations in Rule 52 of the Prison Rules. Legal advisers who wish to conduct a video visit on a person in custody at correctional facilities equipped with video visit facilities may make an application to the CSD in advance. Upon approval, legal advisers may conduct video legal visits from facilities at the High Court on persons in custody at correctional facilities equipped with video visit facilities.

In addition, three offices of the Social Welfare Department and one office of the Legal Aid Department are equipped with facilities for respective officers of the two departments to conduct video visits on persons in custody at Lai Chi Kok Reception Centre.

Statistics on the utilisation of video visit facilities are at $\underline{\textbf{Tables 1}}$ $\underline{\textbf{to 3}}$ respectively.

The CSD is working towards equipping more correctional facilities with video visit facilities. For instance, video visit facilities are being installed at Siu Lam Psychiatric Centre and are expected to commence operation in the second quarter of 2018.
